<u>ORIGIN</u>

Initiated by the Active Transportation Advisory Committee through the Legislative Assistant.

LEGISLATIVE AUTHORITY

Active Transportation Advisory Committee Terms of Reference, Section 14 Report to Standing Committee:

14.1 The Committee shall submit a report of activities to the Transportation Standing Committee during the first quarter of each year.

BACKGROUND

On November 14, 2006, Halifax Regional Council, adopted in principle, the Active Transportation Plan. This plan was developed to integrate all active transportation infrastructure and to ensure that the needs of all active transportation users were being met.

On May 13, 2008, Halifax Regional Council approved the formation of an Active Transportation Advisory Committee and its Terms of Reference, to take affect in November 2008.

On April 1, 2009 the Active Transportation Advisory Committee held its first meeting. The Committee's purpose is to advise the Transportation Standing Committee on all matters relating to active transportation in Halifax Regional Municipality, using the Active Transportation Plan as a guide.

Motion approved that the Active Transportation Advisory Committee recommend that the Transportation Standing Committee direct the Chief Administrative Officer to prepare a staff report on developing and adopting an Active School Travel policy and plan, including considerations of partnering with other stakeholder agencies and allocating funding for necessary education and infrastructure.
