Dear Annie,

I hope this message finds you well. I am writing to you on behalf of Complex Trauma Canada, an organization committed to increasing awareness, driving education, and supporting healing of childhood and complex trauma. Traumatic stress injuries, often unseen, pose significant challenges to those affected.

Recent statistics indicate that approximately 9.2% of Canadians are likely to develop PTSD during their lifetime. This figure represents only a portion of the traumatic stress injuries experienced. The more recent diagnosis of Complex PTSD, remains in need of further study. Additionally, it is estimated that 75% of the population has undergone childhood trauma. The ACEs study further reveals that 64% of individuals have encountered at least one adverse childhood experience. These statistics reflect the experiences of our families, friends, colleagues, and community members.

Complex trauma refers to multiple traumatic events that accumulate over time, significantly influencing an individual's behavior, reactions, and interpersonal interactions. These signs may not be immediately apparent unless triggered. When triggered, individuals may display erratic behavior due to the dominant response of the emotional regions of their brain. This can lead to flashbacks and intense emotional or visual experiences, often without an apparent threat to others.

It is crucial to recognize traumatic stress injuries as invisible disabilities. These conditions often require medical accommodations, especially in the workplace or when accessing services in Halifax. Currently, there are challenges in providing adequate support for employees and rate-payers suffering from such injuries.

We advocate for the implementation of Trauma-Informed training for staff and the appointment of accessibility coordinators or disability support personnel. Such measures would foster a more efficient and inclusive environment in Halifax.

If the Committee is interested in further discussing this topic, I am available to provide more detailed information or to present at one of your upcoming meetings in February or March.

Thank you for considering this important matter. I look forward to the possibility of working together towards a more supportive and understanding Halifax.
