Strategic Opportunities to Address Homelessness

Current State

- By Name List: 1,259 and growing
- 4 Designated locations: 30 spaces, 85+ people
- Non designated locations: 40+ people
- Lots of work underway
- Significant deficits in options available for people
- Organic growth is occurring now into the summer
- New report from Federal Housing Advocate



Provincial activities

- Since 2021, 444 new supportive housing units in HRM.
- There are now 399 additional emergency shelter beds, 193 of them opened in the past six months.
- A 19-unit Pallet Village has been opened in Sackville.
- A temporary housing facility for 32-women and gender-diverse individuals has opened in Halifax.
- A 35-unit temporary housing facility for African Nova Scotian/Black individuals opened in Dartmouth.
- 250 new beds and units coming in 1 12 months



New resources must meet the need

- High acuity individuals
- Adequate mental and addictions support
- Single room occupancy
- Wet shelter
- Couples
- Youth





Municipal activities

Municipality required to support all community members

- Gray Arena
- Modulars
- Humanitarian aid
- Extreme weather
- Case management
- Diversion funds
- Bus passes and tickets

- Zoning and bylaw changes
- BID Navigators
- Halifax Forum Shelter
- 88 calls/month to 311
- Snow, garbage and maintenance
- No tent kits

Support for overcrowded encampments

- On site staff and supports
- Code of conduct
- Additional resources and services
- Strategy to address predatory criminal behaviour
- Place for people to go who refuse to follow the code of conduct



Civilian led response team

The highest impact we could have

- 24/7 behavioural issues response
- Team including mental health practitioner, social worker, and peer support
- Various supports and supplies to support in a variety of situations
- Opportunities for partners

Lived experience

- Impact of encampments is broad, deep, and lasting
- Need for housing and permanent options
- Impact of large encampments
- Value of a civilian led response
- Maintain and support personal resilience

Unsolicited community feedback

- Don't reopen closed park spaces until there is no risk of reoccupation
- Reimagine park spaces
- Program them such that people cant shelter in them

Recommended actions

Immediate

- The Mayor write a letter to the Province requesting specific assistance as outlined in the report
- Continual referrals to existing and pending options
- Strengthen the list of places people are not allowed to shelter
- Dedicated resources from police could help in difficult circumstances
- Designation of other ready to use spaces to meet need
- No encampment approach in the long term

Recommended actions

Further actions

- Homelessness Summit
- Launch a civilian led response team
- Designation of non ready to use spaces, such as preparation of Bancroft and Marketplace site
- Managed encampment support for larger sites
- It will take time to implement many of these options
- Cost no more that \$4,000,000 in 20204/2025 and just over \$6,000,000/year going forward
