 - Alignment with HalifACT
 - Contribution towards 300 kg per capita waste disposal
- Nine Key Themes
 - Impact of Extended Producer Responsibility (EPR) legislation
 - Reducing carbon footprint and waste disposal
 - Cart based collection
 - Expanding Household Special Waste (HSW) program

Key Findings - EPR

- New Program December 2025
 - Likely to continue providing recycling collection and education services
 - Unlikely to continue to processing recyclables long-term
 - Material Recovery Facility is a useful asset

- Next Steps
 - Follow Regional Council direction (December 2023)

Key Findings – Alignment with HalifACT

- Solar for new composting facility
 - Potentially implement starting in FY 2026/2027

- Landfill gas to renewable electricity
 - Further evaluate FY 2024/2025



Key Findings – 300 kg per capita by 2030

- Clear bags for IC&I
- Multi-Res improvements
- Promoting circular economy
- Next Steps
 - Phase 2 Public Consultation (Stakeholders)
 - Phase 2 Assessments



Key Findings – Cart-Based Collection


- Proposing cart-based automated collection for garbage/organics
- Significant labour improvement
- \$14M initial capital investment
- \$700k annually for new/replacement carts

Key Findings – HSW Expansion

- Need to relocate Halifax HSW
 - 222/230/232 Horseshoe Lake Dr. available
 - Start with 2-day operation possibly by 2026/2027
- Need to identify location of a Dartmouth HSW Depot
- Next Steps
 - Halifax HSW Depot Conceptual Design FY2024/2025
 - Identify suitable Dartmouth HSW Depot FY2024/2025
