All delegates to the conference expressed their profound joy and thanks to the city of Halifax. They expressed that we surpassed their expectations, and they were all going back with a memorable experience of a new, changed and beautiful Halifax and conference. I really want to thank all boards members and staff who were able to help plan and attend the conference. My special thanks also go to the volunteers including Carole McDougall, HRM staff and Cathie O'Toole for their sponsorship and support. Also, my special thanks to the Board Chair Becky Kent (especially for the pirate presentation), members of the board that attended and the wonderful members of the local conference organization committee (Becky, Lisa and Josh), and myself as chair. The chiefs and their representatives were also able to attend.

I will refer everyone to the conference agenda (Attachment 1) for a quick review of all the topical issues discussed, the conference brought a lot of information and best practices and if possible, I will be asking CPAG for a video of the event if they have one to share with our board.

The summary of decisions at the conference and some takeaways are presented in a bullet form below.

- The need for Cultural changes and evolution throughout the various aspects of Policing to improve recruitment and staff engagement leading to increased effectiveness and return on investment
- 2) Effective Collaboration, to include all aims of government, Federal, Provincial and Municipal for effectiveness and successful handling of homeless, encampment and mental health. We learnt and agreed that while it has now become the primary goal of "Public Safety "at various levels of government, it was important to understand the root cause of the problems with the aim of providing lasting solutions. This will require dedication and multiple sources of funding to create a center that will house and include, medical solutions for both drugs and mental illness and resources rehabilitation ( work training and care) and bold fully holding through the pressure of the human rights advocate, drug pirates/ lords, gangsters and protesters while focusing our attention on long solutions for helping the vulnerable people in these encampments and needing help with addictions, mental health and other needs. (Edmonton Solution is worth consideration). Our focus as Police Board is to provide

guidance to the Policing aspects of this collaboration and provide support for the successful enforcement of law and order when and as necessary (without use of aims or force where applicable) and including their funding requirements. (I can speak to this further if required).

- 3) Adequate board training and funding with appropriate staff to include an effective communications team to help provide immediate and proactive response to public needs and avoid guided and uninterrupted access to information.
- 4) Policing and transformation using EBI (Evidence Based Information) and Innovative Technology Solutions to drive crime prevention and public safety (Body Worn Cameras), leading to Police trust and accountability.
- 5) Best practices and reduce cost by applying successful and practiced solutions. good examples were the case study, and the successes achieved so far in Peel Regional Police. It is worth listening to the presentation by the Chief of Police Peel.
- 6) Strategic methods of evaluating officers' health conditions by taking proactive and consistent health measures and methods (Case Study by Durham Regional Police).
- 7) Finally, collaboration between chiefs and ranking officers and the board to provide effective communication/management and understanding of Policing requirements. Attendance to Police and community events, Board visits to Police Environments and Ride-along activities to appropriate operational environments and experiences.

Thank you all, I will be happy to speak about all these points if necessary. It was a very busy time but worthwhile conference and experience.
