Hi Becky... congratulations on your re-election.

Over the past couple of months I have been preparing a non-market housing inventory for Districts 2, 3, 4, 5 and 6. I've done this work as a volunteer to meet certification requirements as a professional planner. I've done about a half dozen non-market housing inventories across Atlantic Canada, in fact, I'm just starting one for the City of Fredericton.

I would like to present my findings to the HEMDCC. Across the 5 districts, I've identified 61 non-market housing groups, 82 non-market housing projects and about 3,000 non-market units. There are some gaps in this data, but there is enough content to make some general observations. I believe members of community council would welcome receiving this information and I would do my best to organize the data on a district basis.

If the community council still meets on Thursday nights, I am generally available, except for the evenings of November 28th and December 5th.

Thank you for considering my request.
