EMERA OVAL OPEN FOR THE 2024/2025 SEASON


The Halifax Regional Municipality is advising residents that the Emera Oval, located on the Halifax Common, is now open.

Every year, the Emera Oval is transformed into the largest outdoor, artificially refrigerated ice service east of Quebec City. The skating surface is equal to three NHL hockey rinks, and the facility includes an accessible washroom, street parking on Cogswell Street and wheelchair access to the ice surface.

Beginning on Monday, January 6, the Oval will host a Sensory Skate every Monday from 4 p.m. to 5 p.m. There will be no music playing or any large group bookings during that time.

Free equipment rentals, including skates and helmets, will be available. Valid ID is required for all rentals. CSA-approved multi-impact hockey helmets are mandatory for children 12 years of age and younger. However, all skaters are encouraged to wear a helmet for their own safety.

OVERNIGHT WINTER PARKING BAN IN EFFECT

The municipal overnight winter parking ban is in effect from December 15, 2024 through March 31, 2025. The overnight winter parking ban is enforced from 1 to 6 a.m. during declared weather events and snow removal operations. Residents are encouraged to plan ahead when snow is in the forecast and secure off-street parking when the overnight winter parking ban is enforced.

The municipality has two zones for the overnight winter parking ban:

Zone 1 – Central refers to the Halifax peninsula and downtown Dartmouth within Highway 111 (the Circumferential Highway) and some surrounding areas.

Zone 2 – Non-Central is a designated area outside of Zone 1 – Central. Residents are able to determine which zone they're in by searching their address using the interactive tool available here.

Overnight winter parking bans will continue to be communicated to residents via hfxAlert, our website and @hfxgov on X.



ROADS AND WINTER OPERATIONS

Winter is here!

With each weather event, crews are responsible for clearing approximately 4,322 lane kilometres of streets. Stretched end to end, that's the same distance as driving from Halifax to Winnipeg. Crews also clear about 1,000 kilometres of sidewalks, six kilometers of protected bike lanes/local street bikeways, 11 kilometers of multi-use pathways and approximately 2,300 bus stops across the municipality.

Property owners, never clear snow from your property onto the street or sidewalk. Please ensure the snow is piled on your own property. It is against By-Law S-300 to throw or pile snow in the street or on the sidewalk. This is a serious problem that can cause safety issues for pedestrians and other users as it complicates clearing for crews. When this happens, crews are often forced to double back, delaying service on the rest of their routes. The municipality has enhanced enforcement in place to address non-compliance with the by-law.

Residents are reminded to secure off-street parking for the winter months so that crews can safely and efficiently clear streets and sidewalks. Vehicles obstructing snow clearing equipment may be ticketed or towed anytime, particularly in priority areas like bus routes and streets around hospitals and schools. The municipality can also enforce winter parking bans during snow clearing. Sign up for hfxALERT to be notified when the ban is in effect.

For minor (0 to 5 cm accumulation) and average (5 to 15 cm accumulation) winter events, snow clearing updates will be posted three times a day: 7 a.m., 1 p.m., 4 p.m. on our website and via ohrkgov on Twitter. For major events (15 cm or greater of accumulation), updates will be posted four times a day: 7 a.m., 1 p.m., 4 p.m. and 8 p.m. Please note: Additional updates may be posted outside of these times as required.

We can't control the weather, but if we work together we can all be better prepared for whatever the season may bring



2025/2026 MUNICIPAL BUDGET

Halifax Regional Council has begun the process of reviewing the municipal budget for the 2025/26 fiscal year.

The municipal budget funds all costs associated with servicing our growing municipality. This includes day-to-day municipal operations, capital priority initiatives approved by Regional Council and capital projects and investments to purchase, construct, rehabilitate and replace municipal assets. APPLICATIONS NOW OPEN FOR THE COMMUNITY GRANTS PROGRAM

The Halifax Regional Municipality is advising eligible registered non-profit and charitable organizations that applications for the Community Grants Program have opened.

The program provides annual cash grants to registered non-profit organizations and charities located throughout the region. There are two grants available – a project grant of up to \$5,000 or a capital grant of up to \$25,000.

The program has seven funding categories, which include: community arts; diversity and accessibility; environment and climate change; emergency assistance and neighbourhood safety; community histories; leisure; and recreation. Applicants must indicate the category which best matches the funding request.

Applicants should review the 2025/26 Program Guidebook prior to applying, and first-time applicants are encouraged to contact municipal staff prior to submitting an application.

PROPERTY TAX ASSESSMENT APPEALS

Property Valuation Services Corporation (PVSC) assesses every property in Nova Scotia and mails over 638,000 Property Assessment Notices to property owners every January. If you are a property owner, you should be receiving your latest Property Assessment Notice in the coming weeks.

There is an option to appeal/refute your assessment within 31 days of the date on your Assessment Notice.
