### SNOW SERVICE STANDARDS



During a storm, our crews have 4,322 lane kms or road, 1,000 kms of sidewalks plus bike lanes, multiuse pathways and

bus stops to clear. They begin their work before the winter weather event even begins by applying salt or brine to streets and sidewalks across the region and snow clearing efforts begin once the snow has begun to accumulate.

Streets and sidewalks are prioritized based on traffic volumes, local amenities such as hospitals and schools and steepness. We work as quickly as possible to get all streets cleared, but Priority 1 roads should be cleared to bare pavement within a maximum of 12 hours of the end of a weather event and Priority 2 Roads should be snow covered but passable within a maximum of 24 hours from the end of an event. If your street or sidewalk does not meet the standards, please call 311 and they will dispatch a crew. In exceptional weather events, these timelines may not be able to be met, but we do our best to clear as quickly as possible. ### **BUDGET 2025/2026**



The municipal budget funds all costs associated with servicing a growing municipality. This

includes day-to-day municipal operations, capital priority initiatives approved by Regional Council and capital projects and investments to purchase, construct, rehabilitate and replace municipal assets.

There are several milestones in the annual municipal budget process. Below are the key dates for the 2025/26 municipal budget process:

   Budget Introduction and Capital Plan Recommendation.

**Presentations:** Each municipal business unit will present their proposed budget and business plan. Below are the scheduled presentation dates for each business unit.

- Public Safety (including Community Safety; Halifax Regional Fire & Emergency; Halifax Regional Police; and Royal Canadian Mounted Police Halifax Regional Detachment)
- Wednesday, February 19 and Thursday, February 20
   Operations (including Halifax Transit; Parks & Recreation; Planning & Development; Property, Fleet & Environment; and Public Works).
- Wednesday, February 26
   Corporate Services (including Chief Administrative Office;
   Finance & Asset Management;
   Human Resources; Information Technology; and Legal & Legislative Services.
- Wednesday, March 19
   Budget Adjustment List (BAL) Review:
   The BAL includes all additional items that business units have presented beyond their proposed budgets, including addons ("overs") and subtractions ("unders").
- Tuesday, April 8
   Budget Approval.

Residents will have the opportunity to speak directly to the Budget Committee during the budget process. During each meeting, time will be set aside for the public to provide insight and comments.

# 2024 MUNICPLE ELECTION CAMPAIGN FINANCE DISCLOSURE

The Halifax Regional Municipality is advising residents that campaign finance disclosure documentation for the 2024 Municipal and Conseil scolaire acadien provincial Election is now available on our website.

Within 60 days of 2024 Municipal Election, every candidate was required to provide a Statement of Campaign Contributions and Expenditures and Statement of Campaign Surplus in accordance with <u>By-law C-1100 – Respecting Campaign Financing</u> and the Province of Nova Scotia's <u>Municipal Elections</u> Act.

### SENIOR SNOW REMOVAL PROGRAM



There's no denying it – winter is here!

Did you know that there is a snow removal program available for seniors (ages 65 and

older) and persons with disabilities to help ensure safe access to your home?

The <u>Senior Snow Removal</u> is a YMCA program provided in partnership with Halifax Regional Municipality, and oversees the clearing of front and back steps, walkways, ramps, and access to fuel tanks. Please note that the program does not include driveway clearing.

Those 65+ or persons with disabilities must also meet the following eligibility criteria:

- The participant must reside in a single dwelling home which is owned or rented;
- The participant, also including all individuals who live on the premises aged eighteen or older, must not exceed a total gross household income of \$32,000, and;
- The participant may not be a landlord.

### **BOIL WATER ADVISORY**

Following the January 21 boil water advisory issued by Halifax Water for the area supplied by the Pockwock J.D. Kline treatment plant, I received a number of phone calls from residents questioning what happened and how Halifax Water will address the issue to ensure no further such events occur.

Halifax Water is not regulated by Halifax Regional Council. It is regulated by The Nova Scotia Utility and Review Board (NSUARB).

In addition to the Halifax Water Board requesting a follow-up on this incident, the Nova Scotia Utility and Review Board has requested an investigation report be submitted on February 4. Halifax Water staff are investigating what happened at the Pockwock Water Treatment Plant. The report will be submitted to the NSUARB and then publicly available on their website. Halifax Water will also share the report with the Nova Scotia Department of Environment and Climate Change and Regional Council.

The Boil Water Advisory asked customers to take an additional precautionary step before consuming water readily available at their tap. Whether a customer followed the advisory or decided to purchase water themselves was a personal preference and, in this instance, Halifax Water would not reimburse the cost as water was readily available.

The leadership and staff of Halifax Water understand the impact these events have on people's lives and that their customers are frustrated. Halifax Water stated that they are committed to taking every precaution to ensure the safety of their customers' drinking water and remain committed to improving service.



### SENIOR CARE GRANT

The Seniors Care Grant helps low-income seniors with the cost of household services like lawn care, snow removal, grocery delivery, transportation, small home repairs and phone service, healthcare services like physiotherapy and mental health support and home heating. ## PROPERTY TAX ASSESSMENT APPEALS

Property Valuation Services Corporation

### Property Valuation Services Corporation

(PVSC) assesses every property in Nova Scotia and mails over 638,000 Property Assessment Notices to property owners every January. If you are a property owner, you should be receiving your latest Property Assessment Notice in the coming weeks.

There is an option to <u>appeal/refute</u> your assessment within 31 days of the date on your Assessment Notice.

### **ICE SAFETY**



The municipality is no longer conducting ice thickness testing as changing climate patterns, including rapidly fluctuating temperatures, have made ice thickness testing no longer feasible or reliable.

### WINTER GREEN CART TIPS



When temperatures drop, materials in green carts can freeze and cause issues for both residents and

waste haulers. To avoid some of the problems associated with green cart in the winter, our Solid Waste Resources team has some helpful tips:

- Put your green cart out for each collection, even if it's not full. This will give material less time to freeze
- Line the bottom of your green cart with a yard waste bag, boxboard or newspaper
- Place your green cart in a place where the sun can reach it
- Wrap food in paper scraps

### WINTER PARKING

The Halifax Regional Municipality is advising residents that the municipal overnight winter parking ban is now in effect during declared weather events to ensure effective snow clearing. Residents are encouraged to plan ahead when snow is in the forecast and secure off-street parking when the overnight winter parking ban is enforced.

The parking ban can be enforced throughout the entire municipality or just by zone. Zone 1 – Central refers to the Halifax peninsula and downtown Dartmouth within Highway 111 (the Circumferential Highway) and some surrounding areas. Zone 2 – Non-Central is any

area outside of Zone 1. You can find out what zone you are in here.

The municipality has enhanced enforcement for parking ban violations in areas around hospitals, schools, bus routes and challenging streets to ensure unobstructed access for snow equipment and emergency vehicles. Officers will also be ticketing vehicles obstructing sidewalk clearing.

Regardless of the status of the overnight winter parking ban, vehicles can be ticketed or towed at any time if their vehicle is interfering with snow clearing operations as outlined in Section 139 of the *Nova Scotia Motor Vehicle Act*.

# NEW MINIMUM PLANNING REQUIREMENTS

The Halifax Regional Municipality is inviting residents to learn more about new Minimum Planning Requirements that will affect policies and regulations regarding housing in our region.

Minimum Planning Requirements are provincial regulations that the municipality's land use plans and strategies must meet as required by the province. In August 2024, the province announced 12 new Minimum Planning Requirements to prioritize increasing housing supply.

To comply with the new regulations, the municipality is making changes to the Regional Plan, as well as Community Plans and land use by-laws.


