This year's provincial theme, *Legacy in Action: Celebrating Black Brilliance*, highlights the living legacy of Black Nova Scotians, honouring the impact and perseverance of the long-standing community.

Nova Scotia has 52 historic African Nova Scotian communities with a long, deep and complex history dating back over 400 years.

The Halifax Regional Municipality are committed to fostering safe and inclusive communities for all. Our African Nova Scotian Affairs Integration Office (ANSAIO) are committed to addressing anti-Black racism in our workplaces and communities with the Anti-Black Racism Framework, the African Descent Advisory Committee advises Regional Council on the impact of municipal policies, programs and services for People of African Descent and we are sponsors of the Road to Economic Prosperity for African Nova Scotian Communities, that encourages community efforts and provides a space for realizing future opportunities for all people of African descent.

This month, City Hall will be illuminated in black, green and red and the Pan-African flag will be displayed at some of our municipal buildings in honour of African Heritage Month. RESIDENTS INVITED TO LEARN ABOUT NEW MINIMUM PLANNING REQUIREMENTS

The Halifax Regional Municipality is inviting residents to learn more about new Minimum Planning Requirements that will affect policies and regulations regarding housing in our region.

Minimum Planning Requirements are provincial regulations that the municipality's land use plans and strategies must meet as required by the province. In August 2024, the province announced 12 new Minimum Planning Requirements to prioritize increasing housing supply.

To comply with the new regulations, the municipality is making changes to the <u>Regional Plan</u>, as well as Community Plans and land use by-laws.

COMMUNITY GRANTS PROGRAM

The Halifax Regional Municipality is advising eligible registered non-profit and charitable organizations that applications for the Community Grants Program have opened.



The program provides annual cash grants to registered non-profit organizations and charities located throughout the region. There are project grants (up to \$5,000) or capital grants (up to \$25,000) available in the following categories: community arts; diversity and accessibility; environment and climate change; emergency assistance and neighbourhood safety; community histories; leisure; and recreation.

BEECHVILLE, LAKESIDE, TIMBERLEA COMMUNITY CORNER

New Traffic Lights at Higgins Avenue in Beechville

Residents have asked questions about the recent installation of new traffic lights at Higgins Avenue in Beechville. The Lovett Lake developer was able to finish this installation in January as the civil work was completed a few years ago. The



installation of traffic signals at the corner of the St. Margaret's Bay Road and the Timberlea Parkway is scheduled to take place in spring 2025. This project was postponed in 2024 due to delays with utility relocations.

RCMP Halifax Regional Detachment (HRD): Community Policing Office in Beechville

The RCMP HRD are seeking HRM funding for 14 new positions, with six of these new positions to be located at a new community policing office in Beechville. The rationale for these new positions is to respond to the increased number of calls for service, the growing population in the area and to provide service enhancements. The site of the office is to be determined. I welcome your feedback on this proposal. The funding request that went to the Board of Police Commissioners on January 15 can be viewed here/br/

Townhall Update

Thanks to all the residents that came out on a cold night for the January 30 townhall at Trinity United Church. A big thanks to the Trinity United Church for hosting the event and Barb Charteris for moderating the townhall.

It was a privilege to partner with MLA lain Rankin and Member of Parliament Lina Metlege Diab on this opportunity for residents to ask questions of their representatives. A special thank you to the RCMP (Inspector Jeff Mitchell, Superintendent Don Moser and Sargeant Lynden Morrison) for being there to speak to the proposed BLT community policing satellite office.

Some of the key municipal issues that came up were sidewalks for the Timberlea Parkway, traffic signals close to Exit 3, affordability, winter operations, speeding and opportunities to have community space at the new school in the BLT.

Windsor Street Exchange Council Update

At the January 28 Regional Council meeting, we considered a staff proposal on the Windsor Street Exchange Redevelopment Project. The staff report can be viewed here.

I voted to support the staff proposal as I stated in Council that I feel we need to move forward to address the major congestion being experienced at this intersection. I also feel that while only one dedicated bus lane and a multiuse path do not fulfill all our future growth needs, they will provide significant improvement while other options are being explored. In addition, I recognized the importance of badly needed repaving, the integration with the needs of both Halifax Water and the Port of Halifax and the money that has already been spent on the design. I am also concerned about losing access to the committed \$23 million in federal dollars related to Port of Halifax upgrades. Finally, I am concerned that efforts to obtain more land on either side of the road may take many years and I believe residents would like some relief in the shorter term.

The proposal was defeated, but the report may be debated again at a future Regional Council meeting as three Councillors were missing from the original discussion. Please let me know your position on this proposed project.

Thomas Raddall Drive Shelter Village Update

The Shelter Village, a project of the Province of Nova Scotia, is being managed by the Atlantic Community Shelters Society (ACSS). Currently, there are 20 people living at the site with staff and security on site 24 hours/day. There is space for another 20 but those units will not be filled until the Community Building is completed.

HRM is supporting the site through the provision of land, snow clearing and garbage removal. HRM and community outreach staff are providing regular referrals to ACSS for clients who might be a good fit for the site and their wrap around services. While not quite ready yet, the Village will be seeking help from the general community in the future for donations of clothes and other supplies. At this time, they do not have roles for volunteers, but they do plan to make use of volunteers in the future.

Washmill Lake Drive & Grand Haven Estates Safety Concerns

I wanted to provide an update on this as I have received many resident inquiries concerning this intersection.

Grandhaven Blvd is a private road and HRM does not install infrastructure for private property owners. For developments like this, the need for traffic signals is determined during the development planning stage as part of a traffic impact study that is required to be completed by the developer. At that time, the projected volumes for the area and the proposed development indicated that traffic signals would not be warranted at Grandhaven Blvd. Based on the many requests received for signals here, HRM did reassess the traffic conditions in 2022. The assessment considered the traffic conditions and collision history at Grandhaven Blvd. and affirmed that of the seven property-damage-only collisions that occurred at the location, only one was of a nature that could potentially be addressed by installing traffic signals.

Overall, based on both traffic volume and collision experience, traffic signals are not warranted at Grandhaven Blvd. however considering the many traffic safety concerns brought to my attention, I asked HRM staff to reassess the traffic conditions with updated traffic data again this year.

Halifax North West Trails Association (HNTWA)



On Sunday, January 26, the Association officially opened its new Mainland Common Loop Connector Trail and provided a guided walk on the new trail and its adjacent trails and pathways. Congratulations to the many volunteers that worked on this trail and to the volunteer Board of Directors including Chair Jessica Boyd who are overseeing the evolution of the trail plan.

Applications for the Department of Communities, Culture, Tourism, and Heritage's (CCTH) Community Infrastructure, Active Transportation, and Access-Ability grants for the fiscal year 2025-26 are now open until February 14. This is an important opportunity for local organizations and entities to enhance and improve community facilities and help to support a more accessible and vibrant future for everyone.

There are grants available for renovations to community halls, recreation facilities, rinks and legions, accessibility improvements for businesses and community centres, and active transportation projects that link communities.

To apply, groups must be registered non-profit societies, Mi'kmaw Band Councils, municipalities and villages and schools with facilities available for community recreational use.

Potential applicants can discuss their projects with a CCTH regional manager or program officer before submitting an application to ensure that you are best positioned to succeed in securing the support you need. Remember to bring your tax slips, receipts and valid photo ID.

A tax situation is considered simple if an individual does not have self-employment income or employment expenses, declared bankruptcy in the tax year (or the year before), rental income and expenses, foreign property or foreign income.

WEAR RED DAY

Heart disease is the number one killer of women worldwide and the leading cause of premature death in Canadian women. Wear Red Canada Day (WRCD) is celebrated annually on February 13 to raise awareness about women's cardiovascular. HALIFAX REGIONAL POLICE REQUEST FOR AN ARMOURED RESCUE VEHICLE

Halifax Regional Police (HRP) are seeking funding for an Armoured Rescue Vehicle (ARV) to support officer safety and to serve as a rescue vehicle for citizens in emergency situations. Use of this vehicle would be strictly controlled and only permitted in prescribed situations. Regional Council will vote on this purchase during budget discussions in February. COUNCILLOR DISTRICT CAPITAL FUND

Each Councillor has a small fund that can be used to support non-profits to undertake activities that will benefit the community. To apply we require a letter of request, including the name and address of the non - profit group, and explanation of how the funds will be used and a completed <u>Capital Request Form</u>.

SENIOR CITIZEN SCAM

Police are advising citizens to be cautious of a scam that targets seniors that is continuing to occur throughout our region.

In each incident, the victim received a call from someone pretending to be a family member who indicated that they have been arrested, they are in jail and need bail money.

Another person representing themselves to be from the legal system becomes involved in the call and informs the victim that they need to pay money to have their loved one released from custody. In all recent incidents, a suspect made arrangements to pick up the money in person by attending the victim's residence or meeting in a public place. Recently, the scammers have been asking victims to forward their cash to an address via registered mail or a courier service such FedEx.

If you receive a call like this, do not provide or confirm any personal or financial information and hang up the phone. In Canada, law enforcement and court officials will not attend a residence to collect money in relation to bail.

Call police at 902-490-5020 if you've lost money or your identity has been compromised as the result of a scam. You can report a scam where you haven't been a victim to the Canadian Anti-Fraud Centre or call 1-888-495-8501.
