


Accessible Parking Availability

- In 2021 HRM adopted the Accessible Parking Design & Planning Guideline
 - Where?
 - How Many?
 - What should they look like?
- Audits on existing accessible parking spaces
- New lens for project reviews



Accessible Parking Detail



Enforcement

Parking Services heard that:

- Accessible Parking enforcement was inadequate
 - 2018 Accessible Parking Tickets 967
 - 2024 Accessible Parking Tickets 4,606
- Accessible Parking violation penalties were inadequate
 - Increased fines introduced for repeat offenders
 - 154 Tier 2 (\$200) and 3 (\$400) tickets issued in 2024
 - Province still ultimately controls fine amounts




Accessible Parking Identification

Permits

 Issued by the Province of Nova Scotia

- Requires the certification of a medical professional
- No fee



Can direct citizens to resources







Enforcement

Accessible Permit abuse crackdown

- Parking Services staff can verify permit validity
 - Expired
 - Stolen
 - Deceased

Unlike most other infractions, ticket first, ask questions later

Review is more lenient

Paid Parking

Toronto

"An Accessible Parking Permit holder may park at on-street parking meters, parking machines or mobile only zones without depositing a payment during the hours of legal operation."

Paid Parking (cont.)

What we heard

- Accessible permit holders desire quality over quantity
- Fear that a blanket exemption for paid parking would remove the urgency of designing good accessible spaces
 - Accessible Parking Design & Planning Guideline
- Designated Accessible Parking spaces are free
 - Some have time limits



Winter Works

- On street accessible spaces typically cleared with other on street spaces
 - Winter Parking Ban applies to accessible spaces too
 - Residents encouraged to find off street alternatives during snow events
- Report issues via 311

Signage Must Haves



- White background
- No Parking red circle/letter P
- Blue International Symbol of Accessibility
- Accessible Parking By Permit Only

Alternatives - New York State







- Municipality has no direct capacity to change regulations
 - Appeal to provincial counterparts
