## **DAYLIGHT SAVING TIME**

## HALIFAX WATER UPDATE



# Why did Halifax Water decide to stop fluoridating?

Halifax Water has not decided to stop fluoridating; mechanical/equipment issues at the Pockwock Lake and Lake Major Water Supply Plants have caused interruptions to the process.

- The fluoride storage tank at Lake Major was at end of life and became a safety risk. As a result, it was taken offline, and a plan was put in place to replace it. However, external environmental factors mandated additional changes in the treatment process to maintain compliance. This has delayed the replacement of the fluoride tank as the facility has limited chemical storage space.

- Fluoridation of drinking water resumed at Pockwock Lake on December 12, 2024.

# Who did Halifax Water report the treatment change to?

All drinking water treatment changes, including changes to fluoridation, are reported to Nova Scotia Environment and Climate Change (NSECC) as part of Halifax Water's Approval to Operate permit.

# Is it a requirement to add fluoride to drinking water?

While adding fluoride to drinking water is not a regulatory requirement or mandatory in Nova






Scotia, it has traditionally been decided by communities and public health officials. Halifax Water is currently reviewing these issues with the current HW Board and the Minister of Health and seeking guidance on the next steps.

- In 2014, the HW Board of Commissioners endorsed the addition of Fluoride for Lake Major and Pockwock.
- This decision included support from the IWK, the Nova Scotia Dental Association and the Dalhousie University Faculty of Dentistry.

### HALIFAX TRANSIT SERVICE CHANGES



Starting Feb. 24, 2025

These service changes include the latest installment of Moving Forward Together Plan (MFTP) changes, the reinstatement of 25 trips across eleven routes, a minor schedule adjustment for Route 10C on Saturdays, and the publication of updated route maps and schedules to reflect the reopening of Scotia Square terminal.

- Route 10C Dalhousie: There will be a minor schedule adjustment on Saturdays only, allowing for more travel time between Scotia Square and Dalhousie University.
- **Route 196:** This route will now travel along Highway 102, from Hammonds Plains Road to Bayers Road, taking advantage of bus priority lanes. This route will also add two morning and two evening trips, providing residents with additional options to commute into downtown Halifax.





• Routes 55, 59, 65, 84, 85, 127, 159, 165, 182, 185 and 330: These routes will have 25 previously cancelled trips reinstated, with four of these routes returning to full service.

All Halifax Transit maps and schedules for **routes servicing Scotia Square Terminal** will also be updated to reflect the new and renamed roads in the Cogswell District, and bus routing and bus bay assignments. All service changes, including previous Dec. 2024 Scotia Square changes, will be reflected in trip planning apps as of Feb. 24, 2025.

The introduction of additional trips and routing changes for Route 196 are outlined in the <u>Moving</u> <u>Forward Together Plan</u>. 

## PARKS & RECREATION FEES CHANGING APRIL 1



In 2022, changes to the Parks & Recreation fee structure for recreation programs, services,

rentals, drop-ins and membership fees were announced. In accordance with the five-year fee structure changes, Parks & Recreation fees, including membership fees, will be increasing effective April 1, 2025.

The fee changes will provide more clarity and predictability for residents:

- New user categories will be based on the age group and type of organization.
- Consistent subsidization for fee categories. For example, the fee structure will ensure all youth programs across the municipality receive the same subsidy.
- Reduced risk of unexpected fee increases. The new fee structure accounts for inflation, helping to reduce unexpected and potentially significant fee increases.
- Predictable five-year review cycle. New requirement to review fee structure every five years.
- No user charge for Parks that are rented for public events that are open to the public, non-exclusive and free of charge.
- Overall standardization, consistency and transparency of fees across the municipality. If you have any questions regarding how the Parks and Recreation fee changes will affect you, please email <u>myREC@halifax.ca.</u>

## **RECREATION FUNDING ACCESS PROGRAM**

The Funding Access Program provides recreation opportunities to children, youth and adults in financial need. Depending on the need, the cost of recreation programs could be 50% or 100% covered by the program.

To qualify, you must:

- Live in HRM
- Show proof of financial need
- Apply before registering for a program

All Halifax Recreation programs are eligible except private swim lessons, birthday parties, third-party programs, and rentals.

Proof of financial need must accompany <u>your</u> <u>application.</u> You must include the following as applicable to your application request.

- <u>Canada Child Benefit Statement</u> for children and youth under 18 years of age
- <u>Notice of Assessment</u> for individuals 18 years of age and over
  - <u>Sample Notice of Assessment</u>
- Letter from the <u>Department of</u> <u>Community Services</u>

## ANTI-BLACK RACISM GRANTS PROGRAM



Regional Council has approved funding for 13 projects under the 2024 <u>Anti-Black Racism</u> <u>Grants Program</u>.

The Halifax Regional Municipality's Anti-Black Racism Grants Program offers project-specific funding to eligible registered non-profit organizations and charities within the municipality.

Grants range from \$500 to \$10,000 and focus on five key categories:

- 1. Racial segregation
- 2. Historic omission
- 3. Lack of recognition
- 4. Systemic expropriation
- 5. Negative portrayal in media and literature.

Out of 28 submissions, 13 projects were selected for their strong commitment to addressing systemic challenges faced by Black communities while aligning with the municipality's commitment to equity and inclusion.

# RAMADAN 2025: A HOLY MONTH OF GRATITUDE!



This year, the holy month of Ramadan begins at the first sighting of the crescent Moon on the evening of Friday, Feb. 28.

In practicing the self-restraint and gratitude that Ramadan involves, adult Muslims fast from dawn until dusk at this time and exhibit goodwill through acts of kindness and charity.

Ramadan is the ninth month of the Muslim calendar and begins and ends with the appearance of the crescent moon.

Ramadan is expected to last from Feb. 28/March 1 to March 29 in 2025. However, these dates can vary slightly depending on the crescent moon's appearance.

#### **TRAFFIC CALMING MEASURES**

High Road (Heddas Way to Lockview Rd), Fall River

Kinclaven Drive (High Rd to Lockview Rd), Fall River

Halifax Regional Municipality is committed to road safety for all users. In February 2016 Regional Council approved the Traffic Calming Administrative Order which focuses on making neighbourhood streets safer for all users by slowing down traffic.



Traffic is calmed by constructing physical measures to encourage safer driving behaviours. Under the Traffic Calming Administrative Order, a review of High Road & Kinclaven Drive was completed which included the collection of vehicle speed and volume data as well as other features of the roadway.

As a result, High Road was identified as eligible for traffic calming measures. SPEED TABLES were selected as the appropriate traffic calming measure for High Road & Kinclaven Drive. Speed tables encourage slower speeds of travel by causing discomfort for drivers travelling at higher speeds. There is no negative effect on





cyclists riding at moderate speeds, and there is no effect on resident access or on-street parking. Transit buses can also traverse speed tables with minimal impact. With the construction of speed tables on High Road & Kinclaven Drive we expect slower vehicular speeds.

The figure below shows the approximate speed table locations on High Road & Kinclaven Drive.



Please note these locations may very slightly during construction to minimize the impacts on driveways and drainage structures.

This work is planned for the 2025 construction season.

The project involves several stages and temporary traffic control measures to install the asphalt speed tables along with associated pavement markings and signage work. Efforts will be taken to reduce the impact to your property during construction.

Both on-street and private driveway parking may be impacted. Notice of project timing and

impacts to parking and driveway access will be provided before construction.

Property owners are responsible for removing and relocating any personal property in the street prior to construction. Property that is not relocated may be removed without notice. Trees in the street are Municipal property and must not be removed by the property owner.

It is important that you contact 311 if:

- You have a heated driveway, invisible dog fence or in-ground sprinkler system near the street property line(s).

- You have an anticipated project within the next two years requiring a pavement cut, including driveway access modifications1. You will need to apply for a permit and coordinate with the upcoming capital work. If the work involves utilities servicing, please reach out to them to coordinate the work. For water or sewer lateral works, contact Halifax Water at 902-420-9287. For installation of natural gas laterals, contact Eastward Energy at 1-877-836-7427.

- Anyone at your address has difficulty crossing uneven ground, gravel or using steps. We will work with you for alternate access, where possible, during the project.

- You are aware of any problems relating to your property's drainage, or water/sewer servicing lateral lines connecting to your property.

We look forward to working with you and welcome your questions through our call centre at 311.

Please note that HRM By-Law S-300 states that pavement cuts will not be permitted,





except to address emergency work, for two years after the street has been paved.

#### BUDGET 2025/2026



Please be advised of the following key dates for the 2025/26 municipal budget process.

The municipal budget funds all costs associated with servicing a growing municipality. This includes day-to-day municipal operations, capital priority initiatives approved by Regional Council and capital projects and investments to purchase, construct, rehabilitate and replace municipal assets.

There are several milestones in the annual municipal budget process. Below are the key dates for the 2025/26 municipal budget process:

Wednesday, March 19

 Budget Adjustment List (BAL) Review: The BAL includes all additional items that business units have presented beyond their proposed budgets, including addons ("overs") and subtractions ("unders").

Tuesday, April 8

• Budget Approval

### WINDSOR STREET EXCHANGE



At the Feb. 25 meeting, Regional Council voted 15-2 in favour of proceeding with the Windsor Street Exchange project under its current design and funding agreement.

The proposed project aims to add active transportation connections and transit priority measures through the intersection, improve the movement of vehicles and goods through the area, and improve the safety for all road users.

The previous design was rejected at the Jan. 28 meeting, when Council raised concerns about the lack of a firm commitment to Bus Rapid Transit (BRT) and active transportation in the design. On Feb. 25, staff presented a supplementary report







with a revised recommendation based on Council input.

This includes design and construction of new structures within the project area to accommodate additional dedicated transit lanes and separated pedestrian and cycling facilities.

Municipal staff will also now start planning a second phase of the project, which will include road-widening to provide additional right-ofway for dedicated transit lanes in both the inbound and outbound directions. It will also include separated sidewalks and cycling facilities for active transportation connections from Joseph Howe Drive to Kempt Road.

### **BLOOMFIELD STAFF REPORT**

At the Feb. 25 meeting, Regional Council voted unanimously in favour for a staff report that would look at opportunities to address the situation at the closed Bloomfield School site in light of the recent fire, including addressing the timely demolition of the remaining structures as well as options for cost recovery.

The report will also provide an update regarding the Municipality's buy back rights to the property.

The former Bloomfield School site has sat vacant since 2014, and since being bought in 2021, continues to remain vacant.

The motion indicates that information should be provided to HRM Council to determine what

options and opportunities are available to address the unsatisfactory situation currently occurring on the property.

## COGSWELL DISTRICT PROJECT UPDATE



The final year of construction for the Cogswell District Project is here. Here's the quarterly project update for Winter 2025:

Phase 2 of the project was completed on December 24, 2024. Barrington Street from the roundabout at Nora Bernard Street, through to Duke Street, re-opened to all traffic along with Cogswell Street from Brunswick Street to Upper Water Street.

The Nora Bernard Street leg of the roundabout remains closed except to local traffic to enable underground services installation.

The Barrington Street Transit Terminal was relocated back to its permanent home on Barrington Street between Cogswell Street and Duke Street. Work continues on the installation of bus shelters, benches and signage which are expected to be completed by mid-March.

Commemorative names were approved and implemented for three streets in the Cogswell





District: Reconciliation Way, Dr. Alfred Waddell Street and Amalamek Way.

The third and final phase of project construction began on January 6, 2025. This final year of construction (2025) will see the completion of the remaining street network, underground infrastructure, four parks: Granville Mall Park, Barrington Street Park, Upper Water Street Park and Amalamek Way Park, as well as two kilometres of separated bike paths and multi-use paths.

Substantial work will take place on Upper Water Street in the next 12 months. There will be a variety of changes and disruptions to traffic, pedestrian and bicycle movement starting in April.

These changes will be detailed and announced well in advance of the work occurring. Current work is focused on construction of the two westernmost lanes of the redesigned street.

Underground services are being installed on the lower portion of Dr. Alfred Waddell and will connect to those being installed on Amalamek Way and Nora Bernard Street.

The roof of the Granville Park stage is slated for completion by end of March.

## EXTRA CARE ACCESSIBLE TAXI SERVICE



Halifax Regional Municipality supports an accessible taxi service, <u>Extra</u> <u>Care Taxi</u>, that

operates vehicles 24 hours a day, 7 days a week across the municipality. Passengers pay the standard taxi rate for trips.

Bookings can be made by phone at 902.334.0334, <u>online</u>, or through the <u>Extra</u> <u>Care Taxi App</u>, found at the Google Play store or the Apple Store. In March 2022, Regional Council <u>approved a staff recommendation</u> to grant a three-year contract to Extra Care Taxi. The municipality provides funding to Extra Care Taxi to support the extra cost of accessible service. Extra Care Taxi is part of <u>SeniorsTransit</u>.

The municipality's support for an accessible taxi service is based on feedback from:

- residents and visitors citing the lack of accessible vehicles, making spontaneous trips a challenge.
- service providers about the high costs of providing accessible taxi services
- The municipality's *Accessibility Strategy*, which mandates the creation of an inclusive environment for individuals with disabilities and acknowledges the need to create accessibility for all, regardless of ability.





### ACCESSIBILITY STRATEGY APPROVED



Halifax Regional Council has approved the **2025/28 Accessibility Strategy**, representing an important step in our continued commitment to a more accessible region.

The 2025/28 Accessibility Strategy focuses on how we can improve accessibility throughout the municipality by identifying, removing and preventing barriers for persons with disabilities. In line with the Nova Scotia Accessibility Act, the 2025/28 Accessibility Strategy has 30 recommendations with five key focus areas:

- Transportation and Transportation Infrastructure
- Built Environment
- Information and Communications
- Goods and Services
- Employment

Through deliberate and conscious planning and with this strategy as our guide, the municipality will work diligently to make our municipality a more inclusive place. For more information, read the <u>staff report</u>.

Staff propose a one-year community mediation pilot (with the possibility of year-by-year renewals). Once approved in the 2025/2026 Operating Budget, Council has directed the Chief Administrative Officer to provide a contribution of \$100,000 to the United Way of Halifax to create and implement this pilot program. The addition of this dataset brings the total number of Open Data datasets to 255.
