#### **BUDGET 2025/26**



**Regional Council is** scheduled to approve the 2025/26 municipal budget on Tuesday, April 8.

Following the Monday, March 25 Budget Committee meeting, the approved items from the Budget Adjustment List (BAL) result in the residential tax implications detailed below:

• 0.772 tax rate (an increase of 0.002 from 2024/25) – two thousandths of a cent higher than last year.

The municipal budget funds all costs associated with servicing a growing municipality. This includes day-to-day municipal operations, capital priority initiatives approved by Regional Council, and capital projects and investments to purchase, construct, rehabilitate and replace municipal assets. #### WILDFIRE SEASON



Wildfire season runs from March 15 to October 15. While burning restrictions are in effect yearround, additional restrictions are in effect during wildfire season.

Fire safety is key to protecting your home and community. Follow these tips every time you make an outdoor fire:

- Always check the daily burn restrictions before starting a fire to ensure it's safe and allowed.
- Never leave your fire unattended -• unattended fires can spread quickly and become dangerous.
- Completely extinguish your fire douse it with water, stir the ashes and repeat until everything is cool to the touch.

Through a voluntary process, residents may register to receive a wildfire risk assessment for their property using the **<u>FireSmart</u>** standard. The FireSmart program is a national initiative designed to help communities and property owners reduce the risk of wildfires.





It provides education, guidelines and practical actions to minimize fire hazards in homes, businesses and public spaces.

#### **BEFORE YOU BURN: A NEW ONLINE TOOL TO CHECK FOR DAILY BURN RESTRICTIONS IN THE HALIFAX REGION**

The Halifax Regional Municipality has launched **Before You Burn**, a new online tool that provides residents and visitors with up-to-date information on whether burning is allowed in the Halifax region.

Before starting an open-air fire, check <u>Before</u> <u>You Burn</u> to stay informed and ensure compliance with municipal and provincial regulations.

#### WHY BYB?

- No more guesswork this tool is specific to your civic address.
- Quick visual access to the burn status for the municipality (open, restricted, ban, etc.).
- More detail including the Halifax-specific fire risk index.
- Detailed descriptions of all burning types (campfires, brush burning, etc.).

Both the Province of Nova Scotia and the municipality have burning restrictions in effect.

The new <u>Before You Burn</u> tool displays the burning restrictions in effect across the municipality by comparing municipal by-laws

and provincial legislation with live data from the provincial fire restrictions webpage. Visit beforeyouburn.halifax.ca to see if burning is allowed.

#### APRIL 14 – NEW SUMMER CAMP REGISTRATION PLATFORM



A new online recreation software was launched on **April 1.** Beginning April 14, Summer camp registration will use the new registration platform. The <u>/MyREC</u> <u>webpage</u> will remain

the same but will link to the new system.

However, you will need to set up a **new password** and **link your payment information** to your new account if you wish to complete online transactions.

#### **RECREATION FUNDING ACCESS PROGRAM**

#### The Funding Access Program provides

recreation opportunities to children, youth and adults in financial need. Depending on the need, the cost of recreation programs could be 50% or 100% covered by the program.

To qualify, you must:

- Live in HRM
- Show proof of financial need
- Apply before registering for a program

All Halifax Recreation programs are eligible except private swim lessons, birthday parties, third-party programs, and rentals. Proof of financial need must accompany your application. You must include the following as applicable to your application request.

- Canada Child Benefit Statement for children and youth under 18 years of age
- Notice of Assessment for individuals 18 years of age and over
  - <u>Sample Notice of Assessment</u>
- Letter from the <u>Department of</u> **Community Services**

#### **REFUGEE RIGHTS DAY**



April 4 marks Refugee Rights Day, which is an opportunity to bring attention to the advances made in the protection of refugee rights in Canada as a result of the 1985 Singh Decision.

In this decision, the Supreme Court found that the Canadian Charter of Rights and Freedoms protects the fundamental rights of refugees.

The Court decided that 'everyone' includes refugee claimants in the sentence: 'Everyone has the right to life, liberty and security of the person and the right not to be deprived thereof except in accordance with the principles of fundamental justice.'

# FREE SHORELINE NATURALIZATION TRAINING



This spring, the municipality's Environment and Climate Change team, in partnership with TransCoastal Adaptations (TCA) at Saint Mary's

University and the Ecology Action Centre, will launch a new project called Living Lakeshores.

This project aims to increase the resilience of freshwater shorelines in the Halifax region and build community understanding of natural restoration approaches in sensitive ecosystems.

The municipality will be offering free shoreline naturalization training to residents, delivered by TCA.

This training is based on the <u>Green Shores</u> <u>initiative</u> and will give residents the skills and knowledge to contribute to climate adaptation and help municipal staff implement green infrastructure projects.

Please note that each training has a maximum capacity of 20 people.

#### THE BUILT ENVIRONMENT ACCESSIBILITY STANDARD




The Built Environment Accessibility Standard focuses on rules for outdoor and recreational spaces that will be required in the design and planning of new infrastructure starting April 1, 2026.

On April 28, Nova Scotians will join with Canadians across the nation, and over 100 countries around the world, to recognize the National Day of Mourning.


This day has been designated as a time when workers, families, employers and others come together to remember those who have died or been injured at work.

# HALIFAX NAMED A 2024 TREE CITY OF THE WORLD

Since first earning this recognition in 2019, we've continued investing in urban forestry planting 1,200 trees in 2024 alone.

To receive this recognition, Halifax meets five key standards, including responsible tree management and public education efforts. This





work is part of our broader goal to build a more livable and resilient municipality.

#### WHEN TO CALL AN ARBORIST



Halifax Regional Municipality is fortunate to have a dedicated team of tree care professionals responsible for maintaining and managing our large inventory of public trees.

In HRM, a public tree is defined as any tree where the majority of the trunk is on municipal land, including parkland and the space between the curb and private property (right-of-way).

Ownership of the tree in front of most properties in HRM typically depends on how close the tree is to the roadway, but it's not always that simple. The width of the right-of-way space varies across the municipality, from street to street.

If you are unsure if a tree is public or private, you can call 311 and we can assist with a measurement.

#### Why does this matter?

HRM maintains and manages public trees, ensuring their health and safety.

If you have concerns about a public street tree (or park tree), you can call 311, and a Certified Arborist can assess it and determine if action is required.

#### When to call an Arborist for Private Trees

For trees on private property (e.g. side-yards, backyards, private portion of the front yard), hiring an arborist is advisable if you notice dead or dying branches, cracks in the trunk, leaning or unstable trees, fungal growth, visible signs of stress, damaged roots, pest infestation, cavity or hollow sections, storm damage, tree trimming, safe tree removal and tree assessments.

#### Why Hire an Arborist?

Arborists have put in hundreds of hours toward through schooling, exams, certification, and apprenticeship, all to know the right decisions for the right scenarios.

Arborists provide an expert assessment and ensure the job is done right.

HRM has a robust arboriculture industry equipped to understand the local conditions and species. Check online for reputable firms.

For public tree concerns, call 311. For private trees, a professional arborist can help keep your trees healthy and your property safe.





#### **STRATEGIC PLAN SHAPE YOUR CITY SURVEY**




The Halifax Regional Municipality is inviting residents to review the draft 2026-2030 Strategic Plan content and provide feedback.

The Strategic Plan reflects the municipality's vision, mission and values – and establishes key areas of focus now and into the future. The fouryear plan outlines priorities and goals, which guide how the municipality tracks progress and aligns business plans and budgets. The plan also helps municipal employees understand how their work fits into the long-term goals of the organization, and how they can work together to make a difference in the region. The draft Plan content has been informed by the results of the 2024 Resident Survey and workshops with Regional Council and the administration's senior leadership. While reviewing the draft Plan content, residents can provide feedback on if it reflects the most pressing issues facing the municipality; prioritizes what is most important for Regional Council and the municipal administration; and includes perspectives for the entire region.

Results from this engagement will support **Regional Council in determining final priorities** and goals for the 2026-2030 Strategic Plan.

#### THE SECOND UNIT INCENTIVE **PROGRAM**



The Halifax Regional Municipality has introduced a new program to help property owners create more housing options across the region through non-repayable funding. The Second Unit Incentive Program offers financial grants to help offset costs associated with building new second units. Eligible residents can receive up to \$12,000 to help reduce building expenses related to water and wastewater.

Funded through the Housing Accelerator Fund (HAF), this program is part of the municipality's commitment to increasing housing availability and supporting sustainable community development.

The program is available to owner-occupants of a one-unit dwelling who are up-to-date on property tax payments, where land use by-laws allow. A building permit is also needed to apply.

Applications will be open until **June 1, 2026**, or until funding is fully allocated. More information on how to apply can be found here.

#### **MOBILE FOOD MARKET**



Regional Council has approved an increase in funding from \$75,000 to \$175,700 to the Mobile Food Market.

Rising costs, soaring rates of food insecurity and growing interest in community- based, welcoming and dignified ways of accessing food has resulted in an unprecedented demand for the services of the Mobile Food Market. Since 2019, there has been a dramatic increase in food distribution and has challenged the ability of the Mobile Food Market to respond to communities.





Additional funding will be used to continue supporting a senior leadership role, an additional full-time employee, and for program funding. Regional Council has also approved the continued support for two years until 2029 and directed the Chief Administrative Officer to work with the Mobile Food Market and other partners for the purchase of a new hybrid or electric vehicle.

#### COGSWELL DISTRICT PROJECT UPCOMING TRAFFIC DISRUPTIONS

The Halifax Regional Municipality is advising residents of a series of traffic disruptions along Upper Water Street during the upcoming construction season. This work is needed to facilitate the final year of construction for the Cogswell District project.

**Work details:** These disruptions are necessary for the installation of final underground infrastructure and the reconstruction of Upper Water Street, which will include:

- realignment of the intersection at Barrington Street;
- increase in street grade; and
- construction of a new roadway with bike lanes, sidewalks, trees and widening to four lanes.

**Traffic impacts:** To complete this work, the following traffic impacts are expected:



- April 14 to May 5 Upper Water Street will be closed at Barrington Street.
- April 19 to 22 The intersection of Upper Water and Cogswell streets will be closed.
- Early May (exact dates TBC) Traffic will be moved onto the newly constructed west side lanes of Upper Water Street and the existing east side lanes will close.
- Mid-June to early July (exact dates TBC) Traffic along Upper Water Street will be reduced to a single lane with stop-and-go traffic control for a period of time.

As part of the Youth Climate Action Fund (YCAF), Halifax received \$140,000 from Bloomberg Philanthropies and United Cities and Local

Governments to accelerate climate action and mobilize youth-driven innovation in the municipality.

Alongside our partner HCi3, we're giving out small grants of up to \$7,000 to youth-led and youth-serving groups working on climaterelated projects in the region.

We are extending the deadline for applications to **Monday, April 7**. No previous experience with grant writing is required, and our YCAF team is

more than happy to help with the application process.

The Youth Climate Action Fund gives financial support to young innovators who have creative ideas about how to tackle climate change. This funding is aimed at recognizing and rewarding the incredible resourcefulness of our young residents in the face of the climate crisis. The site cannot be seen from the main roads or homes surrounding the area. There may be some construction vehicles and equipment in the area, but we will make every effort to minimize any inconvenience.
