SUBJECT: Formal Adoption of BoPC Policy on Armoured Rescue Vehicle

#### **ORIGIN**

May 21, 2025 meeting of the Board of Police Commissioners, Item 10.2.3

It is recommended that the Board of Police Commissioners for the Halifax Regional Municipality adopt in principle, subject to a period of public comment, the policy entitled Armoured Rescue Vehicle, for inclusion in the Board of Police Commissioners' Policy Manual, as outlined in Attachment 1 of the staff report dated May 1, 2025, including an amendment to the definition section of the policy to replace the definition of "Chief of Police" to "Chief Officer" meaning the Chief of Halifax Regional Police.

MOTION PUT AND PASSED

#### **RECOMMENDATION**

It is recommended that the Board of Police Commissioners for the Halifax Regional Municipality adopt the policy entitled Armoured Rescue Vehicle, for inclusion in the Board of Police Commissioners' Policy Manual, as outlined in Attachment 1.

#### **BACKGROUND/DISCUSSION**

Following a period of public feedback, it is recommended that the following clause be added to the proposed policy entitled Armoured Rescue Vehicle to ensure alignment with other BoPC policies:

Mission, Vision and Values

6.3 The chief officer shall ensure that HRP's policies regarding an Armoured Rescue Vehicle align with the mission, vision and values, as outlined in HRP's Strategic Plan<sup>1</sup>, and the Principles of Policing, as outlined in HRM's Police Board By-law P-100.

Minor housekeeping amendments were also made in the Definitions section to reflect updated language.

#### FINANCIAL IMPLICATIONS

There are no immediate financial implications to this report. Any future financial implications arising from implementation of the recommendations will be addressed in staff reports and HRM departmental budgets as required.

#### **COMMUNITY ENGAGEMENT**

The Board of Police Commissioners is comprised of four citizen members and three Councillors. Meetings are live webcast on Halifax.ca. The agenda, reports, video, and minutes of the Board are posted on Halifax.ca. The proposed Armoured Rescue Vehicle policy was posted for public feedback on the BoPC website between May 22 and May 29, 2025.

Designed to provide ballistic protection and withstand hostile environments, an ARV is typically equipped with reinforced armor, bullet-resistant glass, tactical communication systems, and may include medical or extraction tools to support rescue and tactical operations.

#### **ORIGIN**

This is a staff initiated report.

#### RECOMMENDATION

It is recommended that the Board of Police Commissioners for the Halifax Regional Municipality adopt in principle, subject to a period of public comment, the policy entitled Armoured Rescue Vehicle, for inclusion in the Board of Police Commissioners' Policy Manual, as outlined in Attachment 1 of this report.

#### **BACKGROUND**

Regional Council approved the procurement of an armoured rescue vehicle (ARV) as a part of its 2025-2026 capital budget

### **DISCUSSION**

During budget deliberations, Commissioners and Regional Councillors expressed the importance of adopting an ARV policy prior to its deployment.

This attached policy ensures the ARV is used responsibly, with oversight, proper training, and regular maintenance to support effective and safe law enforcement operations. Specifically, the recommended board policy provides direction to the Chief to produce an HRP policy with respect to the use of an ARV

that ensures the following:

- The approval and oversight of a qualified Critical Incident Commander is required for the operational deployment of the ARV;
- A list is created of approved and non-approved uses for the ARV;
- Operators successfully complete an ARV operator qualification program;
- The creation of a process to determine whether requests for use of the ARV by other police services will be considered;
- The regular inspection and maintenance of the ARV; and
- The safe storage of the ARV.

The proposed policy also outlines biannual reporting requirements for the Chief.

There are no immediate financial implications to this report. Any future financial implications arising from implementation of the recommendations will be addressed in staff reports and HRM departmental budgets as required.
