
HALIFAX TRANSIT – BUS STOP CONSTRUCTION

UPDATE - STOKIL/ MILLWOOD/ BEAVER BANK ROAD SIGNALS

Through investigation, staff discovered a Traffic Detection Sensor on the east/west entry points was defective and was replaced on May 21. This was in addition to the communication modem replaced a few weeks prior. Fresh sets of Signal Timing Instructions are currently being uploaded and should be completed by the end of day May 22.

PROPOSED HIGHWAY 102 WEST CORRIDOR & SPECIAL PLANNING AREA



On Tuesday, May 16, 2025, approximately 255 hectares (630 acres) of land located west of

Highway 102 between Kearney Lake Road and Lacewood Drive in Halifax, were designated a Special Planning Area under the Housing in the Halifax Regional Municipality Act.

The Regional Plan Review has identified the need for additional serviced lands to accommodate population growth. In January 2022, Regional Council directed staff to advance background studies needed to consider urban development of four potential Future Serviced Communities and the Highway 102 West Corridor Lands were included in that study. Since then, the Future Serviced Communities (FSC) Study has been completed for the Highway 102 West Corridor Lands and the Minister of Growth and Development has initiated secondary planning, also known as comprehensive neighborhood planning. A comprehensive neighbourhood planning process considers all aspects of planning a new neighbourhood. Strategic public investments in infrastructure, parks and facilities may also be identified. The outcome is new municipal policies and regulations to guide and support new development in the area informed by HRM priority plans, public consultation, collaboration with internal and external review agencies, proposals from landowners, and supporting studies.

Expected Units: Approximately 11,500 units

Status: Background studies are complete and will inform potential future development of the area. The studies include a land suitability analysis, watershed analysis, transportation and mobility analysis, and water and wastewater servicing study. On May 16, 2025, the Minister of Growth and Development initiated secondary planning for Highway 102 West Corridor Lands Special Planning Area.

More information on the planning process will be provided once planning is underway.




