•Three-year pilot began in 2017, pilot ended in March 2020


•Currently in our fifth-year post-pilot

•Funded by the Canadian Department of Justice




### Independent Legal Advice for adult survivors of Sexual Assault

The Independent Legal Advice (ILA) program provides free, independent legal advice to adult survivors of sexual assault. The program respects survivors' privacy and their right to make their own decisions.



### Independent Legal Advice for adult survivors of Sexual Assault Eligibility

- participants must be 16 years or older at the time they access the program.
- the sexual assault must have occurred in Nova Scotia.







### How to Access Legal Advice

• Call, email, live chat, or text 211 Nova Scotia between 8:00am and 8:00pm to speak with someone locally to register for the program.

•Once registered, client will receive a package from 211 including the following:

Certificate number
A list of Lawyer profiles
FAQ's
Survey
List of resources – for neighbouring counties

•Clients may select any lawyer on the list to contact to make an appointment.

### How to Access Legal Advice continued..

•Lawyer confirms certificate number with 211.

•Appointment is set and up to 2 hours of free legal advice is received.

• We can provide translation and other accessibility services if required.

# ILA Lawyers

ILA currently has a roster of 19 skilled lawyers.

Lawyers must:

Be insured

Be a member in good standing with the Nova Scotia Barristers' Society

Have a clear vulnerable sector check.





The ILA Roster consists of a diverse team of trauma-informed lawyers:

- from diverse communities;
- from other provinces;
- who have experience with criminal, civil, and other types of law.



## ILA Statistics April 2024 – March 2025 Fiscal Year

In total there were 201 Certificates issued.

Clients will not be identified to the Department of Justice.

Clients do not need to disclose details about the assault to 211, there is no obligation to report the incident to the police and clients do not need to act on the advice received.

211 Nova Scotia is a free, confidential, and accessible information and referral service provided to Nova Scotians 24/7.
