EMANCIPATION DAY



In 2021, Nova Scotia officially designated August 1 as Emancipation Day, a time to reflect and acknowledge our shared history of the enslavement of people of African descent in Canada.

On August 1, 1834, the Slavery Abolition Act of 1833 became law, officially ending the practice of slavery across the British Empire.


Slavery was foundational in the systemic anti-Black racism that impacts people of African descent today. Recognizing Emancipation Day provides an opportunity to maintain ongoing meaningful dialogue around race relations and inclusion, and to celebrate the diverse heritage,





culture and contributions of people of African descent across the region.

DARTMOUTH ROAD RACE



The Dartmouth Natal Dav Road Races have been held in Dartmouth continuously since 1907, making it one of the oldest races in North

FREE SWIMMING LESSONS AT **RURAL BEACHES**



The Halifax Regional Municipality is offering residents free swimming lessons at rural

beaches and lakes this summer for children and youth.

The new weekly swim programs include general swimming lessons and lifesaving programs (including Bronze Cross and Workplace First Aid).

These programs compliment the municipality's annual swim lesson programs, which run at supervised beaches across the municipality. It also aligns with the recommendations of the Rural Recreation Strategy.

All lessons are free and ages for each program differ.

BEACH CLOSURES – WATER QUALITY



Lifeguard supervision and water quality testing in 2025 will take place between July 1

and Sept. 1.

Know your swimming limitations if you choose to swim in unsupervised bodies of water. Always swim with a buddy in supervised areas

and adults should never leave children unsupervised in the water.

Beach status in 2025 is updated weekdays by 8 a.m. and by 9 a.m. on weekends (between July 1 and Sept. 1). Please note that beach closures due to suspected blue-green algae can happen at any time. The municipal website will be updated as needed regarding bluegreen algae-related closures.

Water sample results are provided when they exceed Health Canada Guidelines for Recreational Water Quality. More information on testing processes and Health Canada guidelines are available here: <u>Water Testing at</u> <u>Supervised Beaches.</u>

NOTE: HRM stopped testing First Lake in 2020 due to poor bacteria quality. It is better known as the Kinsman Beach and is not currently supervised by the Halifax Regional Municipality (HRM). It was removed from the HRM's supervised beach program in 2020 due to frequent high E. coli levels. The beach is still used by residents, but there are no lifeguards.

<u>The Aerotech Connector</u> will be a four-lane road, with an adjacent active transportation

trail, between Exit 5A at Highway 102 and Trunk 2 in Wellington near Sunnylea Road.

At a length of 5 kilometres, the connector will provide quicker and shorter access from the Wellington area to the Aerotech Industrial Park Page and Halifax Stanfield International Airport.

The roundabout at Trunk 2 and the connector road will open in the summer/fall of 2025.

COBEQUID ROAD TINY HOME COMMUNITY - UPDATE



In response to many concerns raised by residents concerning the tiny home community

on Cobequid Road, I reached out to <u>Atlantic</u> <u>Community Shelters Society</u> and asked how they are addressing the issues raised. I have attached their letter of response below.

Hello Councillor Gillis & Chris,

Thank you for bringing this concern from a resident forward. We appreciate hearing from community members who demonstrate care for their neighbours.

As you know, the Sackville tiny home community is designed to offer wrap around supports so people are able to remain successfully housed. The homelessness experience for each individual is unique, and so is their healing journey. It is also not always linear. Many individuals have experienced trauma and have lacked appropriate support over time.

ACSS and United Way have worked together to create policies and practices that are meant to keep residents safe and provide them with the support they need to thrive. For the majority of residents, these policies are working well. Tenants are respectful of each other and of staff and visitors, they take pride in their home, and they are working through the barriers that previously made finding and sustaining housing difficult.

For others, the transition has been less smooth. We understand that some residents have used substances in the past to deal with homelessness and other challenges. Our policies do not allow for the use of illegal substances on site. ACSS offers substance use counselling to residents who indicate they need this support, amongst other supports to help them reach their personal goals. It is important to note that those substances may be legal. However, unlike housing supports for those with higher acuity, staff do not have eyes on residents 24/7. Residents might use illegal substances in the privacy of their own homes without our knowledge.

If it becomes known that a resident is using illegal substances, we have mechanisms in place to offer additional support or, if necessary, to end their tenancy. Ending a tenancy is a last resort, but it does happen in cases where the needs are higher than what can be met by staff, or in cases of harassment, violence or another threat to the safety and well-being of residents, staff or visitors.

Tenants start on short term, one month fixed term leases, and those that appropriately thrive have their leases extended. In cases where a tenant has violated a policy that threatens the well-being of the community, we let tenants know they may not be offered a new short term and offer to help them find alternative shelter options.

The tiny home community is still very new, and we are still learning and refining as we go. We expect that we will occasionally have tenants who don't thrive in this environment, but we hope that as we learn, we can continually improve so that these situations are very rare.

The program will make four surplus municipal properties available to eligible nonprofit organizations for one dollar to help offset land acquisition costs:

• 48 Pinecrest Drive, Dartmouth






- 15 Laurelcrest Drive, Eastern Passage

Proposal Details



On June 9, the North West Community Council (NWC) held a public hearing on <u>PLANAPP</u> <u>2024-00312: Development Agreement for 229</u> <u>Beaver Bank Road, Beaver Bank</u>. The proposed development maintains the existing single unit dwelling located on the subject property as well consists of 17 residential units arranged in five (5) townhouse blocks located off a new private driveway with access to the Beaver Bank Road.

COMMUNITY MEDIATION PILOT



Halifax Regional Council has approved funding and directed staff to collaborate with the

United Way Maritimes to create and implement a Community Mediation pilot program. This initiative will provide voluntary, confidential,





and impartial mediation services to residents experiencing interpersonal disputes across multiple neighbourhoods in the municipality.

The pilot program aims to improve community safety and cohesion by offering no-cost mediation and conflict coaching in accessible, neutral locations, including virtual options. The program will focus on common neighbourhood conflicts such as noise, parking, property boundaries, and nuisance issues, while excluding legal and certain sensitive matters.

This partnership leverages United Way Maritimes' extensive community presence and expertise to deliver services in diverse urban and rural areas including Spryfield, Fairview, Dartmouth North, and East Preston. A project coordinator will be hired to oversee program design and delivery, with referral pathways established through municipal staff, community partners, and self-referrals.

This program supports safer, stronger communities by offering a helpful way to solve disputes without legal action.

PROPERTY TAX REBATE FOR SENIORS



The Nova Scotia Property Tax Rebate for Seniors program helps low-income seniors with the cost of municipal residential property taxes. The rebate amount is based on your municipal residential property taxes. Rebates are 50% of what you paid on last year's property taxes, up to a maximum of \$800. You can apply until Dec. 31, 2025.

To qualify for the rebate, you need to meet all of the following criteria:

- your 2024 municipal residential property taxes are paid in full (your name is on the property title)
- you lived at the property as your primary residence in 2024 (the property can't be someplace that you live occasionally or a seasonal home)
- you receive or are eligible to receive the <u>Guaranteed Income</u> <u>Supplement</u> (GIS) or the <u>Allowance</u> from Service Canada as of 1 July 2025

If you're not already receiving the Guaranteed Income Supplement (GIS) or the Allowance, you can check with Service Canada to see if you're eligible for them.

As a regulated public utility, <u>Halifax Water</u> must conduct business in accordance with the Halifax Water Regulations as approved by the <u>Nova Scotia Utility and Review</u> <u>Board</u> – now the <u>Nova Scotia Energy and</u> <u>Regulatory Boards Tribunal</u>. These can be used to help you determine if we have applied an approved practice. Halifax Water will respond to concerns and complaints about:

- Billing
- Metering and meter reading
- Application of standard charges
- Misuse of water resources, sanitary, or stormwater systems
- Halifax Water staff or service delivery

If you are not happy with Halifax Water's response, you may make an appeal to the <u>Dispute Resolution Officer</u> (DRO).
