

NOTICE OF PUBLIC HEARING

GUS GHOSN ET AL. have made an appeal to the Nova Scotia Regulatory and Appeals Board from a decision by the Chief Administrative Officer of the Halifax Regional Municipality approving modification of restrictive covenants to allow development of property located at 1462 Thornvale Avenue and 1445 Birchdale Avenue, Halifax (PIDs 00078352 and 40439796) in accordance with the underlying Regional Centre Land Use By-law's Established Residential 3 (ER-3) zoning. This matter will be considered in a public hearing. The Municipality has asked the Board to consider preliminary motions on issues of jurisdiction. A date for the public hearing of the formal appeal will be set later, subject to the outcome of the preliminary motions.
