NOTICE OF PUBLIC HEARING

SARAH MATHESON ET AL. have made an appeal to the Nova Scotia Regulatory and Appeals Board from a decision by the Chief Administrative Officer of the Halifax Regional Municipality approving modification of restrictive covenants to allow as of right development as per the Established Residential 3 (ER-3) zone in the Regional Centre Land Use By-law for property located at 5914 Chain Rock Drive, Halifax (PID 00000133) This matter will be considered in a public hearing. The parties have asked the Board to consider preliminary motions on issues of production and jurisdiction. A date for the public hearing of the formal appeal will be set later, subject to the outcome of the preliminary motions.

- You may request formal standing as an Intervenor, subject to Board approval. This will allow you to present evidence or cross-examine witnesses. Your request must be received by the Board by **Wednesday, September 10, 2025**, and a copy of your written submissions on the

preliminary motions by **Monday, September 22, 2025**, for Intervenors supporting the motions, and by **Tuesday, October 14, 2025**, for Intervenors opposing the motions.

- You may request the hearing be audio or videocast. Your request must be received by the Board by **Monday, September 22, 2025**. The Board will make its best effort to accommodate any such request.
- Alternatively, you may request a copy of the audio file for proceedings after the hearing by contacting the Clerk of the Board.
