

NOTICE OF PUBLIC HEARING

SARAH MATHESON ET AL. have made an appeal to the Nova Scotia Regulatory and Appeals Board from a decision by the Chief Administrative Officer of the Halifax Regional Municipality approving modification of restrictive covenants to allow as of right development as per the Established Residential 3 (ER-3) zone in the Regional Centre Land Use By-law for property located at 5914 Chain Rock Drive, Halifax (PID 00000133) This matter will be considered in a public hearing. The parties have asked the Board to consider preliminary motions on issues of production and jurisdiction. A date for the public hearing of the formal appeal will be set later, subject to the outcome of the preliminary motions.
