NOTICE OF PUBLIC HEARING

TELAINA KELLY ET AL. have made an appeal to the Nova Scotia Regulatory and Appeals Board from a decision by the Chief Administrative Officer of the Halifax Regional Municipality approving modification of restrictive covenants to allow construction of a backyard suite in accordance with the Planning Districts 14 & 17 Land Use By-law at 221 Aberdeen Drive, Fall River (PID 41243676). This matter will be considered in a virtual public hearing. The Municipality has asked the Board to consider a preliminary motion on issues of jurisdiction. A date for the public hearing of the formal appeal will be set later, subject to the outcome of the preliminary motion.

- You may request formal standing as an Intervenor, subject to Board approval. This will allow you to present evidence or cross-examine witnesses. Your request must be received by the Board by **Tuesday, September 16, 2025**, and a copy of your written submissions on the preliminary motion by **Thursday, September 25, 2025**, for Intervenor

supporting the Municipality, and by **Thursday, October 9, 2025**, for Intervenor supporting the Appellants.

- You may request the hearing be audio or videocast. Your request must be received by the Board by **Tuesday, September 23, 2025**. The Board will make its best effort to accommodate any such request.
- Alternatively, you may request a copy of the audio file for the proceeding after the hearing by contacting the Clerk of the Board.
