NEW FERRY BOARDING PROCEDURES



New ferry boarding procedures starting Nov. 3, 2025.

HALIFAX TRANSIT

Starting Nov. 3, <u>Halifax Transit</u> is introducing new ferry boarding procedures to align with recent changes to Transport Canada regulations related to passenger safety. These include updated processes for recording passengers who require additional assistance and tracking the number of children on board versus available child life jackets.

Passengers may experience slightly longer boarding times due to enhanced security screening and safety checks. They will be required to enter the passenger waiting area single file, allow time for screening, and inform staff if they or someone in their group requires additional assistance during an emergency.

These changes are required to comply with recent updates to federal safety regulations and must be demonstrably implemented by Nov.21, 2025.

COUNCIL EXPLORES TIERED DEED TRANSFER TAX



At the Tuesday, Oct. 7 meeting, Halifax Regional Council voted to send a letter to the Province of Nova Scotia requesting

legislative changes that would allow the municipality to adopt a tiered deed transfer tax structure.

The move follows a staff recommendation to replace the current flat 1.5 per cent tax with a progressive, tiered structure, aimed at improving fairness and increasing revenue for major capital projects. Under the proposed model, lower-value property sales would see reduced taxes, while higher-value transactions and luxury homes would contribute more. Staff estimate the changes could generate at least \$25 million in additional annual revenue.

Council's decision means the municipality will now request amendments to the Municipal Government Act to permit tiered and luxury rates, raise the maximum allowable tax to 2.5 per cent, and close existing legislative exemptions.

Because deed transfer taxes are governed by provincial law, any changes must first be reviewed and approved by the Province. If supported, the Minister of Municipal Affairs would have final authority to approve or amend the requested legislative updates before they take effect.

As a regulated public utility, Halifax Water must conduct business in accordance with the Halifax Water Regulations as approved by the Nova Scotia Utility and Review Board – now the Nova Scotia Energy and Regulatory Boards Tribunal. These can be used to help you determine if we have applied an approved practice.

Halifax Water will respond to concerns and complaints about:

- Billing
- Metering and meter reading
- · Application of standard charges
- Misuse of water resources, sanitary, or stormwater systems
- Halifax Water staff or service delivery

If you are not happy with Halifax Water's response, you may make an appeal to the <u>Dispute Resolution Officer</u> (DRO).

The Dispute Resolution Officer is an independent officer (not an employee of Halifax Water or the Nova Scotia Utility and Review Board) who manages regulation-based customer issues.
