INFORMATION REPORT

ORIGIN

2025-2026 applications received pursuant to *Administrative Order Number 2014-007-ADM: Respecting Grants to Professional Arts Organizations*.

EXECUTIVE SUMMARY

This report details the 2025-2026 Grants to Professional Arts Organizations awards.

BACKGROUND

Halifax Regional Municipality administers an annual funding program in support of professional arts organizations as governed by *Administrative Order Number 2014-007-ADM Respecting Grants to Professional Arts Organizations* (Administrative Order). The 2025-2026 approved funding envelope is \$810,000.

The Grants to Professional Arts Organization Program awards funding to registered non-profit professional arts organizations located within the geographic boundary of the municipality and in accordance with the definitions outlined in the Administrative Order. Applications are assessed by peer jury review and awarded by the CAO, as set out in the Administrative Order.

The program is divided into two funding categories:

- 1. Operating Assistance to Professional Arts Organizations, which supports the regular operations of those organizations; and
- Project Assistance to Professional Arts Organizations, which allocates funding to stand-alone, nonrecurrent arts initiatives.

On December 12, 2023, Regional Council approved an amendment to Administrative Order Number 2024-007-ADM: Respecting Grants to Professional Arts Organizations allowing Halifax Regional Municipality to

provide up to a three-year funding commitment subject to annual budgetary approval. The peer jury considered this option when developing their recommendations.

DISCUSSION

On April 8, 2025, the funding envelope for 2025-2026 Grants to Professional Arts Organizations was approved at \$810,000, with awards recommended and approved at this total amount. The awards reflect approximately 75% toward Operating Assistance, and 25% toward Project Assistance. This allocation is in line with historic allocations and represents feedback from arts groups who have confirmed that Operating Assistance should be weighed heavier than Project Assistance support when additional funding is available. Table 1 provides a comparison of Grant Applications from 2024-2025 and 2025-2026.

In total, ninety (90) applications were considered as part of the 2025-2026 funding requests for the Grants to Professional Arts Organizations funding program. These included:

- Thirty-three (33) multi-year Operating Funding clients (CAO approved in 2024-2025 for 3-year funding).
- Fifteen (15) new applicants to the Operating Funding program.
- Thirty-eight (38) applications to the Project Assistance Program.
- Four (4) applications that were either ineligible or were withdrawn by the applicant.

The cumulative funding request in 2025-2026 is \$1,419,380 which is \$409,799 less than in 2024-2025. This is due to ongoing multi-year Operating Funding agreements that provide consistent funding amounts for three consecutive years. Groups in receipt of multi-year funding could not reapply in 2025-2026 so the amount "requested" in Table 1 is the amount that has been allotted to them in their initial request year which is often lower than the amount initially requested. While this makes the overall request for funding appear relatively lower than in previous years, the need for funding remains consistent across the sector and continues to trend upwards. In 2027 all operating clients will reapply as one cohort and applications will then include the organizations' new operating funding requests for the 2027-2030 three-year funding term. The new funding requests total is anticipated to increase. In 2024 the HRM became members of CADAC (Canadian Arts Data / Données sur les arts au Canada) and joined the National Research Group led by Mass Culture and Canada Council for the Arts which will provide additional metrics that will be applied for future funding considerations.

Operating Assistance

On May 13, 2025 the peer jury was convened. Operating funding recommendations are listed in Table 2. Fifteen (15) new applications were received, three (3) applications were deemed ineligible after the internal review or withdrawn by the group, thirty-three (33) applications were carried over into the 2025-2026 Operating Funding year based on previously being approved for funding in 2024-2025. Organizations approved for multi-year funding will enter into the cohort with a two-year agreement.

Project Assistance

On May 16, 2025, the peer jury was convened. Project funding recommendations are listed in Table 3. The peer jury recommended funds at least 90% of their requests, supporting projects as holistically as possible. Of the thirty-eight (38) eligible applications received, twelve (12) were recommended for funding.

The CAO accepted the recommendations of the peer jury, and the recommended grants have been awarded.

FINANCIAL IMPLICATIONS

The recommended Professional Arts Grant awards for 2025-2026 in the total amount of \$810,000 are accommodated in the approved 2025-2026 Parks & Recreation operating budget (Cost centre W707 GL: 8004) as shown in Attachment 1.

COMMUNITY ENGAGEMENT

The Grants to Professional Arts Organizations program uses a peer jury to assess and score the applications against the criteria. The peer jury is established achieving a balance of artistic discipline or area of professional expertise, regional perspective, age, and cultural and gender diversity while also considering potential conflicts of interest. This process supports public access to professional arts activities, diversifies and grows the local arts sector providing meaningful opportunities for artists and arts administrators and ultimately supports engagement, participation, and appreciation of the arts.

LEGISLATIVE AUTHORITY

Halifax Regional Municipality Charter, S.N.S. 2008, c. 39 as amended

- 79A (1) Subject to subsections (2) to (4), the Municipality may only spend money for municipal purposes if
 - a) the expenditure is included in the Municipality's operating budget or capital budget or is otherwise authorized by the Municipality;
 - b) the expenditure is in respect of an emergency under the Emergency Management Act; or
 - c) the expenditure is legally required to be paid.

Administrative Order Number 2014-007-ADM: Respecting Grants to Professional Arts Organizations Section 16A. (1) Council hereby delegates to the CAO the authority to approve grants under this Administrative Order, and to determine the amount of such grants.

Section 21A. Parks & Recreation staff will provide an information report annually to the Community Planning & Economic Development Standing Committee on the peer jury process and the grants approved by the CAO.
