The Strategic Plan establishes five priority areas:

- Moving Better focuses on creating a transportation system that safely, reliably, and efficiently connects residents throughout the region.

- Our People focuses on making the organization a place where employees feel engaged, safe, and proud of their work.

The plan was developed by Regional Council, municipal employees and strategic partners, and was informed by the 2024 Resident Survey and existing municipal plans and strategies.

WINTER GARBAGE COLLECTION



As the snow season approaches, please remember to place waste for curbside collection in a spot that won't interfere with sidewalk or road clearing. To help our crews keep

PARKING BAN



The overnight winter parking ban is in effect every year from Dec. 15 until Mar. 31; however, it is enforced only during declared weather events and clearing

operations. When the ban is enforced, it restricts any on-street parking between 1 a.m. and 6 a.m. Vehicles in violation of the ban will be ticketed and/or towed.

Remember to <u>stay informed about the status of</u> <u>the parking ban</u> and please think before you park.

SNOW CLEARING



Snow clearing in our municipality is a big job and if stretched into a straight line, it would reach from Halifax to Winnipeg.
Streets and sidewalks are

prioritized based on commuter usage and access to key infrastructure.

The <u>Winter - Street and Sidewalk</u> Information maps and the overnight winter parking ban zone map are web-based, interactive maps allowing users to view street information pertaining to Winter Operations; for example, snow priority levels, street ownership, street maintenance and overnight winter parking ban zones.

2025/26 STREET TREE PRUNING



The Halifax Regional Municipality's cyclical street tree pruning program runs from Dec. 2025 to March 2026. This year, pruning efforts will focus on trees in areas of Eastern

Passage, Dartmouth, and the Halifax peninsula.

This proactive program is guided by industry best practices and the <u>Urban Forest</u>

<u>Management Plan</u> to promote a healthy, safe and climate-resilient urban forest. Crews will prune municipally owned trees to improve canopy health, maintain infrastructure clearances (e.g. roads, sidewalks, signage, and overhead power lines), and help guide tree growth safely around overhead power infrastructure.

Residents are advised to use caution around crews and obey posted signage while work is underway. Temporary street and sidewalk closures may be required. Work schedules are approximate and weather dependent.

At any time of the year, whether a tree is part of planned annual tree pruning or not, residents may report a municipally owned tree of concern that might need pruning. To report a tree of concern, email contactus@311.halifax.ca or call 311.


GLENDALE DRIVE & RIVERSIDE DRIVE DELAYS



Thank you to everyone who reached out to me regarding the intersection of Glendale Drive and Riverside Drive concerning the delays experienced at the west bound entry onto Glendale which, in turn, caused an inability for residents to exit their driveways due to vehicles cued waiting to enter Glendale.

The Traffic Services Maintenance team assessed the situation on site and determined that the vehicle detection sensors on Glendale Drive were not working properly. A work order has been initiated to determine the exact cause and to make the necessary repairs.

No timeline is available as to when the work will be completed, however; I am hopeful it will be soon.

What do we need from you? Do you have a resource you think might be helpful after a serious event like a weather storm, infrastructure failure etc.? Please let us know! We are looking for everything from heavy equipment like back hoes and excavators right to chainsaws, ATV's, snow mobiles and more. We are also looking to create a list of qualified specialists in our community in areas such as small engine repairs, tree removal services etc. You can fill out the form here or you can call us at 902-865-5114.

What do we do with this info? The BBKCC and BBCAA will compile a list of resources available in our community for emergency response. Your information will be kept private but you may be called or contacted in the event of an emergency where one of the resources you have available is required.

What if I need help? As always in the event of an emergency in your home such as fire, medical emergency etc. please call 911. The BBKCC may open as a comfort station after major weather events or community

emergencies. You will then be able to come and charge devices, get clean water, coffee, snacks and warm up/ cool down.
