In response to a letter from the Coundil of the Board of Trade submitted at a meeting of the Board of Control held on the 6th instant, requesting the Board of Control to investigate certain points in connection with a fire which occured on parrington, Sackville and Argyle Streets on the morning of October 27th, ult., I am directed to reply as follows to the questions asked:-

1. Who discovered the fire, and at what time?

Police gergeant Meehan, at about 4.53 a. m.

2. At what time was the alarm struck?

About 4.55 a. m.

3. How long before the Fire Department arrived on the scene?

Two to three minutes.

4. What condition did they gind the fire in when they arrived?

5. How long before concentration of water took place? and what are the regulations regarding concentration?

Concentrationbegan inside of 10 minutes after the bell alarm and was completed in about 15 minutes. Two turnkeys have standing instructions to proceed

5. What was the origin of the fire if known, probable or conjecture?







The Board of Control met this afternoon at four o'clock. Present His Worship the Mayor and Controllers Hoben, O'Connor and Scanlan.

CITY PRISON INVESTIGATION.

The following report, signed by all the members present is unanimously adopted, and ordered to be forwarded to thedity Council for approval, -

The Board of Control has had under consideration three different and distince heads of complaint. These will be dealt with by numbers in the order in which they were raised.

Complaint No. 1. Otherwise known as the Mary Murphy case, - that a prisoner of that name became pregnant while serving a term in the City Prison.

This complaint was raised by a latter to H. V. Wier dated March 17th, 1914, to Controller Harris. The letter was brought before the Board of Control March 21st, 1914. Mr. Wier appeared before the Board and asked for an investigation. He made no charge against any specific person. The members of this Board associated with themselves Aldermen Porell and Hines and proceeded as a Committee to investigate the charge. The Committee held ten meetings and examined many witnesses., They subsequently reported to the Council in writing. After some discussion in Council the report was referred to the Hoard of Control for consideration and report.

The Board, having considered the charge and the evidence in its support, finds the charge sustained.

Complaint No. 2. This was raised by H. V. Wier in a letter to the Board of Control dated September 10th, 1914. The Governor and Matron of the Prison were accused of causing of having caused repeated interruptions to the religious services at the Prison and with evidencing, generally, a spirit of hestility to the religious workers who had been accustomed to visit the Prison.

The Board, having considered this charge and the evidence in its support, finds the charge sustained.

Complaint No. 3. This was a cross complaint raised by the Covernor of the City Prison in a letter to the Board of Control dated September 30th, 1914, Mr. H. V. Wier was accused **C** interference with Prison arrangements and of interfering with other religious workers at the Gity Prison.

The Board, having considered the charge and the evidence, finds the charge not mistained.

During the course of the investigation of the several charges referred to, many matters were developed having a bearing upon the state and conduct of the Institution, and, as well, upon the question of the efficiency or non-efficiency of the Governor and Matron of the Institution. To these matters the Board does not deem it necessary to refer in detail. Upon the whole evidence now before it, the Board considers, (and so reports as its conclusion), that civic interests would be best served by the resignations of the Governor and Matron of the City Prison, and the Board recommends that such resignations be required.

In the opinion of the Board, Governor Grant does not possess that capacity, judgment and understanding which the proper fulfilment of the duties of his present office demand.

Again, the Hoard considers that the Governor and Matron must be held personally responsible as respects Complaint No. 1. The occurance, within the City Prison of the matter to which that complaint relates, is, in the opinion of the Board, sufficient evidence of an exceedingly loose conduct of the Institution.

Further, as respects Complaint No. 2, the Board is of opinion that the Governor and Matron, for reasons into which the Board need not attempt to dely, have exercised with extreme rigor, as against the evangelical workers of the Prison, a supposed but mistaken authority, which authority, if they or either of them had been persons of the capacity and judgment necessary to their positions, they would not have conceived themselves to possess.

The Board is further of opinion that it is not fitting that a large family of young persons should be resident within the Prison. The family of the Covernor and Matron consists of nine boys ranging from four years to twenty-one years. This undesirable condition the Board considers should forthwith be put an end to.

As the Hoard is recommending that resignations be demanded as of date February 1st, 1915, it withholds for the present certain further recommendations as to the future conduct of the City Prison, including certain recommendations respecting the holding of religious services thereat.

The preceding report is that of those whose names are subscribed hereto. Inring the investigetion Controller Herris, having the investigehim to so under oath and to give evidence personally, intimated to the other members of the Board that he would not take part in the deliberations of the Board or in its finding, but would report his cwn conclusions separately.

PURITY OF WATER SUPPLY, LONG LAKE WATERSHED.

Read reports City Engineer and Assistant City Engineer, covering two plans of Long Lake watershed, the report of the City Engineer being as follows:-

> City Engineer's Office, December 7th, 1914.

His Worship the Mayor. Sir:-

I beg to submit herewith two plans prepared by Mr. Johnson, Assistant City Engineer, showing the land which I have recommended to be taken on the watershed of the Long Lake to prevent contamination of the low service water supply. It does not include all the land which should be acquired, eventually, but includes the properties from which pollution is most likely to dome. Plan #2752 shows the properties on the watershed of Long Lake near the foct of the Lake and in the vicinity of the Long Lake Dam.

Trancis Jollimore's property was criginally one acre, for which he paid Ten Dollars. He has erected a house upon it and has done some work on the property. We asks 1500 for the sale of the property. This, in my jadament is more than the property is worth. He sold a small portion of the acres to Frs. John Micholson, as shown on the plan, for 15.00. The portion of Mr. McPhee's property required by the City measures 42.9 acres. His whole property is about 68.6 acres and he is desirous of selling the whole property, offering to take 2500 for it. He paid 22050 four years ago. The City owns a strip 66 feet wide from high water mark back from the shore. The heirs of Charles Unlah own about 7.03 acres. We have been unable to get in touch with them to obtain any estimate of price.

Plan #2753 shows the Beech Hill properties. It is practically impossible to obtain any satisfactory offers from the people who occupy this land, and it would be necessary to expropriate in any case. /These is also a piece of ungranted land which should be asked for from the Provincial Government, as it is on the watershed of Hagged Lake, which may, at some time in the future, form a part of the water supply system . I have endeavored to make an estimate from my own knowledge of a fair value of these properties. It must be taken solely as my own opinion -

I have to report Policemam David Pettipas for that he, on several occasions between the 25th day of November and the 16th day of December, 1914, not being in the regular discharge of his duty, entered a house of ill-fame, to wit, house #70 Bilby Street in the City of Halifax, and that he, while in said house, conducted pimself in a manner unbecomming a member of the Police Force.

The charge being read, Policeman Pettipas pleads

not guilty.

Ethel Howard sworn.

I lived at #70 Bilby Street. I belong to the City; my father lives here.

Examined by Deputy chil of Poles

One morning about 5 o'clock Policeman Pettipas Digital copy of Halifax Board of Control minutes (102-2A) provided by Halifax Municipal Archives. Request reports, correspondence mentioned in minutes: archives[at]halifax.ca.

came to the house and pulled me out of bed. This was after December 1st; don't remember the date. He wanted me to give him some flags off the wall, and I refused to give them to him. I told him to go out of the room and I would get some flags for him that I had in a trunk. One of the boarders let him in the house. Miss Moung, who is present here now, was in bed with me at the time. On account of the way Pettipas acted I had to get out of the room.

Mrs. Mason is proprietress of the house. Mrs. Mason is a widow, - keeps a boarding house. The day before yesterday she was convicted for keeping a bawdy house. Miss Young and myself were brought before the Court as inmates and pleaded guilty, and were convicted. That's what the house is. On another occasion Pettipas was at the house while I was out. I know this, because I accused him of taking my talcum powder and some post cards, and he didn't deny it. Until the morning Pettipas first came to our room and pulled me out of bed, I had never seen him before. He came in carrying on; he was in uniform, He was on night duty; it was before 6 a. m. I went to the house to stay about a week before the first of December, have been there about a month. This occured shortly after I went there. I have one brother in the Industrial School and a sister in St. Paul's Alms House.

#### Cross examined by Pettipas.

You pulled me out of bed, you pulled all the clother off the bed. I told you to go out and I would get some flags out of the trunk. You went out, I tried to turn the key in the lock but the key wouldn't turn, and you came in the room again.

### Maud Young sworn.

I belong to Newfoundland. Was staying at #70 Bilby Street; I went there at the same time Miss Howard went and stayed with her. Before that I worked at Crouses' Restaurant and at Rafuse's Restaurant. I pleaded guilty to being an imate of this place. Mrs. Mason was convicted of keeping a bawdy house and we were convicted of being inmates. I was in bed with Miss Howard when Pettipas came in. Pettipas came in and pulled the clothes off the bed. Miss Howard went outof the room. Pettipas stayed in the room and looked around for flags on the wall. He came in to carryon. Don't know the date this happened. It was about the date described by Miss Howard. I will be 21 February 4th next. Have been in Halifax 3 years. My father and mother are living, but are not living together. My mother is married again. I never lived in a house of this kind before. Previous to this I always worked for my living. Miss Howard and I are both now under arrest.

# Cross examined by Pettipas.

Sure you took the flags off the wall.

#### Policeman Pettipas sworn.

Have been on the Police Force going on two years. (The Chief of Police here reports that Pettipas joined the Force September 24th, 1912). I belong to Bear Cove, Halifax County. Reports came to me about that place (No. 70 Bilby Street) and I went in to see if I

could get any evidence against the house. I didn't pull the clothes off Miss Howard. I don't drink; I take a glass of beer once in a while. I opened the bedroom door and looked in. Never made any reports to the Chief of Police or to the Deputy Chief. I was on search to see if it was an improper place. Alfred Rogers, who keeps a meat shop, was one person who told me so. I cannot fix the date when I first went there, think it was about pecember 1st. Was on night duty at the time. I never got any evidence that it was an improper place. It was not on my information that the charge was laid against this house; I never reported it to anyone.

### Cross examined by Deputy Chief Bayers.

I was in their room; nobody showed me to their room, I was passing and went in. By reports I didn't think they were respectable women. I didn't report because I was waiting to get more evidence. I went there a second time. Howard and Young were out when I went the second time. I didn't go to their room, I went to the kitchen. Mrs. Mason was in the kitchen. Mrs. Mason went upstairs; after she went upstairs, I went up. I went to the little sitting room where Mrs. Mason was. I went to the sitting room to look around. This was at 9 p. m. I was in plain clothes then. I was not on duty; I got no evidence. Don't remember what questions I asked Mrs Howard. Didn't go into those girls' room with Mrs. Mason. I didn't take the talcum powder and comb; didn't take a ring, but I had it. It was on the floor, and I picked it up; Mrs. Mason told me to put it on and see if it would fit. I put the ring on my finger and Mrs. Mason told me to keep it. I knew Mrs. Mason had been convicted for keeping liquor.

### To His Worship the Mayor.

I am married and have one child. Have been married nearly a year.

Was at that house three times altogether within a month. So far as I know, I went there always for thesame reason. Was there twice in plain clothes and once in uniform. Never had a drink there. The second time I went there Howard and young were out, but they came in while I was there.





POLICEMAN DAVID PETTIPAS.

The investigation into the charge against Policeman David Pettipas is resumed.

Mrs. Edith Mason sworn.

I live at #70 Bilby Street. On the morning that Policeman Pettipas came to my house there were several boarders there between whom a quarrel commenced and I sent for Policeman Pettipas. On an occasion or two after that Pettipas came to my house in plain clothes. On the morning that Pettipas came in at 5 o'clock in uniform, two or three of the boarders went cut. I never saw anything wrong with Pettipas at my house. On the morning that Pettipas came in at 5 o'clock I was up getting breakfast ready for Frank Battersley, who worked for Adams with the horses for the war; he had to leave the house for his work about 5 a. m. Jim Allen, and two others whose names I forget were boarders with me for about three weeks and have since gone away. Itwas amongst them that the quarrel started which caused me to send for Pettipas. Allen is now in the humber woods. Harvey was the name of one of the other men. When Pettipas came in I didn't ask him to go upstairs. I haven't spoken to Pettipas since Friday's meeting of the Board of Control. Cannot say why Pettipas came to my place in plain clothes after the occasion upon which I sent for him. In the Police Court I pleaded guilty of keeping a bawdy house. I had no knowledge of what the girls were deing.

(Deputy Chief of Police Bayers here informs the Board that Mrs. Mason did not plead guilty at the trial, but upon the evidence produced she was convioted).

I have three children all living with me in my house. Have been a widow for seven years. Two of my children are under seven years of age. The father of my two youngest children has offered to marry me, but he is now at the war. It was about the 1st of December Pettipas came to my house in uniform. When he came in I do not remember what he said; he just asked who those girls were. It was about a week before that that I called him to my place on account of the quarrel. On the morning he came in at 5 o'clock the boarders I spoke of had left the City.

#### Cross examined by Deputy Chief Bayers.

Have had no conversation with Pettipas since Friday last. The girls complained of having lost several things out of their room. Each of them lost a pair of slippers and a tin of talcum powder, and a locket was also lost. The Howard girl said she gave Pettipas fiv-e or six flags off of the wall. One evening I was sitting by the base-burner sewing when Pettipas came in; there was a tin of talcum powder on the table by him, he asked me if it was mine, I said "No", and he laid it down again. Those two girls, Howard and Young, were with me three weeks altogether. One of my boarders, Michael Barrett, lost a ring. It was on the table; Pettipas picked it up and asked if it belonged to me, and I said it belonged to one of the strangers in the house. I sent my little boy in to the house next doot, Frank Rogers' place, who keeps a grocery, where Pettipas then was, to get the ring from Pettipas. I heard that Pettipas would not give up the ring until he found out who owned it. I told that to Barrett. This was within the last week. Don't know why Pettipas was in next door. Pettipas did not come to see me when I sent for the ring.

#### Michael Barrett sworn.

I belong to St. Peter's, Cape Breton. Have been here thirty years off and on. Was fishing out of Gloucester for twelve years. Until recently I was boarding with Mrs. Charles Sampson; left there and went there to board with Mrs. Mason two weeks ago today. I had a plain ring on my finger; Mrs. Mason asked me why I didn't get my initials put on it, she said it would only cost a quarter. I handed her the ring to get my initials put on it. She told me Pettipas took the ring out of a pocket-book lying on the table and put it on his finger. I got my ring back from Mrs. Mason. Never saw Pettipas until I saw him here. I work all night as watchman and sleep in the day time.

# Policeman Pettipas recalled.

I didn't know who owned the ring. A child came to me at Rogers' place for the ring. I hadn't time to go to Mrs. Mason's with it. I sent a message back that I would give it up when I found out who owned it.



The Board of Control met this morning at 11.30 o'clock. Present His Worship the Mayor and Controllers O'Connor, Harris, Scanlan and Hoben.

#### PUBLIC MARKET BUILDING.

In response to request M. E Keefe appeared befpre the Board in connection with the delay in the completion of the Public Market Building. Mr. Keefe stated that the work of excavating was extraordinary; muc h heavier than was anticipated, and was cause of dalay. The bricks specified could not be obtained, as the makers did not have them manufactured. The time fixed for the completion of the building was entirely tooshort. He was also handicapped by the excavated stone not being removedby the City. The City removed the excavated stone very slowly. No one was more anxious to have the work expedited than he was. He had no control over the come tractors for heating, plumbing, painting etc., but if these contractors finish their work, he thought he would be able to have the building ready for the coming season.

S. P. Dumaresq called, stated that there was some

delay in the supplying of bricks to Mr. Keefe by the Nova Scotia Clay Company, but that he did not want to lay too much stress on this point; there was a delay of probably a couple of months in getting the specified bricks. He did not know whether the bricks delivered in the first instance were the kind ordered by Mr. Keefe, but they were not the kind specified.

City Engineer Doane called, said there was a difference between the City and Mr. Keefe in the interpretation of the clause with reference to the removal of excavated stone. Mr. Keefe contended that the City was to remove all the excavated stone and the City

claimed that according to the contract the City merely had the privilege of removing stone.

The specification in regard to the removal of stone is read.

Mr. Keefe states that no stone will be left unturned by him to finish the work. He has been ready for a considerable time for the minor contractors and has been delayed by James Donohue, contractor for metal work, who had not placed the flashings.

The Secretary is instructed to notify Messrs. Keefe, Dumaresq and Donohue to appear before the Board at its meeting on the 30th inst.

A. L. Wood and C. V. Monaghan, on behalf of water takers at Willow Park, appeared before and addressed the Board, complaining of the condition of the water service. For the past two or three days during the cold snap there has not been sufficient supply to serve the houses. In the day time the water hardly reaches to the kitchen and at night time only at times reaches the second floor. They asked if any measures can be taken to give aproper service. The lack of water supply is seriously affecting the values of properties and the property owners desire to know what to expect. The service until the present cold weather has been much better since September than it was for the previous couple of years.

The City Engineer stated that the service pipes in the high service district are wasting water and will waste more than the mains will hold. The reservoir on Shaffroth's Hill is now connected with the whole high service system. It is intended to improve the service in Merkle's Field and at Willow Park and should be only connected up with those districts. The reason for this at the present time is that the encircling system of mains and valves is not yet completed. During the present winter at every cold snap the conditions will be the same as at present. The reservoir has made a great difference in the service, but the service cannot be satisfactory while the reservoir is supplying the whole high service system.

In answer to Mr. Monaghan, Mr. Doane stated that the reservoir supply was thrown into the system about three months ago.

The Chief recommends that Weston be given another chance, and thinks that a couple of days fine in addition to the loss of a day's pay through suspension would be sufficient punishment.





Section 523 in effect provides that a permit for any engine, dynamo, boiler or furnace for other than domestic heating is not to be installed without a permit from the Building Inspector, and Section 365 in effect that no steam mill, steam engine or other manufacture or trade dangerous or productive of serious inconvenience or discomfort to the persons living near the same shall be established, continued or carried on in any part of the City unless by permission of the Council.

The Board of Control reports to the Council that application for sale of City land has been made, but that the Board has deferred recommendation until the Council has pronounced under Sections 748 and 865 and the Building Inspector under Section 823. Further that the whole request of the promoters of the industry is the whole request of the promoters of the industry is referred to the Council as the proper authority for decision under Sections 748 and 865 without any recommendations.

The Board reports that it has under consideration a proposition that no factory, mill, grain elevator, gas works, chemical or rendering works, laundry, brewery, lime kiln, tannery, vulcanizing plant, soap or candle manufactory, machine shop, steam mill, distillery, candle manufactory, machine shop, steam mill, distillery, candle works, fuel, coal or lumber yard magazine store explosive works, fuel, coal or lumber yard magazine store or tanks for the storage of chemicals, explosives or inflammable oils, or any building containing any dynamo, flammable oils, or any building containing any dynamo, flammable oiler, gasoline engine or motor shall be hereafter erected, established or carried on ithin some defined area upon the North western portion of Halifax Peninsula. area upon the North western portions 745, 523 and 865 of the further that the existing sections 745, 523 and 865 of the City Charter be preserved to enable the City to deal with industries outside said area.






