RECORD OF PROPERTY TRANSFERS.

Controllers Harris reports (see minutes Board of Control February 1st, 1915) recommending that the Deputy Registrar of Deeds be employed at \$10.00 per month for the purpose of furnishing to the City Assessor returns of all real property transfers.

FAIR WACE SCALE AND HOURS OF LABOR.

On behalf of petitions recently submitted by the Typographical Union and by the Trades and Labor Council for the inclusion in all City contracts of provision for a fair wage scale and in respect to hours of labor, the Board is addressed by Jemes R. Theakston and John T. Joy. The City Engineer is heard on the subject. Mr. Theakston submits the following documents, which are read:-

WHEREAS it is desirable that all civic work shall be performed under fair conditions as regards wages and hours,

AND WHEREAS it is desirable that all civic contracts hereafter shall contain such conditions as will prevent abuses which may arise in the performance or sub-letting of such contracts;

AND WHEREAS every effort should be made to secure the payment of such wages as are generally accepted as current in each trade for competent workmen;

ER IT THEREFORE RESOLVED that the work to which the foregoing policy shall apply shall include all work carried on by the City of Halifax or work performed by any contractor on behalf of the City, and shall apply to any City contract whether sub-let or carried on by the main contractor.

By-laws governing fair wage regulation.

The following conditions shall apply to all civic

work, whether contracted for or performed by day's work:-

- 1. That competent workmen shall be employed and paid the current rate of wages.
- 2. The trades union rate, where craft is organized, shall be deemed the current and minimum rate in such trade; where there is no trades union rate, workmen shall be paid the generally accepted current rate of wages.
- 3. That no workmen shall be required to work longer than those fixed by the trade in which he is employed, or longer hours per day than those generally, as current in the trade or calling affected.
- 4. Preference in employment shall be given to residents who are British subjects.
- 5. Any violation of the foregoing conditions shall be regarded as a breach of contract and shall be immediately reported to the Board of Control.
- 6. The contractor shall not assign or sublet any contract or part thereof without the consent of the Board of Contra and if such subletting is consented to all the terms of the contract shall be binding upon the sub-contractor.
- 7. In the event of dispute as to rate of wages to be paid under any contract or as to the amount to be paid to any workman, or the number of hours per working day, said dispute shall be submitted to the Board of Control for settlement, whose decision shall be final.

Fair Wage Regulation to be inserted in all Civic

Contracts.

This contract is made subject to the regulation made by the City of Halifax, dated day of 191 .

All mechanics, laborers or other persons who perform labor in the performance of the work hereby contracted for shall be paid such wages as are generally accepted as the current wage for competent workmen, in the city of Halifax, and if there is no current rate, then a fair and reasonable rate, and shall notbe required to work longer hours than those fixed by the custom of the trade in the City of Halifax, except in the protection of life or peoperty or in case of emergencies. Wherever a trades organization exists the rate of wages of said organization shall be accepted as the current rate of wages. In the event of a dispute arising as to what is the current rate, or a fair and reasonable rate of wages, or what are the current hours fixed by the custom of the trade, it shall be determined by the Board of Control of the City of Halifax whose decision shall be final.

The matter is referred to the City Engineer and the City Solicitor for report.







Hattie (March 6th, 1915) covering letter Thomas Adams (March 4th, 1915), representing the Dominion Government Conservation Commission, covering suggestions and a tentative plan of district suggested to be reserved for residential areas on the western slope of the City, to the exclusion of factories, etc.

Read joint letter Board of Trade and Civic Improvement League (covering plan) outlining area suggested to be restricted for residential purposes, as follows:-

At a meeting of representatives of the Boardof Trade and Civic Improvement League held Friday, March 12th, it was the unanimous opinion that an area

March 16th, 1915. restricted for residential purposes would be reasonably defined as marked on attached plan as follows:-Beginning at Point Pleasant Park and running northerly by the rear line of the lots abutting on the east sides of Young Avenue and South Park Street; thence easterly along the rear line of the lots abutting on the south side of Sackville street to Brunswick Street; thence by Brunswick Street to the rear line of the lots abutting on the north side of Cogswell Street; thence following the rear lines of the lots west to the east side of North Park Street, north to the north side of Cunard Street, west to the west side of Robie Street, south to north side Quinpool Road, west to west side Connaught Avenue, north to a point five hundred feet north of Chebucto Road; thence westerly following a line five hundred feet north of Chebucto Road to the Dutch Village Road; thence southerly by the Dutch Village Road and the shores of the North West Arm to Point Pleasant Park. The inclusion in the legislation of certain points suggested by Thomas Adams, together with other suggestions of the Committee, is recommended, viz .-To include a provision in the Act permitting threefourths of the owners of the properties in any block to secure by petition, that said block should be declared a residential area within the Act. The provisions of the Act should comprise the following:-(1) That no building, except private dwelling houses or houses to be used for such professional purposes as those of a doctor or architect, music teacher and the like and any necessary stabling, motor houses and outbuildings, be erected in the restricted area. (2) That puclic buildings, including churches, halls, schools, etc., should be permitted in the area by consent of the civic authorities, of a height not exceeding 60 feet, except in regard to towers, turrets, etc. (3) That the civic authorities have authority to define restricted shopping districts within the area in which alone stores would be permitted to locate, with a view to prevent the undue mixing of stores with residences and to secure the construction of local stores in suitable and convenient locations. (4) That the building of boat houses of a public or semi-public nature, and other structures on the shores of the North West Arm, be sugject to the approval of the civic authorities, as to position and architectural design. (5) That greenhouses and other buildings to be used for agricultural or horticultural purposes should be permitted.

- 2. The trades union rate, where craft is organized, and where such rate is paid by a majority of the employers, shall be deemed the current and minimum rate in such trade. Where there is no trade union rate, workmen shall be paid the generally accepted current rate of wages.
- That no workman shall be required on any civic contract to work longer hours than those fixed by the Trade in which he is employed orlonger hours per day than those generally accepted as current in the trade or calling affected.
- 4. Rreference in employment shall be given to residents who are reliable and competent workmen.
- 5. Any violation of the foregoing conditions shall be regarded as a breach of contract.
- 6. The contractor shall not assign or sub-let any contract or part thereof without the consent of the Board of Control, and if such sub-letting is consented to all the terms of the contract shall be binding upon the sub-contractor.
- 7. No change in the rate of wages or number of hours per day shall go into effect during the life of the contract until the same has been accepted and put into effect by a majority of the employers in such trade.
- g. In the event of dispute as to the rate of wages being paid under any contract, or the number of hours per working day, said dispute shall be referred to the Board of Control for settlement, whose decision shall be final.

Read charges preferred by David William (Buster) Brown against Policemen Henry Smith, Herbert Huhtley and John Lightel, as follows:-April 1st, 1915. Statement by William Buster Brown. On Monday night, 29th March, Policeman Smith in plain clothes came into my shop with Huntley and a nother party, and three bottles of beer were ordered and served to them. I said "I don't handle it as you well know", and with that he said "Come across, we're all right. I said you cannot get anything in here you had better to out and my wife says you had in here, you had better go out, and my wife says, you had better all go out and Policeman Smith says to my wife, If I clinch you I put you overhead in the kitchen. With that I went to the telephone and asked if the Chief or his Deputy was in and no was the answer. Loud talking about cleaning up the place by the five policemen and one other individual and Policeman Lightening says, Bring down the waggon, it don't worry us. My wife then went out to bring a policeman and soon as she left ex-policeman Sheehan went and locked my Yale lock door and says, We'll take charge of the place. Then Policeman Lightening says, This place has been running long enough and I am going to shut you up. I then heard a knock trying to get in the door and after wading my way through to get to the door, I opened it up and let in my wife and Policeman Conrad. I heard Mr. Brown ask his wife to go for a policeman and one of these men attempted to intercept her and adopted what I considered a threatening attitude and I stepped between them. I know that one of them appeared to want to intercept Mrs. Brown and I got between them when he was going to strike her. Mrs. Brown went out and one of the men closed the door after a little. I didn't hear any knocking at the door. Saw Mr. Brown opening the door and a policeman in uniform came in with Mrs. Brown and ordered these men to leave the place. They were all more or less under the influence of drink. There were about from six to eight

men, possibly as many as eight. There were four or five inplain clother and a couple of men with peaked caps,-

mercantile marine men.

Cross examined by Controller Harris.

I heard something said about clinching. Heard nothing said about "this place has been running long enough."
Heard "Iwant these men put out." Did not hear "You can't put me cut." One of the men said something about there being drink on the premises. I was going out as Mr.
Lawless came in. I thought there was good reason to call the police, think Mr. Brown was justified in calling the police when the men continued to demand liquor. They did not go out immediately, there was a little more talk.

I go there to get cigarettes, some supper occasion—ally and soft drinks. Mr. Brown has a gramaphone which he allows me to manipulate. I am no particular friend of any of these persons. Never met Mr. Brown until about six months ago. My home is not in Halifax, am in the R. C. G. A.. Am single.

Cross examined by Mr. O'Hearn.

I heard beer being ordered. I can identify Mr.
Lightel. I do not know myself who demanded the beer.
I thought these men had had a few drinks and might be able to raise another one.. I can't identify the man who intercepted Mrs. Brown when she went for the police. He came from the back and his side was towards me. It was not one of the sailors, he had a bowler hat on.

Cross examined by Mr. Murray.

April 9th 1915.

He was a medium sized man, would correspond in height and build to Smith .

Mrs Catherine Brown sworn.

Cross examined by Mr. Murray.

I live at #8 Sackville Street. Am the wife of William Buster Brown. I remember the 29th of March. Remember Policeman Smith calling that evening, was with Lightel. The first time when we came home on Monday night he was with Huntley. Nobody elsewas with them, just the two of them came in. Smith said to the waiter "Give us some Kieth's beer". The waiter said "You can't getit". Then he asked for Busterm and when Mr. Brown came out he said "For Christ's dake come off your perch." Buster told the two of them to go out, and they went. They were in plain clothes.

On wednesday, the 31st of March, Huntley, Smith, Lightel and Ex-Policeman Sheehan were there. The waiter said "What can I do", and Smith said "You can do us for nothing." Then one of them said "Give us a round of Kieth's beer," and Buster said "We don't keep it here." Buster ordered them out, and I said "Yes, you had better all go." Smith said "I know you, if I clinch you I'll knock you in the back room. Then I went out and brought in Policeman Conrad. We found the door locked and could not get in. Buster opened the door and let us in and Buster told Conrad to order them out. Smith said "You can't put me out" and put his hand in his back pocket, I do not know what he was pulling out. When I went out I told Conrad to come down that there was a racket between three policemen. They went out for Conrad when he ordered them. He () said "For Christ's sake come off your perch", and "This place has been running long enough and I am goint to close it up."

Cross examined by Mr. O'Hearn.

Smith behaved worse than any person else. I do not feel more resentful towards him than anybody else. I have had trouble with Smith as a police officer. He had my husband arrested before this complaint. He was arrested about three months ago, at least as far as I can remember. Smith has been at our place three or four times. While we were away he was in once in uniform. My brother told us that. I have no feeling against Smith on account of what he did. He did right at that time as my husband was under the influence of liquor. I knew Lightel and Smith were policemen, didn't know Huntley was. When I went for Conrad I told him there were three policemen and Ex-Policeman Sheehan. When Conrad came in my husband ordered him to order them out and Smith said "You can't put me out." Conrad put them out.

My father is Mr. Lawless.

William Ferguson sworn.

Cross examined by Mr. Murray.

I am employed by Mr. Brown. On the 29th of March I saw Smith and Huntley. I could not way whether there was any person else or not. They came in and asked for something to drink - asked for something strong, called it Keith's. I said "We don't keep anytting. They took two bottles of malted beer. They had accounts with Mr. Brown. I don't remember exactly about the first night. Smith said "Come off your perch and give us something to drink. On the 31st of March five came in, Mr. Smith, Mr. Huntley, and there were two perry officer.s.

Smith ordered Keith's beer and I said I had none, and he said if he didn't get Keith's he didn't want anything. Hewalked towards Mr. Brown, and said "Come off theperch and give us something to drink." Mr. Brown told them to go somewhere else and get it, that he didn't have it. One of them went to the door and put the look on the door. I took it to be Huntley. Mrs. Brown went out for a policeman and returned with Policeman Conrad. Smith said to Mrs. Brown that he would knock her over in the kitchen if she didn't keep our of his way. They were under the influence of liquor. Mr. Smith had more than the rest. Mr. Lightel said that Mr. Brown went far enough and he was going to put a stop to it. Mr. Conrad came back with Mrs. Brown and the door was locked. Mr. Brown let her in and stated he wished the men to be removed from the shop and Mr. Conrad put them cut. I saw nothing to indicate they were policemen except hand-cuffs on Mr. Smith. They were hanging at of his pocket. He had his hand on his hip. I didn't see the billy. Conrad just ordered them out and they went out with him. The whole bunch went out. I did not go out after that. Heard no shouting.

Cross examined by Mr. O'Hearn.

I am not sure it was Huntley who closed the door as there were two men who looked alike. I thought it was the man who wore the checked cap who closed the door. I am not positive it was Mr. Huntley. It was not Smith or Lightal, was a bigger man than either of them. It might have been Ex-Policeman Sheehan. Huntley did not interfere with Mrs. Brown, Smith interfered with her. I am not sure who locked the door, but thought it was Sheehan.

I come from Sydney. I have been here back and forth for five or six years. Have been back the last time about three years. Have been employed by Mr. Brown about a little over a month. Before than I worked for Mr. Franklyn. Worked for him a short time, was a special policeman before that.

I was surprised that anybody should ask for intoxicating liquor. I don'tsell any liquor down there never have. I told him it was not in the shop. I
never saw it in the shop for sale. I have had it there
myself, but nobody else. Just had a little drop, that
was all.

Cross examined by Controller Hoben.

I served them malt beer. The bottle has a label on it. I think the Halifax Breweries makes the beer, I am not sure. I don't really know what firm makes the beer.

Cross examined by Controller Harris. serve is

what we/called Golden Malt. We serve that over the counter. I never saw Mr. Messervey on our premises. I know from Mr. Brown he has been there, but do not know personally that he has been there. We just sell soft drinks.

Mrs. John Horner sworn.

Cross examined by Mr. Murray.

I was in the kitchen of Mrs. Brown on the 31st. I heard Mrs Brown say "I want all of you to go out of the shop. I want you, Smith, to go out." I went from the kitchen to the shop to see who she was talking to. When I sent out these three gentlemen were sitting there.

She ordered them out. Smith came to Mrs. Brown and said "I know you, and if I clinch you I'LL knock youback in that room." Mrs. Brown said if they didn't go out she would go for a policeman. Mrs. Brown went out. Huntley went towards the door, and when she came back it was locked and Mr. Brown worked his way through till he got to the door and opened it for his wife. She came in with a cop (Conrad) Mr. Brown worked his way towards the door and Smith interfered with him and he opened the door of his wife came in with a cop. I don't know his name. I saw no hand cuffs. I don't know ex-Policeman Sheehan. I don't know any of the policemen on the force. Smith said "You can't put me out". I don't know who the other men were besides the · cops, I think they were men from the Dockyard - petty I was convicted once in the Police Court. officers. It was for keeping a baway house, but I was not guilty."

DAVID William Buster Brown sworn.

Cross examined by Controller Harris.

This statement that has been read is correct. I swear to the truth.

Cross examined by Mr. O'Hearn.

When I was arrested Policemen Smith and McIsaac took me. Was convicted of assault at that time. was fined for creating a disturbance. I paid \$15.00. There was no assault. I paid it for breaking in a door. I never said I would get him for that, I did not know he was the same man. I have never been con-victed of selling liquor. Have been in business seven months. They have been in eleven times to search the house. Mr. Messervey comes to our place. Thave never been convicted. I don't sell anything only 2 per cent beer, and Golden Buck. I was there Monday night, the 29th of March, and was there 31st of March. Wednesday night there was my wife, Mrs. Horner and

the waiter, the man who looks after the bar.

Novody suggested that I should prefer this charge
against the police officer. My father-in-law didn't
suggest it. I didn't go to Mr. Power, nobody went to
himthat I know of. I called Mr Power up by telephone. Nobody suggested that I employ a solicitor, I went of my own accord. I did not get one until 10 o'clock this morning. I made the complaint myself and got it type-

I have been in Halifax since December, a year ago.
My home is in New Zwaland. Before I came to HalifaxI lived in New York, I lived there about fourteen years. went to sea, was a waiter and steward, that is where I learned my trade as cook. I never had any trouble with the police in New York, had no difficulties in that line at all. Was working on the trains, then opened up

a restaurant.

Michael Lawless is the name of my father-in-law.

I left him incharge of my place while I was away.

When I was arrested before I don't know what I was convited of, I know I paid \$15.00, I don't know what the charge was. There was a trial. I don't recollect what I was arrested for as I was under the influence of drink. Police Officer Smith had very little to do with that affair. I don't think I was charged with assaulting Smith. I was not charged for stealing money belonging to my wife - she hasn't got any. When I went away I went alone, I went on a honeymoon trip by myself. My wife didn't charge me with theft of two orthree hundred dollars from her. I went to the States two or three months ago. I drew some money out of the Bank and went away Tuesday and came back Saturday morning, and when I

April 9th, 1915. came back I found out my wife had a warrant forme in Boston. She thought I had left her, the charge was for desertion. She thought I had gone away for good. It was my own money I took out of the Bank. I just wanted to take a trip by myself. Cross examined by Mr. Murray. I do not know what charge my wife had against me. I got the complaint typewritten d wn at the corner of Granville Street, at Soulis'. I had it written the next morning after the trouble. I had no feeling against these people at all. Monday night I let it go, but Wednesday night I thought it was time to get a little protection. When my wife charged me I don't know what the charge was, -she tried to get me back. I don't know what information whe laid in the matter. Cross examined by Controller Hoben. The police didn't search me out in Boston, I didn't know the police wanted me until I came back. Michael Lawless sworn. Cross examined by Mr. Murray. I am the father of Mrs. Brown. On the 31st of March I went down there. I got a telephone message at St. Mary's Hall from Mr. Brown that there were four policemen going to break up the place. It was Mr. Brown who spoke over the telephone to me. It was a quarter past ten. I came down Sackville Street and saw Policeman Conrad at the corner of Hollis and sackville Streets. He said he was driving them away. I said I got a telephone message that they were breaking up the place. I went down but didn't go in Brown's place, sent across from Brown's place and saw Smith between Lightel and Huntley. I said "Smith, what's the matter with you?" He grabbed me and I said "Let go of me". Smith at that time was good and drunk. The other two were like dummies - couldn't speak to me. Smith was staggering all over the place when he grabbed me. This was the 31st. They were all in plain clothes. Huntley had on a hat and short coat, and Smith and Lightel had overcoats on. They were all drunk. I said to Smith "What do you mean". He said "That men Brown insulted us the other night and we're going to put him om the bum." I said "You better go home yourself, or you'll get put on the bum."
Policeman Conrad got the men to move along, and Ex-Policeman Sheehan who was with them, and went along Bedford Row towards Water Street. That's all I can tell you about this racket of Brown's. I don't know anyting of what happened inside. Cross examined by Mr. O'Hearn. I am the father of Mrs. Brown. Smith was very drunk. If he had had another drink he wouldn't have been able to get home. The whole three of them were staggering going along Bedford Row. I have no resentment against the officers, I have no ill-feeling against any of them, I am sorry to be in it. I would rather protect them. I came here to tell the truth and that I will tell. 918-Digital copy of Halifax Board of Control minutes (102-2A) provided by Halifax Municipal Archives

Policeman Judson Conrad sworn.

Cross examined by Mr. Murray.

I remember the night of March 31st. Mrs Brown came to me at the corner of Sackville and Hollis Streets and said there were two policemen down in her place and some soldiers and sailors and that I had better go down. I could not get in -- the door was locked. Mrs. Brown knocked at the door for a few minutes and it was opened. I saw three police officers, - Huntley, Lightel and Smith, in plain clothes. Didn't see anything, just the three men and the other fellows in the shop. They weren't drunk, had a few drinks in, but weren't drunk. Were under the influence of liquor. I just told them that the best thing they could do was to move away, and they did so and I walked out. They weren's saying anything worth while. Mr. Brown told me to order them out and I told them to move out and they said they would. They walked as straight as I could walk. They waked across the street to Doyle's grocery store. I don't know what they did, I walked up tomy standing point. I don't know whether the sailors went out or not, I only took notice to the three policemen. I didn't notice Ex-Policeman cheehan. Mr. Brown was very much excited, don't know whether he was sober or not. Huntley and Smith seemed to have more in them that the other. I could smell it that's all I could say. Their faces indicated that they had been drinking more than the other.

Cross examined by Mr. O'Hearn.

I don't know whether Mr. Brown was drunk or not. I didn't notice. Didn't take stock enough to know. Coundn't say whether Mrs. Brown was drunk or not.
Didn't smell her breath. She appeared to be excited.
I heard no noise inside before the door was opened.
The Browns were not under the influence of liquor as far as I know, but were excited. No person was staggering drunk. I would not feel justified in arresting any of them for being drunk if they were on the sidewalk.

Policeman Henry Smith aworn.

Cross examined by Mr. O'Hearn.

I went in there about 10.10 on the 31st. I had four friends with me, two were policemen and two sailors. I no sooner got in the door when Brown said "You will get nothing in here Smith". I said "You didn't give me time to ask for anything yet. He said "Get to Hell outside", and I said I was waiting for my friends.. Brown said he was going to get his own back for what Smith and McIsaac did to him on the street. I heard Mrs.

Brown say to go and fetch a policeman. She ran out and I didn't say anything to her about putting her in the kitchen. That's all I know, there was nothing more said. I did not know Ex-Policeman Sheehan locked the door, I don't know whether he was there or not. I didn't interfere with Mrs. Brown. I didn't say "For Christ's sake come off your perch." I didn't demand any beer at all I went in there to have a sandwich. I had three bottles of beer in a licensed saloon.

On Monday the 29th of March, I was taking a walk around and Muntley said "We'll go in here and have a drink." We had three bottles of Golden Buck beer. said he was going to get his own back for what Smith

drink." We had three bottles of Golden Buck beer. None of it was hard liquor. Had one bottle of Keith's ale, an ordinary bottle.

Brown was convicted of assault on the police November 4th, 1914. (Mr. Murray objects.) Brown made threats in respect to this conviction. He said he was going to get his own back on account of what we did to him up the street. March 29th we just had three drinks of beer. He charged me 45¢ for the three bottles of Golden Malt. Huntley sail "That's an awful price." On March 31st I went to wait for my friends, they were going in for something to eat.

Cross examined by Mr. Murray.

I have been in that shop previous to that. I don't know William Lawless. I nevernment there and got two bottles of beer and didn't pay for it. Previous to that I wasn't in there with anyone, was inalone. I don't remember going in at any time and getting beer and not paying for it. Didn't go in the afternoon in uniform. did go in there with Policeman Mcrrison. It was at night time. Didn't get beer and not pay for it. Don't remember Morrison saying "That's a funny thing for you to get beer and not pay for it." On Wednesday I had three bottles of beer, I met the friends about a quarter to ten, before I left Mackasey's. They were threr when I went in. I went in there alone. I met Huntley and two friends in Madkasey's at the bar. I bought a bottle of beer by myself at Mackasey's. I stayed at Mackasey's till 10 o'clock. We were talking about the war and went along down Water Street. One of the sailors said "Let's go and have a sandwich." I didn't ask for a drink at Brown's, didn't hear anybody ask for a drink. They didn't give us time to ask for anything. As soom as I got in the door, Brown said "You will get nothing in here Smith." The beer I drank had no effect on me. I am not used to it. I had three bottles, I thought that was sufficient for me and that's all I took. Brown said to me "Get to Hell outside." I said "I am waiting for my friends." He said "I'm going to get my own back for what you and McIsaac did to me up the street." I heard Mrs. Brown say "Why don't you go out Smith, you know what kind of a man he is." I said "I am causing no trouble in here." I didn't notice the door locked, the door was open when I went out. It might have been locked, I don't know. We were in there when the policeman came. Didn't notice whether the door was locked or not. The first thing I saw was Mrs. Brown and the officer coming in. I didn't interfere with Mrs. Brown in any way. I wasn't in there at any time in uniform, and never refused to pay for a drink. I was not under the influence of liquor. Lawless' statement isn't true. I didn't touch him. I met him on Bedford Row, and he said "What's the trouble?" I remember everything that happened. Had three drinks that night, one at 20.9, one at 15.10 and one at 7.10. The other fellows who were with me behaved right, have no fault to find with them.

Herbert Huntley sworn.

Cross examined by Mr. O'Hearn.

I was in Brown's with Officer Smith on both occasions. I heard his statement here today and corroborate it. I wish to add there was some question raised about the man who wore the cheched cap. There was a man with a checked cap on but he had nothing to do with us - was not in out company. I was with Piert and Hague. we went in there and before we had a chance to say anything Brown said "You can't get anything here." I wasn't drunk, I had only had one bottle of beer at Mackasey's and one shandygaff. That was on wednesday, the 31st. On Monday, the 29th I had no drink at all, it was too late to get one. Had a bottle of Golden Talt at Brown's.

Cross examined by Mr. Murray.

When Conrad came I walked I am not a drinking man. out. We were inside the shop door when he ordered us out. I was about three or four feet away from him, and Smith about five or six feet away from him. There were several people there who had nothing to do with us. The shop is about 9 X 6 and there is a table in it. As soon as Conrad came in we walked out straight past him. I didn't notice him trying to smell my breath as I sent by, it would have been quite easy for him to smell it going past. On April 1st, I had hot whiskey and lemon. Had nothing during the day when I went home at dinner time. Had hot whiskey and lemon at tea time. Had nothing at breakfast. I had one shandy-gaff and one beer the previous night, Previous to the 31st inst. I had no drink since Saturday. On Monday nightm the 29th, there was practically no trouble. Brown didn't seem to have any objection to me being there, but didn't want Smith. On Wednesday night we didn't ask for anything - had no chance. I didn't know the door was locked. Brown came through the coowd and let Conrad in. I was there about five minutes altogether. I didn't smell beer on Smith, I couldn't smell it, as I had it in myself.
Can't smell it when I have it in myself. I don't know
rx-Policeman Sheehan at all. On the 29th Smith didn't
ask for the real stuff. On the 31st Smith, Lightel and
myself came cut at the same time, with the sailors. They
went along Water Street towards the Barracks, and we three went across the street. Had no conversation with Mr. Lawless.

Cross examined by Controller Harris. don't

We didn't carry billys or handcuffs when we are not on duty. I didn't see anybody reach for a billy that pight. There is a special pocket in police trousers for the billy, I have never seen policeman wear police trousers when off duty. Have only been on the police force a short time.

John Lightel sworn.

Cross examined by Mr. O'Hearn.

I was in there Wednesday night. I heard the statement of the two officers. I corroborate it. I have nothing to add. I was not drunk - I had been drinking, had three bottles of Keith's beer in a licensed saloon, between 9.30 and 10 o'clock. I don't have that much very ofter, it was an extra dose for me. Can't say how much I take each week. It didn't have any affect on me, I couldn't feel it. Had nothing during that day before. I met Huntley and Smith at the bar and two naval men, I think the were. That was the first time I was ever in Mackasey's. I occasionally go in other bars. I belong to Ellerhouse, but live here now. Was not a drinking man before I came here, I take a drink occasionally, can't say that I ever took that much at one time before. We went in to Brown's together, and Brown said "You can't get served here."

Smith said "I never asked for anything yet." That's about all I took notice of. Stayed in there about four about all I took notice of. Stayed in there about four or five minutes. I saw no person step up to Mrs. Brown in a threatening attitude (Huntlev and Smith say they saw ho soldier there at all). I had no handcuffs or billy there that night. I can't say there was any soldier there, I didn't see him anywhere. There is one table there that I know of, I don't think there was anybody sitting at the table. It is only a small room about half as big as this (Board of Control Room). The soldier may have been there, but I didn't see him. That was the

first time I was in there. There was one table and a counter. I was not under the influence of the beer, I could feel it, but it didn't affect me. We weren't out for a good time, just happened to meet. Iawless said nothing to me. The sailors there were strangers to me, I met them through Mrl Huntley.

I have told everything that occured as far as I know.

I have told everything that occured as far as I know. I can't say whether Brown and his wife were drunk or not. I won't say they were sober. Mrs. Brown seemed excited and ran out. Didn't see Mrs, Horner. Didn't see Ferguson. There were Mr. and Mrs. Brown and a sailor lying on the lounge, asleep, I supposed. When he ordered me out I said nothing, and didn't hear the others say anything. I heard Brown say to Smith "This is where I get back at you for what you and McIsaac did to me up the atreet." I didn't know the door was locked. When we first went in Brown said to Smith "You can't get anything here and Smith said " I didn't ask for anything yet, you didn't give me time to ask." I was in there altogether about four orfive minutes until Conrad arrived. I don't know whether there is a back room or not. I didn't see the soldier, he may have been in the back room, if there is one.

Mrs. Brown recalled.

(Is questioned by Mr. O'Hearn about her husband's previous trial and as to whether she swore out a warrant against him for theft. Mr. Murray objects.)

I did not swear a warrath against my husband for theft. He went away and I swore out a warrant, but there was no theft in it at all. (Refuses to discuss the matter further).

Board of Control Chambers, City Hall, Halifax, N. S April 12th, 1915. POLICEMEN HERBERT HUNTLEY, HENRY SMITH AND JOHN LIGHTEL - CASE CONTINUED FROM APRIL 9th. Gerald Piert sworn. Was in #8 Sackville I am a naval police officer. Street 31st of March at 10.15 o'clock. The three defend-ants were with me, also my friend Mr. Haeg. Previous to this I met Mr. Huntley at the Postoffice. We went in there to get supper. This man (Brown) turned around and said "You can't get anything in here Smith, and I'M going to get something back on you for what you did to me." The next thing I knew this woman (Mrs. Brown) rushed to the phone and called up Chief of Police Budland, then the phone and called up Chief of Police Rudland, then put on her bonnet and shawl and went out. I said to my friend "It's time to get out of this" and we walked out. we were in thereabout four minutes. I saw her trying to lock the door, and when she couldn't get the police, she opened the door and went out. I came here because I was subpoensed. These defendants weren't drunk, were not drunk while in my company. Cross examined by Controller Harris. I was there when Policeman Conrad9 came. I could not hera what he said, -was going out. The door was locked and he knocked at the door. I believe the woman locked the door after she phoned. I don't know whether the door was locked when Conrad came or not, I don't know Ferguson. I only saw a man and womanin there. Didn't see a Corporal. Didn't notice a man dressed in khaki. Cross examined by Controller Hoben. I saw the woman lock the door while she was atthe phone. I didn't see a man in khaki between the woman and another man. When I saw Mr. Huntley we went to Mackasey's bar. We didn't stay long there. Had two drinks at Mackasey's. We drank Keith's Beer + two bottles. Had no hard whiskey. I never was in the place before. The first thing I heard at Brown's was Brown saying "You can't get anything here Smith, I am going to get back at you for what you did to me." I heard them chewing the rag. Smith sain "What have you got against me?" I wouldn't like to be confident about what was said. There was a good deal said. I had about eight or ten drinks during the afternoon. I didn't drink whiskey, all ale. Drinks didn't set me up, one drink of whiskey wouldn't set me up, I would hardly feel it. I didn't stop to listed to the argument between Smith and Brown - it was rather heated. I saw the woman go to the phone, and told my friend we had better get out of this. The woman locked the door before the went to the phone. Don't know how she got out of the house. I saw Conrad come in - don't know whether he knocked on the door or not. I didn't see Brown going to the door. I said to my friend that it was time to go out, and we went straight out. I had about eight or ten drinks during the afternoon. I straight out. Cross examined by Controller Parris. There is only one door - the front door. Cross examined by Mr. O'Hearn. I didn't notice a side door. No person pointed him out to me coming along the hall (City Hall) Didn't point you out. I left Mackasey's at 15.10.

I know what time it was as I had my eyes about me, I was a clock. Don't remember Huntley saying "I know where we can get a drink. I had my senses about me. I could stand four glasses of whiskey. I didn't hear anything about McIsaac. Didn't see any cld woman interfere in any way.

I didn't see a military man - didn't notice any.

Cross examined by Controller Hoben.

Have not seen any of the policemen since that night. Have had no conversation with them since - have been on board ever since. Had no conversation with anyone in their behalf. I came here because I was subpoensed. No conversation over the phone. I told Smith I would be here at the first hearing. I said if anything happened out of this job I would come, I saw a hearing was to take place Friday morning, I saw it in the papers. I said if anything happened I would give evidence. I heard on the phone that there was a meeting going to be held and I said I couldn't get down. I believe it was Smith who phoned. He didn't ask me to be a lenient as possible.

Cross examined by Mr. Murray.

Met Huntley at the Post Office and went to to
Mackasey's. Am an oldfriend of Huntley's. Met Mr.
Lightel at the bar, then Mr. Smith came in afterwards.
Huntley, Smith and Lightel each had two drinks. It
was after that we decided to go and get something to
eat. Smith was ready to go with us - he said "What do
you want to go there (Brown's) for? I don't want to go
there." Haeg, a petty officer, suggested that place.
Smith didn't want to go. He sand something to the effect
that there might be some trouble, or something like that.
I don't know who went in first, we all went in together.
When I went in the door, I didn't notice anybody else in
there. I guess Brown was tending the bar. There was a
woman, I saw nobody else. I don't think that there were
any other persons in there. Don't know whether there is
a kitchen or not.

James Haer sworn.

Cross examined by Mr. O'Hearn.

My position is chief petty officer. I know one of the men very well, and the other two by meeting them. was in premises #6 Sackville Street March 31st. These three gentlemen over there (Huntley, Smith and Lightel) were with me and Peart. Immediately we went in Brown said "What do you want?" We said "We want something to eat". He said "You can't get anything in here Smith." I said Twhy can't we?" Then Mrs. Brown rushed to the phone and then rushed out, and I thought it was time for me to beat it and I went. I didn't see anybody interfere with the lady, never saw the door locked. I was standing beside the door. I was there when Conrad came in. I didn't wait to see the doings. Immediately Mrs. Brown went out I said "There goes me." Immediately we went in this fellow (Brown) started to go on to Smith and I thought it was time to go. Brown said "I'll get you yet Smith." The constables were not drunk, couldn't get a chancem there was nothing to get to drink. Met this gentlemen (Huntley) about the Post Office, then went in to

Mackasey's. Met Lightel and Smith in there. Had two bottles of beer in there, couldn't get any more, it was shutting-up time. Immediately we went im Brown's, he got after Smith. When Mrs. Brown went out, I went.

Cross examined by Controller Hoben.

I was in Brown's about three minutes - quite long enough for a place like that. I never said a word, not even "Good evening." I met Huntley sinceI came to Halifax. I met him once ortwice. I came a hore about 3 o'clock when I was off duty, I wasn't with the other petty officer. I met him at the corner of Barrington and Cogswell Street. Went up as far as the Academy, then to Mackasey's. I had no drinks all the afternoon. was ashore from 8 o'clock to ll. Went to Brown's about 10.5. Had four drinks before I went to Brown's. Didn't get a drink there, that was the worst of it. I had two drinks at Mackasey's and two at monaghans - had all before I went to Brown's. It was all Keith's beer. I went out of Brown's immediately Mrs. Brown went to create a trouble. My friends were not drunk.

Cross examined by Controller Harris.

I didn't hear anybody say "Can we do anything for you" Didn't hear Smith ask for a round of Keith's beer or anybody say "We don't keep it here."

Cross examined by Controller Hoben.

I was there once before. I didn't suggest that we go there, my friend suggested that we go there for something to eat. It was pay night and any of is could have suggested it.

Cross examined by Mr. Murray.

We left Mackasey's at 10 o'clock when they were closing. I don't remember seeing Conrad. Thepoliceman is wrong if he says he saw two petty officers, emphatically so. I didn't remain indoors at all. I stayed about three minutes. Mrs. Brown rang up the police, then she immediately ran and got on her cloak and hat and went out. She didn't lock the door or I would have been locked in. The door wasn't locked by her. I didn't see anybody in the back room. Smith wasn't under the influence of laquor. I didn't see a soldier in khaki. we didn't have anything to drink there, we went in to have a sandwick. We didn't have a chance to ask for anything. I have an absolutely clear recollection of everything that went on there in that room.

John W. Morrison sworn.

Cross examined by Mr. Murray.

I am a police officer. Iknow Smith. I went in this shop with Whith one night for nothing in particular. Thought we'd go in and have a look. Ilooked in the back place in the kitchen and came out and sat in the shop. Mr. Smith ordered two bottles of temperate beer and cigarettes, and told the man he would see him later. Lawless didn't expostulate with him about it. I remarked to him when we went outside that it was a funny place to go for anything like that. We were both on duty at the time. We had a look through the kitchen - didn't move anything, just had a look to see who was there. There was a man and woman there. Smith didn't tell me what he went in for, I took it for granted he went in to see what was going on. He ordered a beer and didn't pay for it and I understood he was getting it on credit. We were both on duty and in

uniform. I think I said "If I had known what you came for I wouldn't have come in." Will not be positive I said that.

Huntley redalled.

Cross examined by Mr. Murray.

I didn't say "I know where I can get a drink and if not I will clean the place out."

Cross examined by Controller Hoben.

I acknowledge appearing at the Police Station more or less dazed. I took the two drinks at tea time between five and six - took them both together. They must have been too big for me. I took them both before tea, one after the other. Had one as I went in and another as I came out. I didn't have any tea at all. was in the house more than two hours. I took them less than an hour apart. They must have been big drinks. I took a 50¢ flask more than half way down.

Henry Smith recalled.

Cross examined by Mr. O'Hearn.

I got cigarettes and temperate beer at Brown's.
On Monday night I paid 45¢ for the three bottles. I paid it to Mr. Brown. He was away when I got it. I think Ferguson served us. This is the time I went in with Mr. Morrison.

Crosseexamined by Mr. Murray.

Paid Brown +5¢ Monday night, supposed to be for the three bottles of beer got when he was away. I never went there and got two bottles of beer and didn't pay for it. I said before I never went there and got beer and didn't pay for it - I said that, but forget at the time, I didn't recall going in there. I had three bottles on Monday night and two the previous night. The evidence I gave theother day is not correct, I said I was not there previous to that, but didn't recall being there at that time.

Buster Brown recalled.

Cross examined by Mr. Murray.

On wednesday night I stayed in there until Conrad came in, and I told Conrad to put them out. Smith paid 45¢ for three bottles of beer, we charge 15¢ a bottle after 10 o'clock. We charge that to anybody, no matter who they are. The 45¢ was taken and nothing else was said. I didn't know about the previous drinks then, had just come back from the States, I knew nothing about it and said nothing to him about it.

Cross examined by Mr. O'Hearn.

We charge 10¢ for beer in the morning, after 10 o'clock we charge 5¢ more. It is 25 beer. As the hour grown later we charge more because we have to burn electric light, that helps me cut a little.

Cross examined by Controller Hoben.

Have been in business eight months and have been searched eleven times. They have never found a drop of liquor there - I have never had any. I don't sell it because I make enough at what I sell. I don't want

April 12th, 1915. to sell it, I make enough now. Cross examined by Mr. Murray. There was nothing said about getting square with Smith. Cross examined by Controller Hoben. I didn't know he got stuff on credit - know nothing about it, just got back from the States. They said he got beer and cigarettes and didn't pay for them, so I put it down on the statement. I didn't object in any way to serving him, but he called for akeith's beer and I couldn't serve him. John A. Rudland, Chief of Police, sworn. Cross examined by Controller Hoben.

> I do not think Smith a desirable policeman in view of the evidence that has been brought out. He has been

> on the force since January 17th, 1914.
>
> Huntleyhas been drunk, once on his own admission, in two months. I don't think he is a very desirable policeman. He was sworn on the 15th of February, 1915.

Lightel is a very indifferent policeman. Has been on the force since 17th of July, 1914. No man who goes to a place that is reputed to sell liquor is a desirable policeman.

Cross examined by Mr. O'Hearn.

I am assuming that Brown and his wife are to be believed. I don't know much about Brown, have never been brought in contact with him. I know nothing about his reputation. I cannot say that I have ever happened to hear of him telling lies.

Mrs. Brown complained to me of her husband stealing 1500 (Mr. Murray objects.)

I give my decision to some extent from knowledge of the men and some from the evidence.
