Administrative History: The Board of Control was established in the 1913 City Charter, taking over as the executive committee of Council, until it was repealed in May 1919. It was composed of the Mayor and four controllers. Controllers were members of Council elected by the whole City for two year terms. The Board could fix regular meeting times or could meet as often as necessary, often three times per week at noon. All meetings of the Board were open to the public, and were chaired by the Mayor.

The impetus to change the structure of municipal government came from the Special Committee on Board of Control, created by Council in 1910, and a special committee on Civic Administration of the Halifax Board of Trade. Pressured by the Board of Trade, City Council held a plebiscite on April 26, 1911, which favoured civic reform. Aldermen resisted the pressure to reform, but the provincial Legislature passed a bill forcing a Board of Control on the City of Halifax in May 1912, although it was not proclaimed until April 1913 (NS Statutes 2Geo.V c.77), and the first city elections under the new system were held on April 30, 1913. Controllers, like aldermen were elected every two years, and, unlike aldermen, received an annual \$1000 stipend, as they were expected to be more involved in the business operations of the City.

The Board had responsibility for the duties that had previously been assigned to the following standing Committees: The Committee of City Works; The Police Committee; The Committee on Cabs; The Committee on Finance; The Committee on City Prison; The Committee on Laws and Privileges; The Committee on Tenders; The Committee on Charities; The Committee of Firewards.

During the Board of Control era of government, City Council's power was greatly reduced, as was its size (2 aldermen per ward). Aldermen met irregularly, when the controllers, who were also voting members of Council, brought forward policy proposals and financial recommendations. Council could only reject a Board of Control recommendation twice with two-thirds majority. This centralized power in the Board of Control and often pitted aldermen against controllers.

Increased city spending brought opposition to the Board of Control system of governance, with several proposals to replace it narrowly defeated in the spring of 1918. Animosity between newly elected mayor A.C. Hawkins and aldermen resulted in 10 of 12 aldermen resigning mid-1918, essentially leaving city governance to the mayor and controllers, until the Nova Scotia Legislature passed a bill in the spring of 1919 to hold a plebiscite on doing away with the Board of Control. The April 30 1919 plebiscite brought a return to the old aldermanic system and municipal elections were held on May 28, 1919 and the alderman sworn in on June 3.


Public Gardens, Halifax, N. S., October 31st, 1917.

Gentlemen:-

I beg to report on a tree in front of premises #27 Inglis Street. Alderman Foley reported the tree to me as an obstruction to traffic of teams, etc. I examined it and found the tree showed signs of where teams had struck it. I started to cut off the branches that were interfering, when the owner objected, so I left it as it was. If this is not attended to, it will mean that the City may be liable to damage. The branch is useless to the tree as it is scarred and injuring the tree. I would suggest that the owner be sent a copy of the Shade Tree Act, where the City can cut trees interfering with traffic.

TRAFFIC ON STREETS - STREET CARS STOPPING AT NEAR

CROSSINGS - SPRING GARDEN ROAD A ONE-WAY STREET.

Read report Acting City Engineer as follows:-

City Engineer's Office November 5th, 1917.

His Worship the Mayor. Sir:-

We beg to report on the resolution of the Board of Control with reference to having the street cars stop on the near side of the intersecting streets instead of on the far side, and on the advisability of making Spring garden Road from Barrington Street to Grafton Street a one-way street, as follows:-

With regard to the first proposition, the Tram Company have in use at present about forty-six closed cars, Of these, only ten have doors on the front vestibules opening to the left. On the paved streets there would be little difference from the point of view of the convenience of the passengers, whether the cars stopped on the near or the far side, but elsewhere in town, if the cars stopped on the near side, and the passengers were

obliged to alight from the rear platform, it would mean there would be no crossing for them tostep on, and this would mean, more especially during the winter and spring months, great inconvenience and discomfort to them. If the cars were equipped with doors opening to the left so that passengers could get off the front platform, there might be some argument in favor of having the cars stop at the near crossings.

The Tram Company are at present altering the closed cars, so that the doors will open in this manner, and in our opinion, the question of changing the stopping place should be postpaned until all the care are thus equipped.

With regard to the second matter, your Board is aware that traffic conditions are extremely congested and bad at the intersection of Spring Garden Road and Barrington Street. The stationing of traffic policemen there some time ago has been of great service, more especially in regard to safety of the public, but owing to the congestion the convenience of the public is not served on account of the delay. There is a proposition at present before the Board of Contdol to acquire a strip of St. Paul's Cemetery so as to widen this part of Spring Garden Road. Should this be done, it would probably be possible to allow the traffic both ways on this street without inconvenience or danger, but at present, it is out opinion in the interests of the safety and convenience of the public, that vehicular traffic on Spring Garden Road between Grafton Street and Barrington Street, with the exception of the street cars and funerals, should be only allowed to proceed in an easterly direction, and that all vehicles wishing to go to the westward of Barrington Street, should be obliged to go up Elowers Street or Morris Street.

The clause of the report relating to the stopping of street cars at the near side of the street is filed.

With respect to the clause relating to traffic on Spring Garden Road, the City Solicitor is instructed to prepare and submit the same at Thursday's meeting, an ordinance regulating vehicular traffic on Spring Garden Road between Grafton and Barrington Streets, providing that with the exception of street cars and funerals, such traffic shall only be allowed in an essterly direction, and that all vehicles wishing to go to the westward on EarringtonStreet, shall be obliged to go up Elowers Street or Morris Street.

STREET CARS OVER-CROWDING.

Controller Hines called attention to the over-crowding of street cars. On a recent evening about 10 o'clock, an over-crowded car going up Buckingham Street, stopped six times on account of excessive load, and each time the car slipped back down the hill because the brakes would not hold. Passengers boarded the car in spite of the conductor, who tried to keep them off. He thought cars going up Buckingham Street should not take more passengers than could be seated.

The Secretary is instructed to call the attention of of the Tramway Company to the complaint.

CITY HOME REPORT FOR OGTOBER.

Read report City Homefor the month of October, including a recommendation that tenders be invited for supe ply of 1,000 bushels of potatoes and 50 bushels of turnips, usually called for about the 20th of November.

Read report and expropriation resolution submitted by the Acting City Engineer, as follows:-

> City Engineer's office, November 5th, 1917.

His Worship the Mayor. Sir:-

I have taken all the preliminary steps required by the City Charter for the purpose of expropriating the land required from William McFatridge for the purpose of widening Chebucto Road at the said property, and beg to submit the accompanying resolution, which, when passed, and the money paid into Court, and the description, plan and resolution filed in the office of the Registrar of Deeds, will vest the title of the property in the City.

In my opinion, while the widening of the street will take a certain amount of Mr. McFatridge's property, it will, nevertheless, enhance the value of the remainder of

the said property. The area required is about 1090 square feet, and the assessed value of the same is 12ϕ per square foot.

I would recommend that the City pay into Court the sum of \$125.00 for the land to be taken.

WHEREAS the City of Halifax requires the land and premises hereinafter described for the purpose of widening and straightening Chebuoto Road, and the City pneineer has duly peepared a plan of the said land and premises, together with a description of the same, and submitted the said report, description and plan to the City Councilfor its approval, and the said report, description and plan were duly approved by the City Council on the 4th day of October, 1917, and a copy of the same has been filed in the office of the City Engineer, as required by law;

AND WHEREAS on the 18th day of october, 1917, a notice containing a description of the land and premises so required was duly served on William McFatridge, claiming to be the owner of the said land and premises, together with a notice of the intention of the City to expropriate the said land from the said owner after the expiration of the time required by law from the date of the service of such notice;

AND WHEREAS a notice containing a description of the said land so required and a notice of the intention of the City Council to expropriate the said land and premises after the expiration of the time required by law from the date of such expropriation was duly published by the City Engineer in the Acadian Recorder, Evening Mail and Daily Echo, three newspapers in the City of Halifax, for two weeks by two insertions each week, namely, on the loth, 17th, 23rd and 24th days of October, A. D., 1917;

THEREFORE RESOLVED that the said land the premises be and the same are hereby expropriated, which said land and premises are described as follows:-

All that lot, piece or parcel of land situate, lying and being on the south side of Chebuoto Read in the City and County of Halifax, the said lot being more particularly described as follows:-

Beginning at a point on the official south line of Chebucto Road, the said point being 243 feet more or less westerly from the west line of Chebucto Ree Lane; thence westerly by the said official south line of Chebucto Road 130 feet more or less or to the western boundary of propety belonging to the said William McFatridge; thence northerly by the said western boundary until it meets the existing south line of Chebucto Road 180 feet more or less or to the eastern boundary of the said McFatridge property; thence southerly by the said existing eastern boundary of the said McFatridge property to the place of beginning.

The above described lot being all that property shown enclosed by red lines on a plan entitled "Plan of

McFatridge property on Chebucto Road" signed by H.W. Johnston, Acting City Engineer, and dated the fourth day of October, A.D., 1917, and filed in the City Enginner's Office at Halifax at Plan #3988.

CUMARD STREET GRADE.

Read report Acting City Engineer as follows:-

City Engineer's office, oth November, 1917.

His Worship the Mayor. Sir:-

I beg to report on the accompanying minute of the Board of Control asking for a report in writing on the grades of the new concrete curb and sidewalk on the south side of Gunard Street near the corner of Cottingen Street, that when Dr. Little, the owner of the property at the south-west corner of Gunard and Gottingen Streets, proposed erecting a new building on this site, I met him there and told him that the leval of the curb on the south side of Gunard Street when built would be at the same level as that on the north side, and that the inside of the sidewalk would be about four inches higher. Subsequently, when work on the building was ready to be started, Mr. Noonan, his architect, telephoned the office and was given the same grade.

This grade was not followed in the construction of the building, and the level of the floor of the entry to the store on Cunard Street is five inches below the curb level of the north side of the street at the west side of the entry and nearly four inches at its east side.

In constructing the new curb and sidewalk on the south side of Cunard Street, the circular granite curb at the corner of Gottingen Street was reset, and the west end of this is about one-half an inch lower than the north side, and nearly three inches lower than the old level of the curb at this point. The grade runs from here to Creighton Street at about the same level as the curb on the northside of the street. This curb and gutter has been completed and also the sidewalk from Creighton Street to the west side of Dr. Little's building, and five squares of concrete in front of the building.

The grades as given and laid down for the south side of the street are, in my judgment, the best and proper

It has been suggested that the curb and sidewalk might be lowered to give relief at the entrance to the building. If this were done, it would be necessary to reset the granite circular curb and gutter at the corner and lower it at the west end five inches, and reset the concrete curb and gutter from this point to the west end of the building about sixty-seven feet. The sidewalk on Cottingen Street would have to be lowered for at least ten feet south of Cunard Street, and the bitulithic pavement relaid between the gutter and rail at the corner. If the grade were lowered in this manner, the curb would be one-half an inch lower than the floor of the entry at the west side and two and three-eights inches lower at the east side. This would cost about \$200.00. The sill of the doorway is one-half an inch higher than the outer edge of the floor of the entry at its west end, and three and one-half inches higher than at the east end. It is also higher than the main floor of the shop, and is reached from the latter by a ramp. The floor of the entry could be raised and sloped upwards from the doorsill to meet the sidewalk grade as laid, or a step could be made from the level of the sidewalk to the floor of the entry. In either of these cases there would be a liability of rain and waterdrifting in, and they are only suggestions which may help the owner in remedying conditions.

It must be understood that the City would in no way be liable if either were carried out and did not prove satisfactory, as it is a matter entirely within the discretion of the owner to take such steps as he may judge best. As before stated, I believe that the grade adopted is the correct one.

We are agreed that the least increase we could possibly get along with would be \$200.00. The majority of us are married men with families to support and we fund that the average monthly rent paid by each of us amounts of to \$15.00, which is bout the lowest rent obtainable in the City of Halifax today.

We would call your attention to the fact that 3rd year men on the present basis receive only \$850, less 5% paid to the Superannuation Fund, leaving \$807.50, deducting from this \$216.00 for rent leaves a balance of \$591.50 a year, which is less than \$50.00 a month to clothe and feed our families. We submit to you, Gentlemen, that it is an impossibility for us to live on this amount and keep out of debt.

DUTCH VILLAGE ROAD CULVERT.

The brook on the east side of the Dutch Village Road crosses the latter at about the north side of Chebucto Road. There is an old culvert at the crossing, with a wooden plank bridge over it. shall certify that the proposed street conforms to the requirements of law and is in other respects satisfactory.

There is a 16-gt. right of way along the line of the 27-inch water pipe, running diagonally through a portion of this property. The City has a free and uninterrupted right to use this at any time and no structures can be built on it.

We beg to acknowledge receipt of your favor of the 10th inst., being an extract from Minutes of a meeting of the Board of Control held on the 6th of November, and referring to street car overcrowding.

We beg to advise that it would be preferable to this Company if passengers would not overcrowd the cars, and it si out effort to have them avoid doing so. Our employees have no legal authority to eject passengers from the cars, and we are therefore obliged to submit to overcrowding on certain cars when the public insist upon so doing. We believe we are now giving an efficient service and are endeavoring to run extra cars at what is commonly called the "rush hours", and while we are somewhat hampered by scarcity of conductors and motormen, we consider that our service is such that it would entail no great hardship, nor any great loss of time to the public if they would refrain from overcrowding the cars and wait for the following car, in the event of one being overcrowded. We are doing our utmost to cope with the situation and furnish the public with an efficient and regular service, and if the general public would cooperate with us in this respect', there would be no need of overcrowding whatsoever.

We beg to express out appreciation of the interest taken by the Board of Control in this matter, and beg to assure the Board that we will do everything possible to avoid the overcrowding of the cars at any and all times.

His Worship the Mayor and Board of Control, Gentlemen:-

Amongst the great lessons taught by the present war and one which time after time has been brought most vividly to the minds and experience of many communities, has been the utter wastefulness and woeful loss of property, including foods and other necessaries of life, and munitions of war through preventable fires. The magnitude of such losses in war time is more impressive than under other circumstances because the effect is felt by all persons in time of war, whilst in peace times the burden is a pecuniary one only and is suffered only by an immediate, interested few.

It would appear then, that while the minds of the people are filled with instances almost daily through the columns of the press in which great losses through preventable fires might have been averted and immense Quantities of foods and munitions of war saved for their proper purpose is an opportunity not to be neglected by legislative bodies.

In ordinary times the annual loss by fire in Canadian cities is very great and the cost of the upkeep of Municipal Fire Departments a burdensome tax.

Most communities, including the City of Halifax, have officials whose duty it is to inspect properties for fire hazard and to apply certain regulations for the correcting of unsafe conditions, but the results of this system are far from satisfactory everywhere.

An effective deterrent for prev entable fires must touch the pocket of the careless or vicious property holder. A short cut to this is to make him personally financially liable.

The Common Law principle of liability for injury resulting from carelessness or neglect in order that it might be summarily, inexpensively and expeditionally applied should be supported in the special matter under consideration by statutory enactment and municipal regulations.

This subject is most opportunely a live question in h the United States at the present time and is being urged with some diligence by the National Fire Protection Association of which the City of Halifax, through its City Clerk, is a member.

The City of Greater New York, the City of Cleveland, Ohdo, and the State of Pennsylvania have already moved in the matter and have had the principle enacted into law.

I think the subject worthy of consideration by the Oity of Halifax for many reasons.

The Law in the State of Pennsylvania is as follows :-

"Section 1. Be it enacted by the Senate and House of Representatives of the Commonwealth

of Pennsylvania in General Assembly met, and it is hereby enacted by the authority of the same: That where a fire originates on the premises occupied by any person, firm or corporation as a result of his or its oriminal intent, design or wilful negilgence, or where said per-son, firm or corporation has failed to comply with any law or ordinance of said cities or any lawful regulation or requirement of any State or municipal authority enacted or made for the pre-vention of fire or the spreading thereof, such person, firm or corporation shall, in addition to the present penalties for the punishment of persons convicted of arson or the payment of any fine or penalty for the viclation of any law, ordinance or lawful regulation or requirement of any State or municipal authority enacted or made for the prevention of fire or the spreading thereof, be biable in a civicl action to said cities for the payment of all costs and expenses of the fire departments of said cities incurred in and about the use of employees, apparatue and materials in the extinguishment as afore-said. The amount of such costs and expenses shall be determined by the Director of the De-partment of Public Safety based upon the wages of the firemen and other officers fr the time they were engaged in the extinguishment or the attempt to extinguish such fire; a reasonable amount as rental for the use of the apparatus of said city, and the cost of the wate or other materials used in the extinguishment or the attempt to extinguish such fire, with an addi-tional amount of ten per centum on the total amount as aforesaid as supervisory or overhead charges, all of which shall be paid into the City Treesury for the use of said Cities City Treasury for the use of said Cities.

Bection 2. All acts or parts of actsin consistent with this Act be and the same are hereby repealed.

The National Fire Protection Association urge all persons who suffer from preventable fires to bring suit for the recovery of damages.

The enactments in New York, Cleveland and Pannsylvania only confer on the municipalities the power to collect the cost to the Fire Department of extinguishing or attempt ing to extinguish preventable fires.

The turning out of a City fire brigade with its attendent risks and expense for the extinguishing of a preventable chimney fire is a ridiculous example where the property holder should if at fault reimburse the Municipality for actual cost.

Laws of this nature if deemed wise should really be Provincial or Dominion wide and not confined to individual

or isolated communities only, and with that object in mind I would ask the privilege of submitting copies of this suggestion to the Honorable the Premier of Nova Scotia, to the Secretary of the Union of Canadian Muni-cipalities and to the Secretary of the Union of Nova Scotia Municipalities.



In the Spring we let a contract for 1,750,000 pounds of cement in anticipation of our requirements for the year's work. After the contract was let, the Council decided to very materially out down the sidewalk work, and a comparatively small amount of the cement contracted for was required.

The contractor has delivered to date about 925,000 pounds, of which quantity we have in stock about 220,000 pounds. He writes me that it will be necessary, if we propose to take the full amount ordered, to decide on the same before Wednesday. The original contract was for total delivery during the summer.

We have sufficient in stock to carry us until next Spring, and I do not think it advisable, owing to the danger of deterioration in our stores, to store any more. Controller Taylor reported that agreeably to resolution of the Board of November 13th, 1917, p. 528, he and the Chief of Police had conferred with Liquor Inspector Tracey in the matter of co-operation between the Inspector and the police Department in the enforcement of the Temperance Act.

The Inspector had informed them that he believed he was getting from the Police Department all the help they could give him.

His Worship the Mayor stated persons had hinted to him that policemen on their regular beats were not as active in supplying information as they might be, and suggested that policemen's beats be changed more frequently than is the usual custom.

TAXATION ACT.

Controller Finlay submits for the approval of the Board the following report from the City Solicitor re new taxation act:-

Rear Sir:-

In reply to your request as to the present position of the above, I beg to say as follows:-

Améndments to the present law were considered by the former Board of Control and recommended to the former Council. These amendments were confined to the abolition of the tax on personal property and the substitution for it of business and household taxes. The Council added the taxation of improvements onland at a fixed rate, leaving the balance required for the yearly estimates to be raised by a dax on land values.

An Act authorizing these changes was prepared and

submitted to the legislature at the last session, and submitted to the legislature at the last session, and passed with the only addition of requiring an experimental assessment to be made. As a complete Act would have been very lengthy, it was deemed best to follow the precedent by which the Board of Control system was instituted, namely, to pass a comparatively short and simple act embodying the principles required, and directing the preparation of an act working out all the details necessary, which, when prepared, could be brought into effect by an order of the Lieut. Governor in Council. The Act so passed

Immediately upon the passage of the Act, I prepared the draft of the Act so directed to be prepared. To do charter from Section 369 to 483, dealing with taxation. Those which were particularly affected by the change have been entirely redrafted. Others have required only offected taxes, taxes on banks, the register of real estate, notices, tax sales, and others, will require no change, and I have mersly indicated the places at which they will require to be inserted, when it is determined to present the Act in a complete form.

This draft is submitted to the members of the for-mer Board of Control and to the City Assessor. After considerable discussion it was decided to defer further action until the result of the experimental assessment had beenobtained. That experiment was made and every tor result control of the provide to be would be tax payer served with a notice of what taxes he would be called upon to pay under the proposed change, and the exact results are now in the Assessment office.

The present position therefore is that the Act stands ready (after a few days work on formal completion) for submission to the Governor in Council, for enactment by Order in Council. The Government will not, I presume, take any action in the matter unless requested to do so. That request may of course be made by the City, but there is nothing to prevent any other body from making it The Board of Trade has had the matter under consideFation, and it is possible that that body may take some action.

I have only to add that the draft follows the Act in all matters of principle. Several changes in these have been suggested, but if any such changes are to be made, it will have to be done by legislation, as the authority of the Governor in Council is confined to bringing into force an act along the lines of the Act passed by the legislature.

I beg to report on the accompanying minute of the Board of Control covering complaing of Mr. C. E.Smith that the water had been turned off at #745 Barrington Street where there had been no waste of water or defecto ive plumbing, and that he had to pay a fine before the water was turned on.

The premises were inspected by the Water Inspector on Nov. 3rd, 1917. A tap was found wasting and a closet was running full bore. Mr. Smith was notified of this by Mr. Hughes on Nov. 10th and the water was turned off. On the 12th, on which date Mr. Smith paid a fine and it was turned on again.

The law provides that the water may be turned off any property where the owner, agent of the owner, odcupant or consumer of water is allowing the water to run to waste. In this case, the water was not only wasting on the day that it was inspected by the inspector, but from the evidence obtained by him, the waste had been going on for some time.

I find that through an error, Mr. Smith paid \$2.00 instead of \$1.00 before the water was turned on, and he is therefore entitled to a refund of \$1.00. The law distinctly says that where the water is turned off on account of it having been wasting, the owner or occupant shall pay a fine of \$1.00 for the first offence before the water is turned on, and under this section, as there is no question of the waste having taken place, I do not think that the Board has any power to order a refund of the fine.

Dear Sir:-

I have for acknowledgment the receipt of your favor of the 23rd instant, complaining of unsatisfactory service in connection with the street lighting.

We fully realize that the present street lighting system is not a satisfactory one, and I have taken the liberty on many occasions during the last two years of drawing thes fact to the attention of the Board of Con-trol. The foult with the system is not due to any inefficiency in the patrolling regulations, as the en-tire service is patrolled twice each night. I feel that the statement that lamps remain out for several successive nights is an exaggeration of the facts, but we do know that the lamps go out frequently and the cause of this is due to the age of the equipment and the difficulty of promptly obtaining repair parts of this now out of date type of lamp. In as much as our contract with the city for street lighting is a temporary one, and one that is due to expire in March of April of the ensuing year, you will readily understand that this Company could not afford to either replace or rehabilitate the present arc lamps to supply a service of such a temporary nature and the C ity authorities were aware of this condition when the temporary contract was signed. We are doing when the temporary contract was signed. We are doing the best we can to keep the present arc lamps in repair, but we feel that it would be an absolute waste of money to attempt to completely repair the pesent arc lamps, as we do not consider, in any case, that they are a satis-factory type of lamp for use in this City.

I have issued instructions to have more care given to the maintenance of these lamps. and so long as the contract remains in force we shall do the very best we can with the equipment to keep it operating as satisfactorily as possible. I would be glad, however, if you would call my attention to any individual cases of lamps being out for any length of time as suggested in your letter, so that I may make a special investigation in connection therewith.

As this building is situated near the Citadel, a point of interest to all visitors to Halifax the impor-ance, for the sake of the good name of the City and the Military authorities, of keeping it from being an eye sore is obvious.

There is a clause in the city's lease from the De-partment of Militia and Defence which reads " and everafter keep the said premises, including the clock, at all times in good order and repair at its own expense."

It is evident from the appearance of the tower that this clause has not been lived up to by the City, and I would request that you give this matter your earnest attention with a view to having the building immediately put in a proper state of repair.

TRAFFIC ORDINANCE.

Read report Acting City Engineer and Controller Taylor re Traffic Ordinance, as follows :-

His Worship the Mayor. Sir:-

As you are aware, traffic conditions, more especially in the centre of the town, are becoming very much congested, and owing to the diversified nature of the traffic on our streets, it is absolutely necessary for the safety of the public, to have a traffic ordinance.

We have gone into this matter thoroughly and examined

the ordinances from other cities, and beg to submit herewith a proposed ordinance to regulate the traffic on our streets, which we recommend for adoption.

The following Ordinance is submitted and ordered to be printed in the Board of Control Minutes:p

Ordinance No.....

An Ordinance to Regulate Traffic on Streets.

Be it Ordained by the Mayor, Controllers and Alder men of the City of Halifax, as follows:-

1. In this Ordinance, unless the context otherwise required.

(a) The expression "vehicle"" shall mean and include every description of waggon, carriage, cart, sleigh or sled or other thing thravelling upon wheels or runners, except a street car or a baby carriage, and whether drawn by any animal or propelled by mechanical power, and includes also a person on horse back and a horse led by any person;

(b) the expression "horse" shall mean and include any animal or animals;

(c) The expression "driver" shall mean and include the person having charge of a vehicle; the rider, driver or leader of a horse; the rider of a bicycle, tricycle or other wheeled vehicle; and the operator of a motor cycle;

(d) The expression "street" shall mean and include any public street, road, lane, alley, square, way, place, highway or other means of communication used by the public, whether accepted by the City or not;

(e) The expression " one way street" shall mean and include a street all traffic on which shall proceed in one direction, as indicated;

(f) The expression "ourb" shall mean and include any lateral limit of a portion of a street used or intemed to be used for vehicles whether marked by curb stones or not.

2. The control of traffic in the streets both by vehicles and pedestrians shall be vested in the police force of the City, who shall enforce the provisions of this ordinance --

3. A vehicle except when passing a vehicle ahead shall keep to the left and as near to the left curb as possible. - 565 -

4.(a) A vehicle meeting another vehicle shall pass on the left.

(b) A vehicle overtaking another vehicle shall in passing keep to the right.

(c) A vehicle in turning to the right into another street, shall pass to the left of and beyond the centre of the intersecting street before turning.

(d) A vehicle in turning to the left, into another street shall, when its width will permit, keep as near to the left curb as possible.

(e) A vehicle crossing from one side of the street to the other, shall do so by turning to the right, so as to head in the general direction of traffic on that side of the street.

5. No person having charge of a vehicle shall allow the same to come within ten feet of any vehicle in front of him when approaching with the intention of passing over any crossing over which a pedestrian is about to pass.

6. The driver of every vehicle, coming up with or overtaking any tramoar, and intending to pass on the left side shall, if the trancar is at a standstill, or about to come to a standstill or stop, bring his vehicle to a standstill in the rear of the trancar until after the trancar is again in motion.

7. No person shall drive, guide or have the care of two or more horses harnessed respectively to different vehicles.

8. No vehicle shall be driven on any one way street except in the direction indicated.

9. No person shall drive any horse, or drive, wheel or draw any vehicle except hand carriages conveying children only and drawn by hand, upon any footpath or sidewalk of any street unless for the purpose of going dir ectly across any such footpath or sidewalk into a yard.

10. No one shall drive a vehicle that is so cover ed in or constructed as to prevent the driver thereof from having a sufficient view of the traffic following and at the sides of such vehicle.

11. (a) Every driver of a vehicle shall, in slowing up or stopping give a signal to those behind, by raising a whip or hand vertically.

(b) In turning while in motion or in starting to turn from a standstill, a signal shall be given by the driver of the vehicle about to be turned by raising a whip or hand, indicating the direction in which the turn is to be made.

(c) Before backing, ample warning shall be given by voice or uplifted hand, and while backing, due care must be exercised by the driver not to injure any person or vehicle behind him.

12. Vehicles must stop so as not to interfere with or prevent the passage of pedestrians at crossings. - 566 -

13. The driver of any vehicle shall stop the same on a signal to stop made by any police officer-and place his vehicle in such position as such officer directs.

14. Where police officers are stationed at street intersections for the control of traffic, due blast of police whistle indicates that north and south traffic shall stop and that east and west traffic may proceed. Two blasts that east and west traffic must stop and that north and south traffic may proceed. Three or more blasts is a signal of alarm and indicates the approach of a fire engine or some other danger.

15. No vehicle shall be used on any street or highway unless provided with lights and sound signals as prescribed by law.

16. (a) All motor vehicles shall carry and keep burning between the sunset and sunrice such lights as are prescribed by the Motor Vehicle Act and any amendments threto.

(b) All other vehicles shall carry and keep burning between sunset and sunrise two lighted lamps showing a white light ahead and one showing a red light in the rear. The rear lamp may be ommitted if provision is made in the backs of the two front lights to shew a red lightswhich oan be plainly visible from the rear.

17. No owner or driver of any motor vehicle shall make use of any siren, or other similar contrivance or device, emitting or producing any sound resembling or likely to be confused with the siren, or other contrivance of device used for such purposes on any apparatus or vehicle used by the fire department.

18. Every driver of any vehicle shall, on seeing danger of collision with any vehicle, horse or person, or on receiving any warning, signal, or command from any person, or the driver of any vehicle, or horse, requireing him to stop on account of any danger to any person horse or vehicle, stop immediately and not proceed again until all danger has passed, and in every instance the driver of any vehicle shall immediately stop when required by any police officer and place his vehicle in such position as the said officer directs.

19. Any vehicle used by the police department or the fire epartment, and any ambulance shall have the right of way as against any other vehicle on any street, and shall have the right to pass through any procession.

20. Subject to the foregoing section, a street car shall have the right of way between cross streets over any other vehicle, and the driver of any vehicle proceeding on the track in front of a car shall immediately turn out, on a signal by the motorman or conductor of the car.

21. A vehicle waiting af the curb shall promptly give place to a vehicle about to take on or let off passengers.

22. The driver of a vehicle on the approach of

a fire engine or any other fire apparatus shall immediately draw up the vehicle as near as practicable to the left-hand curb and parallel thereto and bring it to a

23. The driver of a street car shall immediately stop the car and keep it stationary upon the appraoch of a fire engine or other fire apparatus.

24. On any alarm of fire the driver of every vehicle on the street traversed or to be traversed by any fire engine or other fire apparatus shall immediately draw or turn to the left side or curb so as to leave a clear path for the passage of such apparatus through

Subject to the foregoing provisions of this 25. Ordinance every vehicle or street car going in an easp-erly or westerly direction shall have the right of way over any vehicles or street cars going in a northerly or southerly direction.

No vehicle shall proceed at a rate of speed 26. greater than the law allows, and at no time shall a ve-hicle be driven, or a horse ridden, with a reckless or negligent disregard of the conditions then obtaining and the rights of others.

27. No person having charge of a truck, dray, cart or bloven, with an animal attached thereto shall dirve the same at a greater speed than five miles an hour except in passing another team.

28. No person having charge of a h^ackney carriage with an animal attached thereto shall drive the same faster than a rate of six miles an hour.

29. No person having charge of a delivery or express waggon, with an animal attached thereto shall drive the same faster than a rate of six miles an hour.

30. On approaching a crossing of intersecting streets, or in traversing a crossing, or an intersection of streets, or in going around a corner or curve in a highway, a vehicle shall not be driven at a great/rate of speed than what is reasonable and proper having regard to traffic at the time and place, and the use of the way and the safety of the public, and in going around corners, the speed of any vehicle shall not exceed six miles an hour.

No vehicle shall stop with its right side to the 31. curb except on an established cab, hack and truck stand or in a one way street.

No vehicle shall remain backed up to the curb ex-32. cept when actually loading or unloading, and then not for more than ten minutes at any one time; but in no event shall any vehicle block any street car.

33. Unless in an emergency or to allow another vehicle or pedestrian to cross its way, no vehicle shall stop in any street except close to the curb.

34. No vehicle shall stop in such a way as to obstruct any street or crossing for the purpose of taking on or setting down a passenger or for loading or unloading freight, or for any other purpose except in case of accid-- 568 -

ent or when directed to do so by a police officer.

35. No vehicle shall stop or stand within the intersection of any street, nor within fifteen feet of a street corner, except when compelled to do so by a street car stopping in front of it.

36. The person in charge of a vehicle shall not stop the same abreast of another vehicle lengthwise of a street or in any street except in case of accident or emergencey.

37. The person in charge of a vehicle shall not place the same in any street so as to prevent or obatruct the passing of other vehicles or street cars.

38. No horse shall be left unattended in any street unless he is securely fastened by being tied to a post or weight, or unless the wheels of the vehicle to which he is harmessed are securely tied, fastened or chained and the vehicle is of sufficient weight to prevent it a being dragged at a dangerous speed with the wheels so secured, and no vehicle shall be left standing in a street for more than thirty minutes, except the vehicle of a physician visiting a sick person at the place at which the vehicle is stopping.

39. No person shall fasten any horse to any tree, tree guard, ornamental light post, fire alarm or post office box.

40. No person shall wash any horse or vehicle on any street.

41. No vehicle shall back to make a turn in any street, if by ad doing it interferes with other vehicles, but shall go around the block or to a street sufficiently wide to turn in without backing.

42. No person shall drive or conduct any vehicle in such condition or so constructed or so loaded as to be likely to cause delay in traffic or accident for injury to man, beast or property.

43. No person shall drive or convey through any public street, any vehicle the width of which, with its load, exceeds ten feet, except in accordance with a permit from the Chief of Police.

44. No person shall in any street use any truck or dray the length of which from the end of the shaft to the extreme end of the side is greater than twenty five feet, or a motor vehicle of a greater length than twentysix feet, except in accordance with a permit from the Chief of Police.

45. No person shall carry or Cause to be carried on any vehicle a load the weight of which exceeds six tons unless such load consists of an article which can not be divided, except in accordance with a permit from the Chief of Police.

46. No driver of a vehicle with a horse attached thereto shall cease from holding the reins in his hands to guide and restrain the horse, nor, when not seated on the guide and restrain the horse, nor, when not seated on the shaft or vehicle, cease from walking by the lead of the shaft or -569 -

wheel horse, either holding or keeping within reach of the bridle or halter thereof.

47. No one shall load a vehicle with iron or other material that may cause a noise by striking without properly deadening it so that it will cause no unnecessary noise, and any vehicle loaded in such a manner shall proceed at such rate of speed(not exceeding that elsewhere in this ordinance mentioned) that no unnecessary holse shall be caused by the vehicle itself or its load.

48. No one who is less than sixteen years of age shall drive any vehicle on any street.

49. No one shall crack or/use a whip as to annoy interfere with or endanger any person, or excite any horse other than which he is using.

50. No horse shall be mbitted in any street or highway unless secured by a halter and no horse shall be allowed to roam at large on any street.

51. No one shall remove a wheel pole, shaft, whiffle tree, splinter bar or any other part of a vehicle or any part of a harness likely to cause accident if the horse or horses start, without first unhitching the horse or horses attached to said vehicle.

52. No one shall steal a ride upon any vehicle or street car and noe one shall ride upon the rear of any vehicle without the consent of the person in charge thereof.

53. Vehicles used for delivery purposes not requiring a license shall have painted or otherwise plainly shewn thereon the owner's name.

54. All vehicles conveying loads which overhang the vehicle to the extent of six feet or upwards, shall display on the overhanging portion of said load, a light, flag or other sign sufficient to warn the public of the projection of said load.

55. No vehicle on runners shall be driven on any street unless there are attached to the harness of each horse drawing the same at least one large open bell or four serviceable round bells.

56. Pedestrians shall when meeting on any street pass to the right; and when overtaking other pedestrians pass to the left.

57. Pedestrians shall use due care so as not to ob struct or impede each other.

58. Persons walking abreast on any sidewalk mist on meeting other pedestrians occupy not more than onehalf the width of the uldewalk, and in case only a portion of the sidewalk be paved, not more than half the width of the paved portion shall be occupied.

59. Two baby carriages shall not be w heeled abreast on any sidewalk.

60. Every person who contravenes or fails to comply with this Ordinance shall wide for each such offence -570 -

be liable to a penalty not exceeding twenty dollars and in default of payment to imprisonment for a period not exceeding one month.

61. This Ordinance to be in addition to any laws or ordinances at present in force, and the provisions of any ordinance inconsistent with the provisions of this ordinance are hereby repealed.

His Worship the Mayor. Sir:-

At the beginning of the month I wrote the Tram Company asking for prices for installing arc or incandescent lights on Barrington Street between Spring Garden Road and Buckingham Street.

The Tram Company expected to have a few extra arc lamps within a few days, which, if obtained, could be installed. I asked them for a figure for 60 watt incandescent lamps also. Their estimated cost of installing incandescents is \$15. each, and the arcs 56 each. but the Company offer to do the work and charge for the exact cost of same. They will supply lighting at the contract rates.

I wrote the General Staff Officer asking for permission to instal the incandescent lights with reflectors over them, and have obtained same, subject however, to the approval of the location by the Headquarters office. Under the new regulations, it will be necessary to darken the arc lamps for three-quarters of the way down. Under these circumstances, I am inclined to the opinion that the incandescent lights, if not required to be dark ened, would give better results.

I would ask for authority to instal the incandescent lamps in one block, and if satisfactory to continue the same on the others; otherwise, to use arc lamps. We have sufficient money in the appropriation to do this work.

The Tramway Company have just issued notification that they propose to introduce a change to one-man oper-ator on certain parts of their system. Before this change is permitted, the City is entitled to know the justification for same. It is useless to claim that such a change is going to improve the service, as the result would be directly opposite. It would seem the real purpose behind the move is to effect further economy in their operation.

The convenience and safety of our citizens should be of equal importance, and before such a change is put into effect, the matter should be carefully gone into.

One explanation offered of the difficulty experienced by this Company in securing the necessary help is that the wage paid is not sufficiently attractive. If this is so, it would seem, in view of the enormous surplus earnings shown year after year, by this Company, that the remedy should be applied by increasing their scale of wage, so as to attract the class of help required.

I would recommend that this Board ask that the proposed change be not put into effect until an opportunity is extended of going into same.

The Board of Controlmet this morning at 11.30 o'clock; present Deputy Mayor Colwell, Chairman, Controllers Hines, Finlay, Murphy and Taylor. Chairman

The Mayor informed the Board that this is an emergency meeting demanded in the absence of the Mayor by Mr. D. Macgillivray and W. A. Black who represent the Relief Committee.

Both men are present and addressed the Board.

Mr. Macgillivray states that the Executive Committee Comprising Ex-mayor McIlreith, G. S. Campbell, G. E. Vaulkner, W. A. Black, Mr Beazley, Mr. Silver, Mr. Jones, have been in continual session since the accident. He states that conditions are such that steps should be taken ina civic way. They have been unable to meet with civic author-. ities to present matters in an official manner.

The Committee express the opinion that the Board of Control shound be here at all times so that matters may be dealt with in an official way.

The question of proclaiming Martial Law is discussed. IS. The matter is deferred for the present and Mr. Bell, City . Solicitor, instructed to confer with the Deputy Attorney General and report to the Board later.

The Committee further complained that there are no patrols, no police guards, that able bodied men should be compelled to work to protect food stuffs, elothing and other necessities which are being stolen by looters. There is no need of bringing men in from other towns, when food and she: ter are so scarce, when our own able bodied men are idle. Committees should be appointed to see that food and clothing are properly distributed,

The City Edicitor reports that he has held a conference with the Deputy Attorney General and that it is not

advisable to place the City under martial law. Approved.

The Committee thought that City Engineer, F. W. W. Doane, who is now overseas on active duty, should be recalled to give assistance to overtake the work of the Engineer 's department. With regard to the suggestion of recalling Mr. Doane, a vote is taken, His worship the Acting Mayor, Controllers Murphy, Hines, and Taler voting againstthe motion and Controller Finlay in favor of recalling Mr. Deane. The Acting City Engineer informes the Board that his present staff is adequate and the matter of recalling Mr. Doane is deferred for the present.

The matter of lighting the City has not been attended to and the Committee ask why steps have not been taken in this direction. The Board informs the Committee that as far as they know the lights are on in the City with the exception of those that were broken by the explosion.

The Committee ask what official steps have been taken to ascertain whether or not the City is in danger from further explosions. The Boa rd decides to confer with the Naval and Military authorities in that direction.

At the request of the Board Colonel Flowers repres-18 enting Military Headquasters appears before the Board. Colonel Flowers discusses with the Board the matter of plac ing Military guards in the City. He states that if the Chi of Police will take care of the part of the City wouth of North the Military can take care of the portion north of north street. There are now 12 mounted police guarding the devasted district and Col. Flowers informs the Board that if he were furnished with about 12 more horses it would be easier for him to overtake thewark of guarding 1 the devastated district. The Chief of Police is instructed tic to furnish the required number of horses. The Chief of an I Police later reports to the Board that permission to use 18 the horses stationed at the Remount station, at the Exhib-

Controller Hines informed the Board that on Sunday f he asked Major Willis for assistance in getting the Motor rtic Fire Engine Patricia out of the ruins and he was informed that he could not get help from that quarter. Controller Hines further reports that the new motor Fire Engine which

was on on its way to Halifax had been sent back to Foronto. He is instructed to take the necessary steps to have the engine brought back here, as soon as possible. He futher reports that a representative of the American LaFsance Fire Engine Company is in the City and that he has given him all authoirty to have the necessary repairs made to the fire engine patrician and he is informed that it will be in commission in a few days. App. .

Reports having been made to the Board that excessive charges are being made for necessities , the Deputy Mayor is ordered to public h the following proclammation in the newspapers:-

PROCLAMMATION.

It has come to the knowledge of the authorities that some persons are demanding exhorbitant prices for merchandise such as lumber, nails, glass, putty, beaver-board, roof ing paper, food stuffs, furniture and other necessities. Any person so acting will be dealt with under the provision of the law in that respect.

The Board of Control met this afternoon at 3 o'clock. presuant to adjournment, present Deputy Mayor H. S, Celwell, Controllers Hines, Finlay, Taylor and Mirphy.

Agreeably to request of the Board, Rear Admiral Chambers appears before the Board and discusses the matter of further danger from munition ships in the harbour. He states that he holds no official position under the Canadian authorities directly. He holds two positions, One Pasco Senior as Acting/British Officer. Capt. Moscow is the Senior British Officer for this port. Capt. Howes is direct officer of Patrol at preent taking charge. The admiral is also the organizing cenvoy officer and has nothing to do with the lacing of ships. He is not officially present and can only spak for himself and the British ships. The Mayor asked the admiral to whom the City will go for the desired information. The admiral replied that Capt. Howes is the man he wants and that the Mayor can get him through Capt. Elridge who is the Naval Staff Officer. The admiral informs the Meputy Mayor that if he has an official request from the City he will himself Sonfer with Capt. Howes.

The Mayor asked the admiral if he could make any statement to allay the fears of the people with regard to further explosions and if the Naval Authorities have taken any steps to prevent a similar occurence.

Rhe following resolution is adopted and ordered to

be forwarded to Rear Admiral Chambers .:-

RESOLVED that the following communication be sent to Rear Admiral Chambers by the Deputy Mayor :-

In view of the terrible Catastrophe occasioned by the explosion of a munition ship in this port, I beg on behalf of the Citizens of the city of Halifax that the Admiralty authorities will take every precaution to prevent a recurrence of any such disaster and in particular as representation have been made that the disaster was in some way due to an improper loading of cargoe upon the ship which exploded, I ask that particular attention be paid in whatever manner is

most suitable to secure that munition ships entering this port be loaded in such a manner as to prevent as far as possible any danger from explosions.

All unidentified bodies which were taken from your morgue to the Chebucto Mortuary will be your charge.

All otherwise unidentified bodies for which the City is liable will be assigned to you and to the other Undertaking Firms in proportion to respective ability to handle the business as determined by the Chairman of the Mortuary Committee.

--Suggestions offered by the Railways Con-cerning Passenger Transportation.-

The Railways have been carrying passengers into and out of Halifax without much, if any check, but now feel that in the interests of all concerned some measure of check should be established, and therefore beg to offer the following suggestions:-

INWARD: All agents and conductors to be instructed that commending December 13th, no free transportation will be issued to Halifax to relief workers, laborers or others, without proper authority issued through the railway. If the City of Halifax wish held brought in they should place their request through the Halifax City Offices of the respective lines, on form not being pre-Diffices of the respective lines, on form not being pre-pared for that purpose, and the City Ticket Agent will place such orders by size with the agent at the starting point of the workers.

OUTWARD: Commencing December 13th, no free trans-portation to be issued except upon request to the Hal-ifax Ticket Agents of the City Transportation Committee, on form [M.P.1), of the City Transportation Committee.

His worship the Mayor. Sir:-

Mr. Adams, the Town Paanning Advisor of the Commission of Conservation is in town, and has informed me that the Chairman of the Commission has instructed him to place his services at the disposal of the City should the latterrequire the same.

I consider that it is in the interests of the City to have the benefit of all the experience that can be obtained, in our endeavor to improve it, and I would recommend that the offer of the Commission be accepted, and that Mr. Adams be asked to co-operate with your City Engineer in replanning the part of the city affected by the late disaster. H. W. Johnston,

Read report Thos. Adams, Town Planning Advisor, Commission of Conservation, as follows:-

Halifax, December 14th, 1917.

Report to the Board of Control of the city of Halifax.

Gentlemen:-

-)

I came here yesterday at the request of the Executi ve of the Relief Committee and at the suggestion of the City Ingineeri - with your approval.

I desire to report to you, as the Executive body of the City Council, as follows :-

For the past year it has been part of my duty to study Halifax and neighborhood with a view to preparing study Halliax and Heighborhood with a view to preparing a series of town planning schemes for parts of the City and couty areas. These schemes were intended to deal with all the land incourse of development or likely to be developed on both sides of the Harborand round Bedford Basin. The local authorities having jurisdiction over basin. these areas, showed every desire to cooperate. At the time of the explosion, the Town Planning Boards appointed by 598

the City and County of Halifax, were waiting for my report .

The great calamity that has befallen Halifax, has brought about new conditions and has entirely changed the whole aspect of the problems we have to deal with. If, as a result of that calamity, we can get a seri us effort made to prepare a scheme of debelopment worthy of the City, if we can use the opportunity now offered, to rebuild the Northern end so as to improve the industrial facilities of the port and provide real home conditions for the working classes, we may thereby get some benefit to offset the loss sustained.

When we feflect that the death rate in Halifax from preventable disease, and particularly from the death rate of infants, meant that we were continuously wiping out the lives of hundreds of citizens - merely as a result of bad social conditions - does that not suggest that even the terrible losses in this appaling tragedy may not turn into an ultimate gain, if we can so improve the social conditions as to save as much human life in the future as has been lost in the febl blow that descended on the city a week ago?

The task is worthy of the efforts of all of us. Let us try to achieve it by action based on large-minded co-operation of all working forces.

I have made a hurried inspection of the devastated area. It is enough to show me the importance, urgency and immensity of the task to be dealt with.

I do not suggest as a first duty, the expropriation of any land. That May follow as a desirable thing after full investigation.

The first duty is to prescribe an area to the north of North Street and the upper part of Chebucto Road as an area in which no new buildings may be erected for a period of six months. Certain buildings in that area which are slightly damaged, should be repaired by the Reconstruction Committee, but outside of such reconstruction, all new building should be deferred, pending the preparation of a plan of development.

The next duty is to apply as much labor as can be spared to clearing up the debris on the debastated area, so that when Spring comes, everything will be in readiness for new development to be permitted.

Meanwhile, an organization should be set up to prepare a comprehensive plan for that part of the City, and without involving loss of time, consideration could be given in that plan to the rest of the City, and the adjacent county area. Preliminary consideration has been given to these matters already, and plans are partly prepared. Among other matters of importance that need attention are -

(1) The planning of the railway approaches and new railway development in view of the ultimate removal of the terminals to the south side, and having regard to the new conditions created by the disaster. In that matter, the Railway authorities will no coubt assist.

(2) The increase of suitable industrial sites available for the erection of factories and warehouses in proximity to the Harbor and rallways, for which opporties tjnity is provided by the demolition of buildings in the

Richmond area.

(3) The improvement of the road approaches to the City from the north and the lessening of the grades of the principal streets between the main lines of the C.G. Railway and the high ground towards the Cotton Factory area.

(4) The linking up of the existing streets, sewers and water mains with any new scheme of development so as to secure the minimum of loss to the City.

The question of precedure and organization has first to be settled Who should prepare a report on these matters, and to whom should that report be presented?

The existing authorities at the time of the disaster were the Town Paanning Boards of the city and County. The Board of the City is your sub-executive to deal with this matter. To them you should refer this question with any recommendation you care to offer as to who should be called in as their consultant. I am requested to state, on behalf of the Commission of Conservation and Sir Clifford Sitton, its Chairman, that we will be glad to co-operate in any way.

I understand that the Managing Committee and Reconstruction Committee of the Relief Committee, will cooperate and this should be heartily accepted .

But the question of planning there-development of Halifax is not a purely local matter.. It is not even a provincial - it is a question of Dominion-wide and even of Imperial importance.

The first thing to do, is to secure that all the authorities interested shall appoint someone to be primapily responsible for making a thorough investigation and survey of the area, and present a report, accompanied by a plan of re-development and recommendations regarding the organization needed to carry it out.

The statutory duties and powers of the Town Planning Board should be kept in mind, but representation on that Board of Ferera, Provincial and Relief authorities should be invited. That report should be prepared with all urgency, and meanwhile other action by Government authorities should be deferred as far as possible. A meeting of the Town Planning Board should be held at once to act upon any recommendations that you or ot her authorities may make.

It will probably be beyond the financial resourses of the City or even of the Province, to carry out an effective plan of development, without Federal aid, and therefore it will be desirable to widen the responsibility and enlarge the jurisdiction without interfering with local autonomy in regard to these matters which are best left to the sole control of the council.

I my judgment the problems to be dealt with are so important and far reaching that I think it may ultimately be necessary to appoint a small special commission representative of the Federal, Provincial and City covernments to execute the plan and control the exprnditure of funds, other than the ordinary revenues of the City, that may be available to deal with the larger problems of reconstruction.

This is a matter of policy that will have to be considered in due course, but I mention it because I wish to emphasize the need for approaching the provlems with which we are confronted from a broad national standpoint, and because I believe that the responsibility involved is much greater and wider than the citizens of Halifax can be expected to bear.

The Admiralty and Ministry of Shipping representatives in the United States and Canada, also the International Commission, whose agents in the United States and Canada control the shipment of munitions for the Allies, have received further instructions impressing the necessity of every precaution being taken both at the time of loading and in moving the loaded vessels un port, to insure the safety of the ship itself and surrounding property.

The report of the Admiral is ordered to be printed in the daily newspapers.

His Worship the Mayor stated that it is proposed to temporarily fit up a number of the school buildings, the work to be done by the Relief Committee, and he suggested that before the children be allowed to go the following schools back to them, that they be inspected by our City Engineer:- Tower Road School, Morris Street School, Le-Marchant Street School, Quinpool Road School, St. Mary's Boys' School, St. Mary's Girls's School, St. Petricks Boys' School (Common) and College St. School

HORTON AERIAL LADDER.

The Acting City Engineer informed the Board that the

Reconstruction Committee would be able to use the Horton aerial ladder for several purposes in connection with reconstruction work and would be willing to pay \$250.00 for it but no more.

The Engineer submits the following report :-

City Engineer's office, December 22nd, 1917.

His Worship the Mayor. Sir:-

We have a letter from the Reconstruction Committee asking the lowest price the City will take for the Horton ladder truck. This truck is at the City Yards at present, without any covering, and we are unable to put it in the store house owing to the latter being partly used for relief purposes.

When the truck was advertised for sale a few months ago, the highest price offered was allo. Both the controller in charge and the Chief of the Fire Department at the time recommended the acceptance of the tender, as the ladder was of absolutely no value to the Department and in their judgment was of no value as a piece of fire-fighting apparatus to any fire department. The scrap value was estimated by them to be a little less than the price offered.

If these opinions are correct as to the uselessness of this apparatus it does not seem good policy for the City to store the same, as whatever value it has at present will lessen as the years go by, besides the fact that it d does take up valuable storage room.

I would recommend that the Board fix a price on this ladder, so that it may be sold.

INVESTIGATION INTO CATASTROPHE.

WHEREAS, the recent catastrohpe to the City of Halifax was apparently due to some causes which might have been prevented, and attention to which may avert a recurrence.

AND WHEREAS, the investigation at present being conducted is apparently concerned only with the responsibility

for the collision which resulted in the explosion, which in the opinion of the public, is the least important of the contributing causes:

AND WHEREAS, it may be that an investigation into all the causes can only be properly held by a commission appointed by the Federal or even the Imperial Government;

THEREFORE RESOLVED, that this Board request the Dominion Government to take such steps as are necessary to fully ascertain all the causes of the disaster and also what measures should be taken to prevent a recurrence.

The resolution is unanimously adopted and a copy ordered to be forwarded to Sir Robert L. Borden and copies delivered to the Cabinet Ministers who are expected to arrive in the City tomorrow.

SAFETY TO SHIPPING.

INFECTIOUS DISEASES HOSPITALS.
