# Halifax man gets conditional discharge for Calgary assault

A Calgary judge just handed a Halifax man a conditional discharge and two years of probation for a brutal and prolonged assault on his former girlfriend that the assailant called "the worst thing he had ever done."

Arthur Thomas Caines, 35, pleaded guilty to assault causing bodily harm in the June 2020 attack that started after he and his former partner – identified only by the initials S.M. – attended a drinking party with mutual friends.

"Mr. Caines left the party without S.M., who returned to their residence at about 2:30 am. An argument ensued between the two of them and Mr. Caines told his girlfriend she was no longer welcome in the home," Alberta provincial court Judge Gregory Stirling said in his written decision.

"At one point, S.M. went to the bathroom. Mr. Caines followed S.M. and broke down the bathroom door and began assaulting S.M. The assault included repeated punches to S.M.'s face and head with a closed fist. Mr. Caines also grabbed S.M. and smashed her head into the toilet and countertop in the bathroom. S.M. was then taken into a bedroom where Mr. Caines continued to punch her repeatedly."

The woman didn't lose "consciousness but became dizzy and confused and she was extremely fearful for her life," said the judge.

"She told police that during the assault, Mr. Caines said he was going to kill her."

She was eventually able to break free and ran out of the house's front door barefoot.

"Mr. Caines chased her down the street. S.M. was able to get to a neighbour, who called 911."

When police arrived "they observed significant swelling to both sides of S.M.'s face as well as bruising under her left eye. Both of her eye sockets were very swollen. S.M. was seen by EMS on the scene diploma," said the judge. "He is now taking a construction management program at Nova Scotia Community College."

He is currently unemployed, Stirling said.

Caines "has no significant mental health issues although he felt very 'dark and sad' with the stillbirth of his child and he expresses regret for his conduct towards S.M.," said the judge.

Caines testified that he "has very little recollection of the events," Stirling said. "He and S.M. had consumed alcohol. He said he is distraught over his actions and feels remorse

and guilt for his assault of S.M."

He completed an anger management and emotional intelligence program with the John Howard Society. At the sentencing, "Caines expressed remorse for his conduct, describing it as the worst thing he had ever done," said the judge.

His ex-girlfriend told the court she didn't want Caines jailed. "Her wish was that he attend counselling for alcohol addiction and for domestic violence," Stirling said.

The woman was beaten "repeatedly in her home by her boyfriend in circumstances where she indicated she felt she was going to die and she had to escape in bare feet and run for safety," said the judge. "In view of the seriousness of the offence, and the high moral blameworthiness of Mr. Caines, such conduct should be a matter of public record."

The judge said the loss of his son four days before the baby's due date – and a year before the assault -- was a mitigating factor. "This was a devastating loss for Mr. Caines. He entered into a dark period and the defence argues the assault was out of character for him."

He counted the guilty plea and remorse as mitigating factors.

The judge did not impose the weapons ban the Crown was seeking.

Photographs from the time show "extensive bruising to S.M.'s lip, both eyes, the side of her forehead, the inside of her upper arm and two bruises on her waist," Stirling said.

The Crown asked for a sixmonth conditional sentence, followed by 12 months of probation, and a five-year weapons ban.

Caines' lawyer wanted a conditional discharge with a year of probation.

Caines "currently lives in Halifax, Nova Scotia," said the judge. "He is not married and has no children. The Crown does not allege a prior criminal record."

Caines was born in Newfoundland and remained there until he turned 19.

"He had an active childhood and was involved in a number of sports," said the judge. "He was not exposed to any violence or form of abuse in the home. He has some resentment towards his mother for her critical nature and the way that she treated his father. He described living in the home as 'walking on eggshells.""

He'd been in a relationship for three years with the woman he assaulted.

"He described the relationship as having ups and downs with alcohol consumption likely contributing to some of the difficulties," Stirling said. "In July 2019 their child was stillborn. He said this event had an impact on their relationship and their lives 'in every way possible.""
