B.C. agency to probe police treatment of Assoun

A civilian-led police oversight agency in British Columbia is going to investigate how the police handled the case against Glen Assoun, who was wrongfully convicted of murder in 1999.

The Independent Investigations Office (IIO) of B.C., led by Ronald J. MacDonald, former director of the Nova Scotia Serious Incident Response Team, will conduct the investigation into whether there was criminal misconduct by police before Assoun's conviction in the 1995 killing of Brenda Way.

SIRT director Felix Cacchi-one asked the IIO to conduct the probe.

"On March 8, an Order

in Council endorsed an IIO inquiry into allegations that the RCMP in Nova Scotia inappropriately destroyed evidence, which was used in the 1999 wrongful murder conviction of Glen Assoun," a news release issued Thursday said. "The investigation will also examine whether any member of the Halifax Regional Police committed any offence related to this conviction."

The release said the investigation will begin "in the near future" and will include deployment to Nova Scotia as

necessary.

"The IIO utilizes a 'start from zero' approach, drawing no conclusions regarding the outcome of an investigation while working to gather all available evidence," the news release said. "The chief civilian director will then review the evidence and, applying relevant legal principles, will determine whether reasonable grounds exist to believe that an officer may have committed an offence."

The IIO findings will be reported transparently at the conclusion of the investigation.

Accused released on conditions

SYDNEY — A man has been charged with weapon offences in connection with a series of incidents during which shots were fired at a residence on Dorchester Street in Glace Bay.

Gerald Dennis Roberts, 63, of Dorchester Street is charged with carrying a weapon (a gun) dangerous to public peace, careless storage of weapon and mischief by endangering life relating to a damaged roof to another home on the street.

The offences are alleged to have occurred between January and March.

Cape Breton Regional Police have been investigating reports of shots fired resulting in property damage to a vehicle and home. Officers were called to the neighbourhood several times in recent months.

Roberts was arrested earlier this week at his home and was released on conditions Friday.

Among the conditions, Roberts is to live at a residence on Quarry Road and have no contact with three people. He is not to possess weapons or be in any residence where weapons are available.

He is to surrender all firearm certificates to police and refrain from alcohol and drugs not prescribed him.

Roberts is also to stay away from Dorchester Street and abide by a curfew.

He is now scheduled back in provincial court April 26 to enter pleas.
