Mr. Regan advised he attended the Lucasville Trail Group meeting. They are trying to get organized to build a trail along Lucasville Road. He further announced that Jessie Debaie, HRM Asst. Trails Coordinator, is retiring and suggested the Chair send a letter of appreciation to her on behalf of the committee, to which the Chair agreed.

In response to a question by Mr. Regan as to whether the Committee had ever received a speaker from the Green Network, the Chair advised it did not; and he would follow up on this matter.

Ms. Dobson inquired about a SHIFT event on February 2, 2017. Ms. Lane advised it is a Pecha Kucha event which is a kick-off event and a fundraiser for the annual SHIFT conference. More detail can be located at the Dalhousie Planning Conference website.

Ms. Lane advised that the Winter Bicycle Week is kicking off on February 10, 2017. It is still open for groups who wish to participate. Currently, there are 13 groups that are involved in suppling rides or discounts or vendors. She thanked Halifax Bike Week for their support in putting this on.

# 7.3.1 Centre Plan – Elora Wilkinson, Planner II, HRM

Ms. Wilkinson provided a Draft Centre Plan Update to the Active Transportation Advisory Committee. The Centre Plan is a municipal planning strategy for Regional Centre, described as Halifax Peninsula and Dartmouth within the Circumferential Highway. The goal of the plan is to direct future growth in this area in a way that is comprehensive and that looks not just at land use but also starts to think about the effects of land use

In her remarks, Ms. Wilkinson noted that the results of public engagement synthesized into four "What We've Heard" reports. She added that these documents are an analysis and summary of what staff have heard and how they use it to influence the plan.

Relating to Active Transportation, she highlighted the following:

#### Four Core Concepts:

- Complete Communities
- Human Scale
- Pedestrians
- Strategic Urban Structure Map

#### **Urban Structure:**

- Established Residential Communities
- Downtowns
- Centres
- Corridors
- Future Growth Nodes
- Employment Lands

With regard to Active Transportation, Ms. Wilkinson further noted three policy directives for the mobility section of the Centre Plan:

- 2.2.2 a Complete Streets
- 2.2.4 b Active Transportation
- 2.2.5 d New Connections through Larger Blocks

In concluding her presentation, she advised that staff intend to take an updated plan to Community Design Advisory Committee next month. Ms. Wilkinson ended her presentation and asked for any questions. A discussion ensued with Ms. Wilkinson and Mr. Ritchie responding the questions.

The Chair thanked Ms. Wilkinson for her presentation and information.

#### 8. REPORTS/DISCUSSION

#### 8.1 COMMITTEE MEMBER UPDATES

Ms. Dodson noted concern about the term "complete streets" and the need for a clear definition on what constitutes a complete street. A brief discussion ensured. Mr. MacIsaac pointed out the Centre Plan is working to address those concerns.

# 8.2 STAFF UPDATES

#### Mr. MacIsaac commented on:

# Complete projects:

- Devonshire Bike Lane completed; signs coming soon
- Greenway connecting St. Margaret's Bay Rd. into Chain of Lakes
- Finished greenway on Dartmouth harbour front
- Bissett Lake greenway now complete
- Paved shoulders on Cole Harbour Road (paved and painted)

# Planning projects underway:

- South Park bike lane and enhancement
- Forrest Hills Parkway
- McDonald Bridge Bikeway
- · Redesign options for Chebucto, Cunard, and Windsor streets

# Mr. MacIsaac provided further updates to advise:

- They are looking at a plan for next year on backlog of projects not completed last year and putting finishing touches on next year's capital budget.
- The Hwy 107 extension may happen. Looking to extend from Akerley to Bedford/Lower Sackville with an Active Transportation greenway built along side of it (7 kms).
- Starting to plan Bike Week 2017 soon.
- Trans-Canada Trail report coming to TSC next Thursday giving staff the direction to work with that Trans-Canada Trails group.

Councillor Mason left the meeting at 5:07 p.m. The Chair thanked him for his work on the committee

Ms. Dodson asked about the Cogswell intersection demolition and whether there is a plan around this in regard to pedestrians. The Chair advised he will follow up and ask for an update on any interim provisions for pedestrians.

The Chair advised he received a request through Halifax Regional Trails Association. There has been a fair amount of discussion among trail managers relating to complaints from trail users about cyclists passing too fast with no bell use. HRTA has indicated this is one of the biggest user complaint issues. They wanted to suggest the creation of a by-law which would require cyclists to use a bell when riding on a trail and passing pedestrians. They have approached the Active Transportation Advisory Committee to begin a conversation with the Municipality. They are possibly looking to advocate for some kind of regulation through a municipal by-law.

Through committee discussion on this matter, it was noted that the Motor Vehicle Act only requires the bell, but there is no regulation to indicate it must be used. The Chair asked Mr. MacIsaac if it is possible to move forward with this topic. Mr. MacIsaac noted that this is something that needs more time and, currently, there isn't the staff resources to investigate best practices in other jurisdictions.

The Chair agreed to take back some comments on this general discussion and would suggest to HRTA that, if they wished, they could present to this Committee.
