Chief Blais responded to questions from members, noting the following:

- Information Item No. 2 Bimonthly Strategic Plan Update provides further information which feeds into the Business Plan Deliverables.
- Recruitment of a Chief Information Security Officer has been challenging.
- The recent retirement turnover has triggered promotions, and HRP are catching up on filling positions.
- Work is ongoing with regard to opioid use strategy and cannabis strategy.

Commissioner McDougall requested that members be provided with a list of acronyms used by HRP and RCMP. The Chief indicated that this will be circulated to members.

Commissioner Mason indicated that these conversations are already taking place Nationally and in Nova Scotia and it would be appropriate to have the Board formally endorse this direction.

# 9.3.2 Updates from the Nova Scotia Chiefs of Police Association & Nova Scotia Association of Police Governance 2017 Fall Conference – Pictou – September 27 – 29, 2017

Commissioner Graham and Deputy Chief McNeil provided a follow up on the Nova Scotia Chiefs of Police Association & Nova Scotia Association of Police Governance 2017 Fall Conference.

#### 9.4 HRP/RCMP CHIEF UPDATES

Chief Jean-Michel Blais, Halifax Regional Police, provided updates beyond what was included in the Information Item No. 3 - Information Report – Chief of Halifax Regional Police dated October 16, 2017, noting the following:

- Review of section 163(1) of the Motor Vehicle Act on stunting, which states "Any person who
  operates a motor vehicle on a highway in a race, in a contest, while performing a stunt or on a bet
  or wager shall be guilty of an offence" which can lead to a \$2242 fine, loss of points and seizure
  of vehicle.
- The new Wellness Coordinator, Melanie Bower, has been hired and will be presenting to the Board in December.
- Updates on the Drug Exhibit Audit will be provided to the Board in November and December, with the completing report scheduled for January 2018.

Responding to a question about the status of the formation of the Halifax Regional Police Foundation, Chief Blais advised that the foundation is set up, a volunteer board will be arranged, and communications will go out.

Responding to a question about traffic noise, Chief Blais advised that HRP are working with the Transportation Standing Committee to put forward a request to the Minister of Transportation for changes to the Motor Vehicle Act with regard to excessive vehicle noise.

Chief Superintendent Lee Bergerman, Halifax District Detachment, RCMP, provided updates beyond what was included in the Information Item No. 4 - Information Report – Officer in Charge Halifax District RCMP dated October 16, 2017, noting the following:

- Officers have received IARD (Immediate Action Rapid Deployment) training for active shooter situations.
- A harm reduction policy has been prepared for consistent deployment in reporting of naloxone use.
- Education is underway on motor vehicle "stunting".
- The Director of Finance for the Department of Justice will be attending the December Board meeting to provide further information to the Board on the RCMP H Division Budget.
