9.1 2018 Heritage Advisory Committee meeting schedule

10. MOTIONS

10.1 Request to Present – Elizabeth Pacey re: Case 20923: 2720 Gottingen Street, Halifax – The Narrows: A Halifax Public House

The following was before the Committee:

• Correspondence from David Wallbridge, Pink Larkin, dated August 8, 2017

Aaron Murnaghan, Principle Planner, Heritage, advised that a request was made by Elizabeth Pacey through her solicitor, David Wallbridge, to address the Heritage Advisory Committee when an application comes forward for recommendation to Community Council on Case 20923: 2720 Gottingen Street, Halifax – The Narrows: A Halifax Public House. It was noted that Ms. Pacey is a neighbouring property owner to the subject property.

Aaron Murnaghan reviewed the current status and next steps of the subject application, noting that a public information meeting has been held, and the matter was before the Halifax Peninsula Planning Advisory Committee. The Heritage Advisory Committee will be presented with the report on this matter within the next few months for recommendation to Halifax and West Community Council, followed by a public hearing.

The Committee discussed the request, with staff clarifying that proponents, residents, and organizations have been given the opportunity to address matters at the committee level in the past, with a time limit of five or ten minutes being proposed.

Staff clarified that the matter will be brought before the Heritage Advisory Committee for consideration of whether this would be a suitable use as a heritage property, and that any comments on the application should be limited to that. Staff further clarified that should the applicant, or any other neighbouring property owners, also wish to have an opportunity to address the Committee on this matter, then the same process of submitting a request to speak would be brought forward to the Committee for consideration on an individual basis.

The Committee discussed requesting Elizabeth Pacey to instead provide a written submission for consideration by the Committee, and encouraging Elizabeth Pacey to speak during the public hearing.

Staff clarified that all correspondence addressed to the Heritage Advisory Committee on this matter will be circulated to members.

MOVED by Janet Morris, seconded by Dylan Ames

THAT the Heritage Advisory Committee approve a request by Elizabeth Pacey to address the Committee with regard to Case 20923: 2720 Gottingen Street, Halifax – The Narrows: A Halifax Public House, when the matter comes forward to the Heritage Advisory Committee for recommendation to Halifax and West Community Council.

10.2 William Breckenridge - Heritage Conservation Districts

William Breckenridge addressed the Committee, expressing concern with the length of time it has taken to complete the Old South Suburb and Schmidtville Heritage Conservation Districts. He suggested with the increased staffing in the Heritage department that a two-year time frame for completion of future heritage conservation districts may be possible.

MOVED by William Breckenridge, seconded by Councillor Hendsbee

THAT the Heritage Advisory Committee recommend that the Community Planning and Economic Development Standing Committee request a staff report examining the possibility of requesting the Chief Administrative Officer to direct staff to:

- 1. expedite the Old South Suburb and Schmidtville Heritage Conservation District (HCD) plans to be presented to the Heritage Advisory Committee and Halifax Regional Council before January 2, 2018: and
- 2. explore a two-year time frame of completion for any future Heritage Conservation Districts.

Kurt Pyle, Acting Manager, Heritage Planning, noted that the proposed time frame of January 2, 2018 would not work procedurally. Kurt Pyle indicated that work is being realigned internally to speed up the process and work toward completion of the two proposed heritage conservation districts. Staff are working to deliver the Schmidtville Heritage Conservation District report for the February 24, 2018 Heritage Advisory Committee meeting, and the Old South Suburb Heritage Conservation District report is about six months out. Staff clarified that the proposed motion will add extra work to heritage planning staff workload and may delay things further.

The Committee further discussed with staff the challenges encountered with the creation of the heritage conservation districts, and efforts that are being made to move them forward. Staff advised that following completion, a review of the timeframe and lessons learned will be undertaken to make improvements to the process for future Heritage Conservation Districts.
