# 9.1 Case H00454: Request to Include the United Memorial Church, 5375 Kaye Street, Halifax in the Registry of Heritage Property for the Halifax Regional Municipality

The following was before the Committee:

- Staff Recommendation Report dated January 5, 2018; and
- Correspondence dated January 18, 2018.

Kathleen Fralic, HRM Heritage Planner, presented to the Committee on the property located at 5375 Kaye Street, Halifax. They additionally provided members of the Committee with a brief overview of the evaluation criteria for registration of heritage buildings.

William Breckenridge noted to the Committee that they would be abstaining from the ensuing discussion and scoring of the subject property, as well as abstaining from any motions resulting therefrom, due to a conflict of interest.

Councillor Hendsbee joined the meeting at 3:20 p.m.

The Committee proceeded to score the subject property against the evaluation criteria provided, resulting in the following scores:

- **1. Age of the Property** In accordance with the evaluation criteria, the Committee agreed upon a score of 5.
- 2a. Relationship to Important Occasions, Institutions, Personages or Groups The Committee noted that the property in question had a moderate relationship to the Halifax Explosion. On the basis of their evaluation, the Committee agreed upon a score of 15.
- **3. Significance of Architecture/Building –** The Committee took note of the architect, Andre Cobb. On the basis of their evaluation, the Committee agreed upon a score of 5.
- 4a. Architectural Merit Construction Type/Building Technology The Committee noted that the building in question is a relatively common example. On the basis of their evaluation, the Committee agreed upon a score of 3.
- **4b.** Architectural Merit Style The Committee noted that the building in question reflects a shift in the area towards a more modern style of architecture following the Halifax Explosion. The Committee additionally noted the building's distinctive features. On the basis of this evaluation, the Committee agreed upon a score of 5.
- **5. Architectural Integrity –** The Committee took note that there have been alterations to the building since its construction, agreeing that these alterations can be considered modest in nature. On the basis of this evaluation, the Committee agreed upon a score of 8.
- 6. Relationship to Surrounding Area The Committee noted that the neighbourhood in question had already lost a historic church. On the basis of their evaluation, the Committee agreed upon a score of 10.
- **Total** Based on the assessment of the evaluation criteria, the Committee gave the property in question a cumulative score of 51, out of a possible total score of 100.

Aaron Murnaghan, HRM Principle Planner, noted that there is an error in the report at page 7. Specifically, the report speaks to the adjacency of the property in question to another registered heritage property, citing implications resulting from this under policy CH-16 of the *Regional Municipality Planning Strategy*. As Aaron noted, this is an error, as the registered heritage property is actually across the street from the property in question.

THAT the Heritage Advisory Committee recommend that Regional Council:

- 1. Set a date for a heritage hearing to consider the inclusion of the subject property in the registry of heritage property for the Halifax Regional Municipality; and
- 2. Approve the request to include 5375 Kaye Street in the registry of heritage property for the Halifax Regional Municipality, as shown on Map 1, as a municipal heritage property.
