The meeting was called to order at 6:35 p.m., and the Committee adjourned at 7:59 p.m.

11.1 STAFF

11.1.1 Staff Presentation - Committee Orientation

Krista Vining responded to questions raised by the Committee.

Presenting staff clarified that current vacancies in committee membership roles may apply through the Office of the Municipality to join the Committee. The two current vacancies are public trails, and ecological sciences. The Chair suggested members speak to people they know who may be interested in submitting an application for the vacant positions.

11.1.2 Staff Memorandum - Update on Nichols Lake Trail

The following was before Western Common Advisory Committee:

A staff memorandum dated January 16, 2018

Gareth Evans, Recreational Planning Specialist shared that since August of 2017, 1000 meters of train have been completed as per tender 17-010 Nichols Lake Trail Phase 2, and provided information as to the state of the budget, and further grubbing and clearing work.

The Committee requested information be provided for their next meeting on the financial state of the project and what funds, if any remain.

Gareth Evans shared that there is an unresolved question as to a proposed water crossing which is likely to be resolved following the clearing and grubbing in the area, and would benefit from the perspective of a committee member with ecological science expertise.

Gareth Evans advised that staff is considering facilitating temporary construction access to McDonald Lake Drive for a western branch of the Trail, possibly through a temporary road. Members suggested that this would likely to be a topic of interest and concern to local residents. Gareth Evans projected having further details on this issue in early March.

- 12.1 Tom Musial Clarification of Halifax & West Community Council July 25, 2018 motion, Item 4.1 respecting bicycles on the barrier-free training in the Western Common Regional Park

Tom Musial sought clarification on a motion passed by Halifax & West Community Council on July 25, 2017, Item 4.1 Submission during Public Participation - May 30, 2017 – Bicycles on the barrier-free trails in the Western Commons Regional Park.

Staff clarified the procedural history of a community member presentation by John Cascaden to Halifax and West Community Council and clarified that all requested meetings and follow ups indicated in the minutes had occurred in the proper committees. Gareth Evans, Reactional Planning Specialist further confirmed that they had follow up and spoke to this matter at the Western Common Advisory Committee's September 27, 2017 meeting.

Several committee members sought to clarify information about the trail width, particularly as it related to barrier-free trails and entranceways to the park.

MOVED by Tom Musial

THAT the Western Common Advisory Committee re-examine the Wilderness Common Master Plan for trail development in the Wilderness Common Park to determine what sites are of significance within the park relating to trail access and existing trail networks.

Discussion was held with a suggestion being made that the Committee ask staff to provide information for their next meeting on the reasoning for choosing six feet wide trails over ten feet. Gareth Evans noted that the largest trials, being constructed as per the Western Common Wilderness Common Master Plan, would be barrier-free trails, however some wider pre-existing trails are identified in the Plan's maps. Gareth clarified that restricting the trail width of trails to be constructed to that of barrier-free trails was consistent with the Plan's goal to maintain and embrace a wilderness experience with minimal interference to the park environment. **There being no seconder**, and in consideration of staff providing information at the next meeting around the rationale for 6-foot-wide trail widths, **Tom Musial withdrew the motion**.

13. PUBLIC PARTICIPATION

Amy Hockin, Prospect Village, wanted to see further bicycle access into the Wilderness Commons Park. She stated that as a cycle trainer, she finds it difficult to gain access, and risky to cycle on the roads to the entryways. She was concerned about the lack of public transportation to the Park's entry points.
