The meeting was called to order at 12:32 p.m., and the Board moved into an In Camera (In Private) session at 12:57 p.m. The Board reconvened to the public session at 1:06 p.m. and adjourned at 1:07 p.m.

4. Halifax District Funding Request – Regular Member Resource - Original Report & Addendum – Inspector Robert Doyle, Halifax District Detachment, RCMP

The following was before the Board:

• Report titled "Halifax District Funding Request - Regular Member Resources" dated January 15, 2018, with addendum dated January 29, 2018.

Inspector Robert Doyle, RCMP, Halifax District Detachment, provided the Board with the following updated information as it relates to the RCMP, Halifax District Detachment's funding request:

- The RCMP, Halifax District Detachment, does not see utilizing civilian staff to replace school
  resourcing officers as a viable option to reduce operational pressures, due to the policing
  expertise required for the role.
- Speaking to the impact that a failure to grant the additional funding would have on the RCMP,
  Halifax District Detachment's operations, it was noted that the level of police services would likely
  be negatively impacted. One example cited is that school resourcing officers may have to be
  reassigned to meet operational pressures.
- Additional officers would have a positive impact on overtime both in terms of the RCMP, Halifax District Detachment's budget, as well as the wellbeing of its regular members.
- With regards to police resource sharing with other jurisdictions, it was noted that this would be
  more of a short-term remedy that would not provide a realistic long-term solution for meeting
  operational needs.
- If the request for additional officers were granted, then these additional resources would realistically see implementation beginning in late 2018.
- Inspector Robert Doyle noted the current and anticipated operational pressures leading the RCMP, Halifax District Detachment to make the request. Specifically, they cited increased mental health service calls, increased cybercrime, the growing opioid crisis, and the impending legalization of cannabis.

MOVED by Commissioner Mancini, seconded by Commissioner McDougall

THAT the Board of Police Commissioners add the requested increase of six officers for the RCMP, Halifax District Detachment, as set out in the report dated January 15, 2018, for inclusion in the proposed 18/19 budget.

Jacques Dubé, Chief Administrative Officer, clarified that the motion before the Board is to add the RCMP, Halifax District Detachment's request for an additional six officers to the proposed budget being forwarded to Regional Council for approval. The motion does not in itself approve the addition of \$877,890 to the proposed budget. As the report before the Board implies a phased-in approach to the implementation of these funding requests, it would not be an addition of \$877,890 as outlined in the said report. Rather, approximately ¼ of that amount would be added to the budget for 2018/2019, as the actual implementation of the requests would not take effect until late in 2018.
