THAT the Regional Watersheds Advisory Board recommends that the Environment & Sustainability Standing Committee recommend that staff be directed to review the Regional Watersheds Advisory Board's Terms of Reference and mandate.

The Board discussed their mandate and composition. The Board noted an opportunity to use their knowledge and expertise to advise the Environment and Sustainability Standing Committee (ESSC) on more extensive water relate matters. Currently their mandate limits the Board to only providing advice

when directed by ESSC or staff initiated. The Board considered the following:

Proposed changes to the Board's purpose:

- Ability to advise on solid waste management issues (e.g. if a composting or waste facility were to be built near a watershed)
- Having the ability to advise on joint projects between HRM and Halifax Water
- Having ESSC provide a yearly work plan to RWAB
- Have a mechanism to be able to bring municipal water related issues that represent the public
 interest to the attention of ESSC and highlight concerns at the earliest stage for possible policy
 and planning considerations (e.g. land based issue such as winter road maintenance operations,
 or beach and lake water quality testing)

Proposed changes to the Board's composition:

- Have representation from a member of Halifax Regional Council
- Replace the word 'NGO' with Environmental Community Group as a more friendly terminology
- Have formal mechanisms to receive feedback from the outcomes of the recommendation made by the Regional Watersheds Advisory Board

The motion and formulation of directives were deferred to the next meeting.
