7.3.1 Case 20923 – Application for a Development Agreement, 2720 Gottingen Street, Halifax – Elizabeth Pacey

The following was before the Committee:

Correspondence from David Wallbridge dated August 18, 2017

Elizabeth Pacey spoke to members of the Committee regarding Case 20923 and the proposed development agreement for 2720 Gottingen Street. They provided the Committee with an overview of the history of the property, and outlined their concerns with the initial proposals. They further indicated that they were now in support of the proposed development agreement as set out in the staff report.

Myles Baldwin spoke to members of the Committee regarding Case 20923 and the proposed development agreement for 2720 Gottingen Street. Baldwin outlined the restoration work that has been completed on the property to date, as well as their future plans for the property. They noted that they were able to consult with HRM staff to revise their plans for the property to be more in line with policy 6.8 of the Municipal Planning Strategy, which is reflected in the proposed development agreement before the Committee.

THAT the Heritage Advisory Committee recommend that Halifax and West Community Council:

- Give notice to consider the proposed development agreement, as set out in Attachment A
 of this report, to allow a restaurant, pub and residential units within the existing building
 located at 2720 Gottingen Street;
- 2. Approve the proposed development agreement, which shall be substantially of the same form as set out in Attachment A of this report; and
- 3. Require the agreement to be signed by the property owner within 120 days or longer if warranted, or any extension thereof granted by Council on request of the property owner, from the date of final approval by Council and any other bodies as necessary, including applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.
