### 10.1.1 Presentation by Infrastructure Planning on the Flood Risk Assessment Study

Yusuf Habboushand, Program Engineer, Planning & Development and Paul Burgess, Program Manager, Infrastructure Policy & Standards, presented the Flood Risk Assessment Study for the National Disaster Mitigation Program (NDMP). Staff gave an overview of the origin of the study and its objectives, as well as the criteria and methodology used. Staff used the example of Sackville Rivers to demonstrate how they calculated risk and a mitigation strategy. They also explained their recommendations to Council and next steps.

The following points were noted:

- Coordination with Emergency Measures and establishing emergency centres
- Infrastructure and evacuation plans and further study required
- There will be a joint plan with Halifax Water and others to address identified sites not on the shortlist
- The focus of the study was public infrastructure and evacuation routes for the public

- The NDMP study began in 2017 and is an opportunity for community engagement and public workshops
- Pending Council approval, an implementation plan will be ready for the Fall
- Additional sites are not excluded in the future
- Staff recommends presenting an inventory of sites to Council instead of a priority list
