9.1 HRM Boards and Committees Orientation

The following was before the Committee:

Aaron Murnaghan, Principle Planner, and Kathleen Fralic, Heritage Planner, provided the Committee with a presentation on the responsibilities and heritage related mandate of the Heritage Advisory Committee.

9.2 Case 20928: Development Agreement for 5720-5722 Inglis Street, Halifax

The following was before the Committee:

- A staff presentation on Case 20928

Kathleen Fralic, Planner II, provided the Committee with a presentation on Case 20928 - Development Agreement for 5720-5722 Inglis Street, Halifax. Fralic noted that Attachments B and C were missing from the report, and reviewed the missing items with members of the Committee.

MOVED by Jennifer Clarke-Hines, seconded by Lois Yorke

THAT the Heritage Advisory Committee recommend that Halifax and West Community Council:

- 1. Give notice of motion to consider the proposed development agreement, as set out in Attachment A of the staff report dated December 20, 2018, to allow a twelve unit residential building located at 5720-5722 Inglis Street and schedule a public hearing;
- 2. Approve the proposed development agreement, which shall be substantially of the same form as set out in Attachment A of the staff report dated December 20, 2018; and
- 3. Require the agreement be signed by the property owner within 120 days, or any extension thereof granted by Council on request of the property owner, from the date of final approval by Council and any other bodies as necessary, including applicable appeal periods, whichever is later; otherwise this approval will be void and obligations arising hereunder shall be at an end.

9.3 Case H00437: Strategy for the Protection of Potential Heritage Resources in Downtown Halifax (Map 6)

The following was before the Committee:

- A staff presentation on Case H00437

Seamus McGreal, Planner III, Heritage Planning, provided the Committee with a presentation on Case H00437: Strategy for the Protection of Potential Heritage Resources in Downtown Halifax (Map 6).

Responding to questions from members of the Committee, McGreal and Murnaghan noted that under the staff recommendation, staff would quickly work to research potential heritage resources and apply for heritage registration as appropriate. It would then be up to Regional Council on whether to register each property.

MOVED by Lois Yorke, seconded by Councillor Austin

THAT the Heritage Advisory Committee recommend that Halifax Regional Council:

- 1. Initiate a process to evaluate existing potential heritage properties identified in Attachment D of the staff report dated December 28, 2018 under the HRM Evaluation Criteria for registered heritage properties under H-200, the Heritage Property By-law;
- Initiate a background study for the Historic Properties Heritage Conservation District that will consider additional potential heritage resources identified in Attachment D of the staff report dated December 28, 2018 within a boundary that is contiguous with the area identified in Attachment B of the staff report dated December 28, 2018, as Historic Properties; and
- 3. Direct staff to prepare a program, including financial and land use incentives, for registered heritage properties located in Downtown Halifax, outside of Heritage Conservation Districts, for Council's consideration.

William Breckenridge expressed concern that some buildings were not reflected in Map 6. Staff requested that Committee members follow up with them to identify any buildings which have been excluded, which will subsequently be communicated to Regional Council when the matter comes forward.
