### 10.1.1 Regional Centre Secondary Municipal Planning Strategy and Land Use By-law

The following was before the Committee:

- Staff report dated April 3, 2019
- Correspondence from Peggy Cameron and Howard Epstein

Ross Grant, Planner I, outlined the purpose and targets of the Centre Plan, and the data and collection of studies that helped to inform it. Grant briefly explained the legislative process for the Centre Plan's adoption, and listed the various engagement initiatives, such as pop-ups, surveys, and walking tours. Grant reiterated the core concepts of complete communities, human scale, pedestrian first, and strategic growth. Staff spoke to the general policies of heritage conservation districts, cultural landscapes,

affordable housing, incentive or bonus zoning and landscaping. The presentation also covered urban structure, site plan approval, built form, performance standards, design requirements, Dartmouth plan amendments and transitioning to the Centre Plan. Staff concluded the presentation with their recommendation to the committee. A copy of the presentation is on file.

The Committee discussed the Plan with staff responding to questions. Staff explained that the grant components for density bonusing are included in the Centre Plan, and that it would come as a separate administrative order. In response to a question around transitions, staff stated that there are a number of tools recommended to ease transition, including landscaping. Staff additionally clarified that height was measured in meters and not storeys in the Plan. Members asked what impact the Centre Plan would have on the Halifax Peninsula Planning Advisory Committee. Staff advised that any changes to the board and committee structure would come in the form of a future governance report to Council.

The Committee discussed the powers of the development office appointed by Council and asked staff to confirm that the Halifax Common will be included in Package B of the Centre Plan. The Committee sought clarity around the difference between work living space and a home office, and adult entertainment and arcades in terms of land use by-laws.

THAT the Halifax Peninsula Planning Advisory Committee defer item 10.1.1 Regional Centre Secondary Municipal Planning Strategy and Land Use By-law and schedule a special meeting prior to the next meeting to conclude the matter.
