9. REPORTS 9.1 STAFF 9.1.1 Staff Presentation – Administrative Order on Future Roles and Responsibilities of Community Trails Associations with Respect to Active Transportation Facilities

The Vice Chair invited Emma Martin, Active Transportation Community Programs Coordinator, Project Planning & Design Services, to take the floor.

A copy of the staff presentation is on file.

Martin explained that the objective of the presentation is to present the project plan and to receive feedback from the Committee with respect to making trails more accessible. An Administrative Order is being developed for Council's consideration that updates the roles and responsibilities of community trails associations and establishes a Municipal grants program to support the work of these associations. The biggest stakeholder is Halifax Regional Trails Association (HRTA) which meets monthly. Martin noted that there have been 119 kms of trails built since 1999 with the majority being on provincial land and that recreational trails differ from active transportation trails as active transportation trails connect destinations.

Martin explained that there is a lack of clear responsibility between what trails supporters should do and what HRM should do. It is hoped that these roles will be clarified through the Administrative Order which should be in place by September of 2020.

Members responded to the presentation. The following points and clarification were noted:

- Members suggested putting an "A" at the trailhead, so people would know its accessible
- The Committee suggested reviewing and comparing criteria from other jurisdictions that have accessible trails
- Members noted that using all terrain vehicles (ATVs) can reduce accessibility on trails
- Railings on bridges and clear signage were mentioned as ways to assist with accessible needs

Members questioned whether trails are paved or not. Martin indicated that some trails are paved and some have crusher dust and that they are currently identifying issues with the use of ATVs on trails but not sure there is a lot they can do since the Province owns the majority of the land.

9.1.2 Staff Presentation – Dutch Village Road Complete Streets Project

The Chair invited Leen Romaneh, Transportation Planner, Strategic Transportation Planning, to take the floor.

A copy of the staff presentation is on file.

Leen Romaneh advised that engagement is taking place with stakeholders and that it is still early in process. They further stated that Dutch Village Road has been identified as a candidate bicycle route, that there are no sidewalks on west side of the street and that a lot of the existing parking spots are encroaching in the right of way. Further, that approximately 16,000 cars use Dutch Village Road per day and there are only two bus routes servicing the street with no new routes being proposed in the Moving Forward Together Plan.

Romaneh explained that sidewalks, curbs and a raised protected bike lane are being proposed for both sides of the street and the process has started for acquiring properties that will be needed.

Romaneh confirmed they are monitoring similar projects for ideas.

It was noted that sometimes bike lanes affect accessibility with respect to parking and bus stops.

The Chair invited Melissa Myers, Accessibility Advisor, to take the floor.

Melissa Myers stated that they are hoping to present the Accessibility Strategy to Council in the New Year and confirmed that it has been presented to the HRM Business Units.
