9.1.1 Design Review Committee Orientation

Judith Ng'ethe, Legislative Assistant, took the floor to give the Committee orientation. Ng'ethe outlined the role of the Chair and the Legislative Assistant. Attention was drawn to the *Municipal Conflict of Interest Act* which applies to Regional Council and its Boards and Committees.

Carl Purvis, Planning Applications Manager, took the floor.

Purvis explained that the purpose of Design Review Committee is to administer the site plan approval process by making decisions on applications for substantial site plan approval through their evaluation against Design Manual. There are two types of applications, non-substantive and substantive. The non-substantive applications do not come to the Committee for consideration.

Purvis explained the difference between qualitative and quantitative elements and went through the role of the Committee and the site plan approval process. They indicated the four-step site plan approval process includes the following steps:

- 1. Preliminary Committee presentation;
- 2. Pre-application;
- 3. Public consultation; and
- 4. Formal application.

Purvis displayed the Design Manual briefly and advised it is the primary reference document for this Committee and provided the following options the Design Review Committee has in issuing its decisions:

- 1. Refuse application;
- 2. Approve the application; or
- 3. Approve the application with conditions.

Purvis provided a brief explanation on density bonusing.
