Commissioner Smith proposed staff develop a communication plan and proposed to assist with this task as part of the Councillor's role on the Halifax Board of Police Commissioners Work Plan.

8.3.1 Martha Paynter – Women's Wellness Within Nova Scotia

A presentation from Martha Paynter dated August 17, 2020

Martha Paynter, founder and coordinator of Women's Wellness Within Nova Scotia, gave a presentation to the Board of Police Commissioners regarding the application of a gender lens to the public arrest of several women and children earlier in the winter of 2020, and particularly to policies regarding arrests of breastfeeding persons.

10.1.1 HRM Wortley Report Recommendations – Update

Commissioners expressed support for the format of the Wortley Report Recommendations update document and several expressed support for the inclusion of the document for posting to supporting websites.

Janis Gray, Chief Superintendent of the Halifax Detachment of the Royal Canadian Mounted Police, provided an update on the Halifax District RCMP's progress with the HRM Wortley Report recommendations including information relating to the street check ban data, dates for data collection and management and the extension for data access.

Chief Kinsella provided an update on HRP's progress with the Wortley Report recommendations including data collection, meetings with stakeholders groups to accomplish recommendations, and the recruitment program outreach.

The Board discussed the update with Chief Kinsella and Chief Superintendent Janis Gray responding to questions.

In response to a question from Commissioners regarding challenges to freedom of information requests for police data, Chief Kinsella and Chief Superintendent Janis Gray provided insight regarding the process for collecting and vetting data. They noted that most data requests are simple and limited in scope, and thus quickly processed. Where police receive large scope data requests, police communicate with the requester to see if there are ways to reduce the scope while addressing the concerns identified.

10.2 MEMBERS OF BOARD OF POLICE COMMISSIONERS

10.2.1 Defunding the Police – Further Discussion on the Approved Motion

Martin Ward, Solicitor, updated members regarding process and the motion approved at the July 9, 2020 meeting of the Board. The motion was at that time approved on the understanding that the decision of whether to create a sub-committee was dependent on a future discussion of the Commission. The Commissioners engaged in a discussion of the merits of creating a subcommittee to develop a definition of defunding the police, and also discussed the process to form a subcommittee.

The motion now reads:

THAT the Halifax Board of Police Commissioners appoint a Community Advisory Committee to assist in adopting a definition of defunding the police and that the Committee present this definition at a future meeting of the Board for further discussion and debate. Further, the definition of defunding the police should be based on the following:

- Police performing core policing functions;
- Allocating appropriate resources to perform non-police functions; and,
- Investing in resources that have been proven to support community risks and promote crime prevention.

10.2.2 Commissioner Blackburn – Public Access to HRP Policies via Website

THAT the Board of Police Commissioners direct the Halifax Regional Police and the Royal Canadian Mounted Police as part of the Board of Police Commissioners workplan covering policy review make available to the public, via the website, their policies including but not limited to: information on Conduct of Service Members, Conflict of Interest, Complaints and Use of Force policies.

Commissioners expressed a desire to suspend the requirement that the motion return by way of a staff report.

THAT the motion be amended to add that "the Board of Police Commissioners suspend the requirement to return with a staff report"

The Chair proposed two friendly amendments that the motion be amended to include the Royal Canadian Mounted Police to make policies available to the public and also that the list of policies be deleted from the motion, to which the Mover agreed.

THAT the Board of Police Commissioners:

2. Suspend the requirement to return with a staff report
