9.1 STAFF

9.1.1 Overview of UN Safe Cities Safe Public Spaces for Women and Girls Programme's Draft Scoping Study

Brandy Whitford, Program Coordinator, Office of Public Safety conducted scoping study on the UN Safe Cities Safe Public Spaces for Women and Girls programme.

Whitford sought input from the Committee on the following:

- 1. What does the Committee think needs to be addressed in the Halifax community?
- Safety when walking around the city: women should be able to walk around the city without feeling fear regardless of time or location (street, restaurants, bars).
- Safety in online environment as public space/ online harassing
- Safe streets having better lights on the streets for pedestrians
- Making transportation more accessible for women active transportation, walking, cycling
- Identifying individuals' needs in the community
- Different perception of public safety by community members depends on their area of residence, neighborhood, age, or gender.
- Safety surrounding different mode of transportation including cars, taxi, buses, and public transportation in general.
- Safety button in universities
- Education
- Designing a city through female lenses.
- 2. Where does the Committee's priorities lie regarding gender-based violence in public spaces in Halifax?
- Transportation (Public Transportation, female driver taxi services, safer bus stop locations)
- Education (age inclusive learning opportunity)
- Building a walkable and lively city
- Having Intersectional lenses and approaches
- Safety Assessment of the Infrastructure
- Substitutions of sentences/speech to build up confidence when women are resisting unwanted advances by others.

- 3. What would the Committee like to see come out of Halifax's participation in the UN Women Safe Cities Safe Public Spaces programme?
- · All women feel safe in Halifax Regional Municipality
- Safety Audit with Objective Metrics making sure that female lenses are considered in HRM policies
- Data and information on level of safety within Halifax to measure and assess changes over time
- Learning other jurisdictions' examples in minimizing gender-based violence to implement in Halifax Regional Municipality.

The Chair thanked Brandy Whitford, Program Coordinator, and Amy Siciliano, Public Safety Advisor for providing Committee Members with the opportunity to participate in the scoping study. The Chair indicated that the Committee looks forward to receiving updates on the UN Safe Cities Programme at future meetings.

9.1.2 Update on International Women's Day March 16, 2021

The committee continued their discussion with Caroline Hemstock, Diversity and Inclusion Advisor, on the following questions regarding 2021 International Women's Day:

- 1. The most important issues emerging from each member's community;
- 2. Mechanisms to engage members' respective communities in the event; and
- 3. How members would like to participate in the event (i.e. speeches, participation in panel discussions etc.)

The Committee shared the following points:

- Engaging young teenage girls in celebrating International Women's Day
- Engaging men in celebrating International Women's Day
- Supporting Halifax's female-owned business by buying local
- Pop up session on social media (Instagram)
- Online workshop/webinar inviting people in diverse professions such as in business, academia (education), or organizations to share story on their accomplishment & challenges. Nomination of community members for recognition of individual's accomplishment and contribution.
- Housing, house care for queer and trans community members, impacts of climate change on youth
- Honoring the 23 women who passed away (Constable Stevenson, RCMP member, snowbirds pilot Captain Jennifer Casey, and military member)
- Resiliency especially through COVID-19
- Recognition of "invisible champions" such as single parents and grocery store workers.
- Events that encourage people to take a break from their screen time (Art Installation, workshop, walking tour that highlights women's history/contributions)
