1. CALL TO ORDER

Kathy Jourdain, facilitator asked the Board of Police Commissioners to break into pairs to brainstorm the Board of Police Commissioners' values.

- Value to the community

5. BOARD OF POLICE COMMISSIONERS' PRIORITIES FOR 2022

Kathy Jourdain, facilitator presented to the Board of Police Commissioners regarding the issues and priorities for the Board of Police Commissioners identified by the Commissioners during individual presession discussions the facilitator conducted with each Commissioner. Jourdain broke the Board of Police Commissioners into two groups lead by the Chair and Vice Chair to discuss identified value clusters and how they influence the priorities that the Board of Police Commissioners would like to identify for 2022.

The Board of Police Commissioners identified the following priorities for 2022:

- Clear purpose/mandate for Board of Police Commissioners (governance)
- Strengthen police relationship with the community
- Fiscal responsibilities
- Board of Police Commissioners communications and public (community) engagement plan
- Understanding legal authority and duties
- Establish more control over own budget (to allow for research, etc.)
- Resources to support the Board's work (staffing)
- Establish a committee structure share workload
- Development of action plan to address upcoming reports
