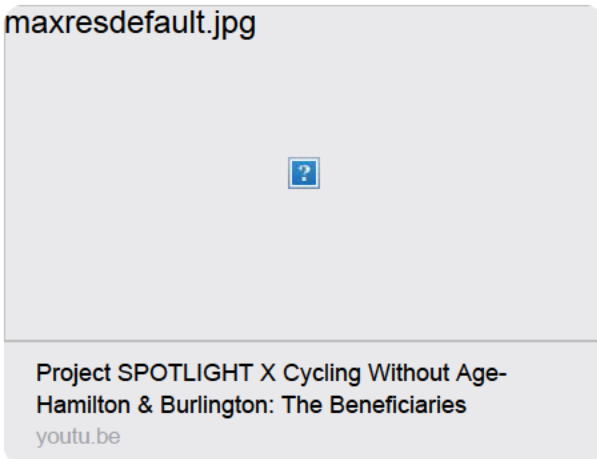

Hello Catherine,

I have discussed with Diane Levandier and Lillian Ash (HRM Recreation) the need to bring the Cycling Without Age program to Musquodoboit Harbour, for use on the HRM Active Transportation Spine; Musquodoboit Trailways and the Gaetz Brook Greenway. Other municipalities across Canada are investing in sustainable positions of employment via their recreation departments to ensure that the equipment is maintained, loaned, volunteers are trained, and participant passengers can schedule rides. Musquodoboit Harbour has a beautiful recreation/library facility, as do other communities throughout HRM. There may also be the possibility of building this program into the design of the new Eastern Shore District Highschool being built in East Chezzetcook.

This is grassroots community planning and economic development, that could grow to benefit all of HRM.
