## 9.1.2 Active Transportation Update

David MacIsaac, Manager, Active Transportation spoke to the Midtown 'AAA' Bikeways public engagement on February 15 and 18, 2025 and the Technical Committee feedback on the Grahams Grove concepts. MacIsaac spoke to ongoing Active Transportation projects under the Active Transportation (AT) Grants Program, which included five separate grants: AT Capital, AT Recapitalization, AT Emergency Repairs, AT Education and Promotion approved through the Capital Budget Process and AT Maintenance and Operations approved through the Operational Budget process. MacIsaac noted that the report outlining the results on a new area rate to enable sidewalks or on-road multi-use pathways in rural centres would go before Regional Council in March.

MacIsaac responded to questions of clarification from the Committee.
