Superintendent Don Moser, Acting Officer in Charge, Royal Canadian Mounted Police Halifax Regional Detachment (RCMP HRD) spoke to two recent RCMP HRD led town hall public engagements, key operational updates, upcoming events and responded to questions of clarification from the Board.
