Commissioner Kent requested that the definition section of the policy replace the definition of "Chief of Police" to "Chief Officer" meaning the Chief of Halifax Regional Police. As provided for in section 50 (2) of Administrative Policy One, *Respecting the Procedures of the Board of Police Commissioners,* the amendment was accepted as friendly.
