Brianna Rietzel, Transportation Engineer-in-Training, WSP Canada gave a presentation, seeking feedback on the proposed designs.

Rietzel and Erin Elridge, Active Transportation Planner responded to questions of clarification from the Committee.

The Committee provided feedback on the following:

- Safety considerations regarding intersections;
- Lack of barriers between Halifax Transit bus stops and bike lanes;
- Lack of adequate space for cars to pull onto the street;
- Dangers posed by slip lanes;
- The importance of post project evaluation regarding how disabled residents navigate the built environment; and
- The importance of accessible parking spots and universal design.

The Committee requested that WSP Canada provide follow up regarding how their feedback was incorporated in the project's final design.

Elizabeth Macdonald, Legislative Assistant responded to questions of clarification from the Committee regarding options for follow up with Halifax Regional Municipality staff and WSP Canada.
