Chief Superintendent John Duff, Officer in Charge, Royal Canadian Mounted Police Halifax Regional Detachment spoke to recent community engagements, past and upcoming events. Duff spoke to current and ongoing vehicle safety initiatives, recent major incidents and ongoing investigations. Duff spoke to the equipment modernization initiative and timelines respecting the adoption of new uniforms. Duff responded to questions of clarification from the Board.
